DECLARATIONS exchanged between the Governments of Great Britain and of the Roman States for securing National Treatment to the Vessels and Commerce of the one Country in the Ports of the other.

Declaration.

THE Undersigned, Her Britannic Majesty's Chargé d'Affaires at the Court of Tuscany, having received from His Eminence the Cardinal Antonelli, Secretary of State to His Holiness Pope Pius IX, the assurance that no other or higher duties or charges are levied in the ports of the Papal States on British vessels than are payable on National vessels, nor on goods imported or exported in British vessels than are payable on the like goods imported or exported in National vessels, has received the commands of Her Majesty to declare :--

- 1. That no duties of tonnage, harbour, lighthouse, pilotage, quarantine, or other similar or corresponding duties, of whatever nature or under whatever denomination, levied in the name or for the profit of the Government, public functionaries, corporations, or establishments of whatever kind, shall be imposed in British ports upon Papal vessels, from whatever port or place arriving, which shall not be equally imposed in the like cases on National vessels; and that no duty, charge, restrictions tion, or prohibition shall be imposed upon, nor any drawback, bounty, exemption, or allowance withheld from goods imported into or exported from British ports in Papal vessels, which shall not be equally imposed upon or withheld from such goods, when so imported or exported in National vessels.
- 2. That no other or higher duties shall be imposed on the importation into the dominions of Her Britannic Majesty of any article the growth, produce, or manufacture of the Papal States, than are or shall be payable on the like article being the growth, produce, or manufacture of any other Foreign Country. That no other or higher duties or charges shall be imposed in the British dominions on the exportation of any article to the Papal States, than such as are or may be payable on the exportation of the like article to any other Foreign Country: and that no prohibition shall be imposed upon the importation of any article the growth, produce, or manufacture of the Papal

- 1. Che nei porti dei dominii Pontificii non sarà imposto ai bastimenti Britannici provenienti da qualsivoglia porto o luogo, alcun diritto di tonnel-laggio, di porto, di fanale, di pilotaggio, di quaran-tena, o altro diritto simile, o corrispondente (di qualsiasi specie, o sotto qualunque denominazione, percetto in nome, od a profitto del Governo, de' pubblici funzionarii, dicasteri, o stabilimenti), che non sia ugualmente imposto in simili casi a bectimenti Nacionali. bastimenti Nazionali. E che niun diritto, niuna imposizione restrizione, o proibizione sarà imposta, ne alcun ribasso, favore, esenzione, o condiscendenza sarà ricusata, ai generi importati nei porti degli Stati Pontificii, o da questi esportati, in bastimenti Britannici, che non sia ugualmente imposta, o ricusata a simili generi, quando questi sieno così importati od esportati in bastimenti Nazionali.
- 2. Che niun altro, o maggior dazio sarà imposto sulla importazione nei dominii Pontificii di qualunque articolo, prodotto, o manifattura dei dominii di Sua Maestà Britannica, se non che quello che pagasi, o pagherassi in simili articoli, prodotti, o manifatture di qualunque altro estero paese. Che niun altro, o maggior diritto, o dazio sarà imposto negli Stati Pontificii sulla esportazione di qualun-que articolo ne' dominii Britannici, fuorche quello che pagasi, o possa pagarsi, sulla esportazione di simili articoli in qualunque altro estero paese. E che non sarà imposta alcuna proibizione sulla importazione di qualsiasi articolo, prodotto, o manifattura de' dominii Britannici negli Stati Pontificii

States into the British dominions, nor upon the exportation of any article from the British dominions to the Papal States, unless such prohibition shall extend to all other Nations.

- 3. That Papal vessels shall be at liberty to import into British ports any article legally importable, and to export from British Ports any article legally exportable, on payment of the same duties, and with a right to the same bounties and drawbacks, as are or may be payable or allowable in respect of the same articles if imported or exported in National vessels.
- 4. That all vessels which, according to the laws of the Papal States, are to be deemed Papal vessels, shall, for the purposes of this Declaration, be deemed Papal vessels.
- 5. That the foregoing stipulations shall not apply to the coasting trade, which is reserved exclusively to National vessels.
- 6. That if any ship of war or merchant vessel of the Papal States shall be wrecked on the coasts of the British dominions, such ship or vessel, or any parts thereof, and all furniture and appur-tenances belonging thereunto, and all goods and merchandize which shall be saved therefrom, or the produce thereof if sold, shall be faithfully restored to the owners, upon being claimed by them or by their duly authorized agents. If there are no such owners or agents on the spot, then the said ships or parts of ships, furniture, appurtenances, goods, and merchandize, or the proceeds thereof if sold, as well as all papers found on board such wrecked ships or vessels, shall be delivered to the Papal Consul or Vice-Consul in whose district the wreck may have taken place, upon being claimed by him; and such Consul, Vice-Consul, owners, or agents, shall pay only the expenses incurred in the preservation of the property, together with the salvage or other expenses which would have been payable in the like case of a wreck of a National vessel. The charge for such salvage and other expenses shall be made and settled immediately, subject to such right of appeal on the part of the person paying the same, as may exist in the British dominions. The goods and merchandize saved from the wreck shall not be subject to duties unless cleared for consumption, in which case they shall be liable to the same duties as if they had been imported in a British ship.
- 7. That the foregoing concessions are granted on condition of a perfect and entire reciprocity in favour of British vessels in the ports of the Papal States. They shall come into operation from and after the date of the present Declaration, and shall remain in force for seven years, and further until the expiration of twelve months after notice shall have been given by the British Government, or by the Papal Government, for terminating such reciprocal arrangement.

In witness whereof the Undersigned has signed the present Declaration, destined to be exchanged against a similar Declaration on the part of His Eminence the Cardinal Secretary of State, and has affixed thereto the seal of his arms.

- 5. Che le precedenti stipulazioni non saranno applicabili al cabotaggio, il quale é esclusivamente riservato ai bastimenti Nazionali.
- 6. Che sa qualche legno Britannico da guerra, o mercantile, farà naufragio sulle coste dello Stato Pontificio, tali legni, o qualunque parte di essi, e tutti gli attrezzi e pertinenze ad essi spettanti, non che tutti gli effetti e le mercanzie che ne saranno salvate, o il loro prodotto, se vengano vendute, saranno fedelmente restituiti ai proprietarii, quando vengano reclamati da questi, o dai loro agenti debitamente autorizzati.

In mancanza poi di tali proprietarii, o agenti sulla faccia del luogo, i suddetti legni, o parti di essi, gli attrezzi, le pertinenze, gli effetti, e le mercanzie, o il prodotto di queste, se vengano vendute, come pure tutte le carte trovate a bordo di tali legni naufragati, saranno consegnate al Console Britannico, o Vice-Console (nella cui giurisdizione sia avvenuto il naufragio), a di lui richiesta; e tali Console, o Vice-Console, proprietarii, o agenti pagheranno soltanto le spese incorse per portare a salvamento gli effetti, o altre spese che sarebbero state rifattibili in simil caso di naufragio di un bastimento Nazionale. La tassa per detto salvamento, ed altre spese verrà conclusa e stabilita immediatamente, e sarà soggetta a quel diritto di appello (per parte della persona che la pagherà,) che esistà nei dominii Pontificii. Gli effetti, e le mercanzie salvate dal naufragio non saran soggetti ad alcun diritto, a meno che non siano ammesse al consumo, nel qual caso saranno tenute agli stessi diritti, o dazi, come so fossero state importate in un bastimento Pontificio.

7. Che le precedenti concessioni si accordano a condizione di una perfetta ed intiera reciprocità in favore de' bastimenti Pontificii nei porti dei dominii Britannici. Whereas by an Act passed in the Session of Parliament holden in the fifteenth and sixteenth years of the reign of Her present Majesty, intituled "An Act to enable Her Majesty to abolish, otherwise than by Treaty, on condition of reciprocity, differential duties on "Foreign Ships," it is provided that where it shall appear to Her Majesty that by the laws or regulations of any Foreign Power the trade and shipping of Great Britain, in the ports of such Foreign Power, have been placed upon the same footing as the trade and shipping of such Foreign Power, either absolutely or on condition of equal or like benefits being conceded to the vessels of such Foreign Power in the ports of Her Majesty, it shall be lawful for Her Majesty, by Order to be by Her made, with the advice of Her Privy Council, and to be published in the London Gazette, to order and declare that the trade and shipping of such Foreign Power shall have the benefit of the provisions of the said Act:

And whereas it appears to Her Majesty that by the regulations of the Roman States the trade and shipping of Great Britain, in the ports of the Roman States, have been placed on the same footing as the trade and shipping of the Roman States:

Now, therefore, Her Majesty, by virtue of the power vested in Her by the said recited Act, and by and with the advice of Her Privy Council, is pleased to order and declare, and it is hereby ordered and declared, that from and after the publication hereof in the London Gazette, the trade and shipping of the Roman States shall have the benefit of the provisions of the said recited Act.

And the Right Honourable the Lords Commissioners of Her Majesty's Treasury are to give the necessary directions herein accordingly.

Whereas by the fifteenth section of "The "Merchant Shipping Law Amendment Act, 1853," it was enacted that Her Majesty might, by and with the advice of Her Privy Council, from time to time, as circumstances might appear to Her Majesty to permit, reduce all or any of the tolls received by the Commissioners of Northern Lighthouses:

And whereas it has been made to appear to Her Majesty that the tolls received by the Commissioners of Northern Lighthouses in respect of coasting

vessels may be reduced;

Now, therefore, Her Majesty, by and with the advice of Her Privy Council, and in pursuance of the powers vested in Her by the said recited Act, is pleased to direct, that the tolls received by the Commissioners of Northern Lighthouses in respect of coasting vessels shall, on and after the first day of January one thousand eight hundred and fifty-four, be reduced as follows; that is to say:—where the toll payable in respect of any such vessel upon passing or deriving benefit from any lighthouse is now fixed at the rate of one farthing per ton, such toll shall be at the rate of one-sixteenth of a penny per ton, and where such toll is now fixed at the rate of one half-penny per ton, it shall be at the rate of two-sixteenths of a penny per ton.

Whereas by the fifteenth section of "The "Merchant Shipping Law Amendment Act, "1853," it was enacted that Her Majesty might, by and with the advice of Her Privy Council, from time to time, as circumstances might appear to Her Majesty to permit, reduce all or any of the lighthouse tolls received by the Trinity House, the Commissioners of Northern Lighthouses, and the Port of Dublin Corporation;

And whereas it has been made to appear to Her Majesty that the said lighthouse tolls may be reduced without injury to the services in re-

spect of which such tolls are levied:

Now, therefore, Her Majesty, by and with the advice of Her Privy Council, and in exercise of the powers vested in Her by the said recited Act, is pleased to direct that the lighthouse tolls (as defined in the said Act) received by the Trinity House, the Commissioners of Northern Lighthouses, and the Port of Dublin Corporation, shall, on and after the first day of January one thousand eight hundred and fifty-four, be reduced as follows; that is to say:—

Until Her Majesty, with the advice of Her Privy Council, may see fit otherwise to determine, there shall be allowed to every person paying such tolls, an abatement or discount upon the amount payable by him, which abatement or discount shall, in the case of every oversea vessel, be twenty-five per cent, and in the case of every coasting vessel, ten per cent.

The Right Honourable the Lords of the Committee of the Privy Council for Trade and Plantations have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Chargé d'Affaires, at Stockholm, enclosing a translation of a Royal Edict issued by the Government of Sweden and Norway, reducing the duties on salt and firewood, of which a copy is subjoined.

(Translation.)

Royal Proclamation relative to the reduction of import duties on salt and firewood:—

We, Oscar, &c., hereby make known that from considerations laid before us, we have thought fit to order:

That from this day inclusive to the end of the year 1854 salt may be imported into the kingdom at a reduced duty of 18 skillings banco a ton.

During the same period wood may also be imported on paying the following duties:—

Birch wood . . . 12 skillings a fathom.
Oak and beech wood 18 , ,

Other kinds of wood 8 ,, ,,
