REGULATIONS TO BE OBSERVED AT THE QUEEN'S LEVEE AT ST. JAMES'S-PALACE,

The Noblemen and Gentlemen who purpose to attend Her Majesty's Levee at St. James's Palace, are requested to bring with them two large cards, with their names clearly written thereon, one to be left with the Queen's Page in Attendance in the Presence-Chamber, and the other to be delivered to the Lord Chamberlain, who will announce the name to Her Majesty.

Those Gentlemen who are to be presented are hereby informed it is absolutely necessary that their names, with the name of the Nobleman or Gentleman who is to present them, should be delivered at the Lord Chamberlain's Office, before twelve o'clock, on the Monday previous to the Levee, in order that they may be submitted for The Queen's approbation; it being Her Majesty's command, that no presentation shall be made at the Levee but in conformity with the above Regulations.

It is particularly requested that in every case the names be very distinctly written upon the cards to be delivered to the Lord Chamberlain, in order that there may be no difficulty in announcing them to the Queen.

The State Apartments will not be open for the reception of Company coming to Court until Half-past One o'Clock.

Notice is hereby given, that all persons having Petitions or Addresses to present to Her Majesty at the Levee, are to deliver a card (having on it their names, a statement of the object of such Petitions or Addresses, and the names of the persons from whom they come,) to the Lord Chamberlain's Office, before twelve o'clock, on the Monday previous to the Levee above announced; and that two other cards, having on them precisely what is written upon that sent to the Lord Chamberlain's Office, are to be taken to the Levee, one of the two cards to be delivered to the Page in the Ante-Room, and the other to the Lord Chamberlain, who will read its contents to

Her Majesty; and on these occasions no other statement is to be addressed to Her Majesty.

A Deputation to present an Address is not to exceed four persons.

NOTICE TO MARINERS.

For the guidance of vessels passing through the Little Belt, a mark, in form of a Tower, 20 feet high from the ground, and forty feet above the level of the water, has been placed on the west coast of Fyen, \(\frac{1}{2} \) a mile (2\frac{1}{4} \) miles English) north of Assens, in 55° 18' 25" N. lat., and 9° 53' 48" E. long, of Greenwich, Kjerte Church in a line with Sandager Church.

It will be kept white, and is furnished with a red "balloon" on the top.

The Right Honourable the Lords of the Committee of Privy Council for Trade and Plantations have received, through the Secretary of State for Foreign Affairs, a copy of a Letter from the Agent in this country of the King of the Sandwich Islands, inclosing the subjoined Notification respecting the increase in the duties to be levied on the importation of certain kinds of merchandise into those Islands.

AN ACT TO INCREASE THE IMPORT DUTIES ON CERTAIN KINDS MERCHANDISE.

Approved, May 24th, 1853.

Be it enacted by the King, the Nobles, and the Representatives of the Hawaiian Islands, in

Legislative Council assembled:

Section 1. That there shall be levied on all goods, wares, and merchandise imported into this Kingdom, from any port in China or the Phillipine Islands, a duty of fifteen per cent. ad valorem, upon the invoice cost thereof; provided, however, that no more than five per cent. duty shall be levied on the article of rice; and further, provided that this shall not be construed into a repeal of any part of "An Act levying specific duties on sugar, syrups of sugar, and coffee," passed June 6th, 1852.

Section 2. The increase of duties provided for in the first section of this Act shall not affect goods, wares, or merchandise, which are the growth or manufacture of any Foreign Country having a

treaty with this Kingdom.

Section 3. In order to prove that any goods, wares, or merchandise, imported into this Kingdom, from any of the ports of China or the Phillipine Islands, are the growth or manufacture of some other Country, having a treaty with this Kingdom, it shall be necessary for the person entering the same at the Custom-House, to present to the Collector of Customs a certificate to that effect from the resident Hawaiian Consul, or in default of such Consul, from the Consul or Commercial Agent of such other Country, at the port in China or the Phillipine Islands from whence such goods, wares, or merchandise shall have been brought to this Kingdom; and the person entering the same at the Custom-House shall make oath that such goods, wares, or merchandise are not the growth or manufacture of China or the Phillipine Islands, to the best of his knowledge and belief.

Section 4. This Act shall take effect at the expiration of six months from the date of its pub-

lication in the Polynesian newspaper.
