BUCKINGHAM-PALACE, August 12, 1854.

THIS day Her Majesty, accompanied by His Royal Highness Prince Albert, proceeded in state from Buckingham Palace to the House of Peers, where she arrived soon after two o'clock; and was received, on alighting from her state coach, by the Lord Chancellor, the Lord President of the Council, the Lord Privy Seal, the Lord Steward of the Household, Garter King of Arms, and the Yeoman Usher of the Black Rod, and proceeded to the State Robing-room in the customary

manner.

Her Majesty was there robed, and the procession moved into the House in the usual order;—the sword of state was borne by the Earl of Aberdeen, K.T., the cap of maintenance by the Marquess of Winchester, and the crown by the Marquess of Lansdowne, K.G.

Her Majesty being seated on the Throne, and His Royal Highness Prince Albert on a Chair on the left side of the Cloth of Estate, the Great Officers of State and others standing on the right.

Officers of State and others standing on the right and left, James Pulman, Esquire, Yeoman Usher of the Black Rod, was sent with a message from Her Majesty to the House of Commons, commanding their immediate attendance in the House of Peers. The Commons being come thither accordingly, Her Majesty was pleased to deliver the following most gracious Speech to both deliver the following most gracious Speech to both Houses of Parliament:

My Lords and Gentlemen,

I am enabled by the state of public business to release you from a longer attendance in Parliament.

Gentlemen of the House of Commons,

In closing the Session, it affords Me great pleasure to express My sense of the zeal and energy you have shown in providing means for the vigor-ous prosecution of the War in which, notwithstanding My efforts to avert it, we are now engaged. This liberality in granting the supplies for the public service demands My warmest thanks; and although I lament the increased burdens of My people, I fully recognise your wisdom in sacrificing considerations of present convenience, and in providing for the immediate exigencies of the War, without an addition being made to the permanent debt of the Country.

My Lords and Gentlemen,

In cordial co-operation with the Emperor of the French, My efforts will be directed to the effectual

repression of that ambitious and aggressive spirit on the part of Russia which has compelled us to take up arms in defence of an Ally, and to secure the future tranquillity of Europe.

You will join with Me in admiration of the courage and perseverance manifested by the troops of the Sultan in their defence of Silistria, and in the various military operations on the Danube.

The engrossing interest of matters connected with the progress of the War has prevented the due consideration of some of those subjects which, at the opening of the Session, I had recommended to your attention; but I am happy to acknowledge the labour and diligence with which you have perfected various important measures, well calculated to prove of great public utility.

You have not only passed an Act for opening the coasting trade of the United Kingdom, and for removing the last Legislative restriction upon the use of Foreign vessels; but you have also revised and consolidated the whole Statute Law re-

lating to Merchant Shipping.

The Act for establishing the direct control of the House of Commons over the charges incurred in the collection of the Revenue, will give more complete effect to an important principle of the Constitution, and will promote simplicity and regularity in our system of public accounts.

I rejoice to perceive that amendments in the administration of the law have continued to occupy your attention; and I anticipate great benefits in the improvements you have made in the forms of

procedure in the Superior Courts of Common Law.

The means you have adopted for the better government of the University of Oxford, and the improvement of its constitution, I trust will tend greatly to increase the usefulness and to extend the renown of this great seminary of learn-

ing.

I have willingly given My assent to the measure you have passed for the prevention of bribery and corrupt practices at elections; and I hope that it may prove effectual in the correction of an evil which, if unchecked, threatens to fix a deep stain

upon our representative system.

It is My earnest desire that on returning to your respective counties, you may preserve a spirit of union and concord. Deprived of the blessings of peace abroad, it is more than ever necessary that we should endeavour to confirm and increase the advantages of our internal situation; and it is with the greatest satisfaction that I regard the progress of active industry, and the general prosperity which

happily prevails throughout the Country.

Deeply sensible of these advantages, it is My humble prayer that we may continue to enjoy the favour of the Almighty; and that under His gracious protection we may be enabled to bring the present contest to a just and honourable termination.

NOTICE TO MARINERS.

Publication respecting the alterations that have been made in the relative positions of the buoys and tuns in the channel or fairway at the mouth of the River Weser.

On the 1st October, 1853, a public Notification was issued to the effect that in the course of the present year an alteration would take place in the relative position of the buoys and tuns in the fairway or channel of the Weser; and such said alteration having been effected and arranged, the following particulars, bearing reference thereto, are herewith brought to public notice:—

I. Instead of the previous four red and two white buoy tuns, six red and five white tuns are now laid down in the new channel or fairway. The red tuns on coming in lie on the starboard side, are buoy tuns in the usual form. The white tuns, on the contrary, have the form of the usual Weser tuns.

a. The first Red Tun at the new mouth of the Weser, which is distinguishable by a gilt key on a pole and two white-painted keys on its sides, lies in 9 fathoms water at low water, and the bearings from it by compass are

The position of the remaining black and white tuns below the Floating Light (light vessel) and up to the Black C Tun, but which, instead of the cross, is at present distinguishable by carrying a black vane stock (Flügel Stange), remains till further notice unaltered.

All vessels coming in and making the new mouth of the Weser, on an E.S.E. tack, will, after having found the first Red Buoy Key Tun in the above specified bearings, retain their course for a short distance till within the vicinity of the first White Outer Tun, and having reached this they will have to direct their course S.E., and then get the Floating Light (light vessel) No. 1, straight before them. Steering in a direct line up to the

Floating Light (light vessel), they pass over the sandridge of the former Mellum, direct into the old channel.

The depth of water in the new mouth is 9, 10, 11, and 8 fathoms; and on the sandridge of the Mellum, which is moreover but very narrow, 27 Bremen feet at low water, or fully four fathoms English.

In conclusion, it is further notified that in the spring of next year the first Weser Key Tun will be painted black instead of red as at present, but that with respect to the remaining tuns no alteration will take place.

WITH reference to the Notifications of Blockades of certain Russian ports in the Baltic Sea, published in the Gazettes of the 16th of June last and of the 16th of July last, it is hereby notified, that the Lords Commissioners of the Admiralty have received further information from Vice-Admiral Sir Charles Napier, K.C.B., Commanding Her Majesty's Naval Forces in the Baltic, from Captain Key, R.N., of Her Majesty's ship "Amphion," senior officer off the coast of Courland, and from William James Hertslet, Esq., British Vice-Consul at Memel, relating to such Blockades, which information is as follows, viz:—Sir Charles Napier states that—

"On and from the 17th of April last, all Russian ports, roads, harbours, and creeks, from lat. 55° 53′ 0″ N., long. 21° 3′ 0″ E., to Cape Dager-ort, in lat. 58° 55′ 0″ N., long. 22° 5′ 0″ E., including especially the ports of Libau, Windau, Riga, and Pernau, were placed in a state of strict Blockade by a competent force of Her Majesty's ships,"

"On and from the 26th of April last the Russian ports of Helsingfors and Sweaborg, and all Russian ports, roads, havens, and creeks to the westward of Helsingfors, as far as Hango Head, in lat. 59° 48′ 0″ N., long. 22° 53′ 0″ E., were in like manner blockaded."

"On and from the 20th May last the Russian ports of Hafsal, Warmso Islands, Port Baltic, Revel, and all Russian ports, roads, havens, and creeks on the coast of Esthonia, from Cape Dager-ort to Ekholm Light (situated in lat. 59° 43' 0'' N., and long. 25° 48' 0" E.), were placed in a state of strict Blockade by a competent force of Her Majesty's ships."

"On and from the 26th of June last the Russian ports of Abö, the Islands of Orö Onto, and the Aland Archipelago, Nystad, Bjorneborg, Christinestad, Wasa, the Walgrund Islands, New Carleby, Jacobstad, Old Carleby, Lohto, Kalajoki, Brahestad, Uleaborg, Carlon Island, Ijo, Gestila, Kemie, and all Russian ports, roads, havens, and creeks, from Hango Head, in lat. 59° 48′ 0″ N., long. 22° 53′ 0″ E., to Ned Tornea (included), situated at the head of the Gulf of Bothnia, in lat. (about) 65° 50′ 0″ N., long. 24° 15′ 0″ E., were placed in a state of strict Blockade by a competent force of the Allied Fleets."

"On being joined by the French Squadron in the Gulf of Finland on the 13th June, the duties of blockading in that Gulf and elsewhere were henceforward conjointly carried into effect."

Copy of an Official Report from Captain Key, R.N., Her Majesty's ship Amphion, to Vice-Admiral Sir Charles Napier.

Amphion, off Windau, June 14, 1854.

HER Majesty's ship under my orders having detained several vessels belonging to Neutral Nations for attempting to violate the Blockade established on this coast, and sent them to England for legal adjudication, in accordance with Articles 9 and 10 of the Admiralty instructions on the subject,—I have the honour to report for your information, the circumstances under which the said vessels have been captured, the manner in which the blockade has been carried out, and other points which may be of importance to the Court of Admiralty commissioned to take cognizance of this question.

Three points must be proved to condemn these vessels as lawful prizes:—

1st. That an effective Blockade has been established.

2d. That the vessels detained attempted to violate this Blockade.

3d. That they were aware of its existence.

Regarding the first point, I have the honour to inform you that since May 9th, when I was first intrusted with the Blockade of this coast (at which time I found Her Majesty's ships Conflict and Cruizer on the station, which vessels had been blockading since April 20th), two ships have been ordered to cruize off the entrance of the Gulf of Riga, a passage limited by the shoals to a breadth of three miles; this entrance has

never been left without one vessel. Two other ships have been continually passing between Windau and Memel within sight of the coast.

No doubt in a few instances vessels have succeeded in evading the cruizers under cover of the night and the fogs which have been so prevalent; the number of vessels boarded is of itself a proof that vigilance has been exercised.

The second point is readily ascertained by a reference to the definition which has been sent in each vessel by the Captain of the ships detaining her, in which the locality, the course the vessel was steering, and the direction of the wind are stated.

With respect to the third point—the knowledge of the Blockade—great care has been necessary to prevent injury to innocent vessels. The captured vessels come under two heads—those attempting to enter the blockaded ports, and those leaving them. As regards the former, the Captains of Her Majesty's ships received orders that if the slightest reasonable doubt existed as to the captain or the owner of the vessel being informed of the Blockade, she was to be sent away with a Notification to that effect on his papers.

Under these orders 154 vessels have been warned off since April 20th, although nearly all of them passed through the Sound, communicating at Elsinore, which scarcely allows a doubt to exist of their knowledge of the Blockade. Nevertheless, I deemed it my duty to show as much leniency to Neutrals as was compatible with the interests of the Allied Powers. Four vessels only

have been detained for attempting to enter the ports. Two of these contained coal, and were without proper papers; the others were from Copenhagen, and confessed their knowledge of the Blockade.

To insure that the residents in the blockaded ports should not plead ignorance of their condition, I wrote the accompanying letter (Enclosure No. 1,) to the British Vice-Consul at Memel, the contents of which were published in the Berlin Gazette, and were publicly made known at Riga, Libau, and Windau. Mr Hertslet's answer (No. 2,) I enclose.

Notwithstanding this, several vessels have taken in cargoes, and left Riga; they have therefore been detained, and sent to England for adjudication.
