It is this day ordered by Her Majesty in Council that the Parliament, which stands Prorogued to Thursday the nineteenth day of October instant, be further Prorogued to Thursday the sixteenth day of November next.

#### PRESENT,

The QUEEN's Most Excellent Majesty in Council.

THEREAS by an Act passed in the last Session of Parliament, intituled 'An Act for amending the Laws relating to the Militia, 'and raising a Volunteer Militia Force in Scot-'land;'-It is amongst other things enacted, 'and ' in regard to the raising of Men for the Militia, it 'shall be lawful for Her Majesty, by and with the 'advice of Her Privy Council, to raise, and from ' time to time to keep up any number not exceeding Ten Thousand Private Militia-Men to serve 'for the several Counties in Scotland;' and it is thereby further enacted, that 'It shall be lawful 'for Her Majesty, with the advice of Her Privy ' Council, forthwith, after the passing of this Act, ' and afterwards, from time to time, as occasion may 'appear to Her Majesty to require, to ascertain and 'fix the number of Militia-Men who shall serve 'for each County; and the numbers so fixed, as 'aforesaid, shall be transmitted to the respective Lieutenants of the said Counties from time to 'time, and Notice of the same shall be published 'in the Edinburgh Gazette; and the numbers so 'from time to time appointed by Her Majesty, 'shall be the Quotas of the several Counties and ' places, until other Quotas are appointed in like ' manner.'

And whereas Her Majesty was pleased by Her Order in Council of the 13th of September last, to ascertain and fix the number of Militia-Men who should serve for each County in Scotland.

And whereas it is expedient that the numbers so fixed for the Counties of Ross and Cromarty, which were included in one, should be separately fixed.

Now therefore, Her Majesty, by and with the advice of Her Privy Council, is pleased hereby to ascertain and fix that the number of Militia-Men who shall serve for the County of ROSS shall be 278,—and that the number who shall serve for the County of CROMARTY shall be 12: And Her Majesty is further pleased to direct that this Order be published in the Edinburgh Gazette, and be transmitted to the respective Lieutenants of the said Counties, in order that they may proceed upon the same, in pursuance of the directions of the above recited Act of Parliament; and the number so appointed by Her Majesty shall be the Quotas of the said two Counties, until other Quotas are appointed in like manner.

The Earl of Clarendon, Her Majesty's Principal Secretary of State for Foreign Affairs, has received from Lord Cowley, Her Majesty's Ambassador at Paris, the subjoined copies of a Letter, addressed by his Excellency to M. Drouyn de Lhuys, Minister for Foreign Affairs to His Majesty the Emperor of the French, offering the condolence of Her Majesty's Government on the lamented death of the late Marshal St Arnaud; and of a Letter addressed by M. Drouyn de Lhuys to Lord Cowley, in reply.

Paris, October 10, 1854.

#### M. LE MINISTRE,

I AM desired by Her Majesty's Principal Secretary of State for Foreign Affairs, to take the earliest opportunity of conveying to the Emperor the expression of the deep regret with which the Queen's Government have learnt the intelligence of the death of Marshal St Arnaud.

Her Majesty's Government desire to offer to His! Imperial Majesty, and to the French People, their condolence on an event which has deprived the Emperor and France of the services of so distinguished and brave a General. If anything could mitigate the sorrow that must be felt by the Governments and People of France and England upon this occasion, it must be the satisfaction—though a mournful one that the Marshal's last moments were preceded and cheered by the triumph of a victory which will always be glorious in the military annals of both countries.

In requesting your Excellency to convey these sentiments to the knowledge of the Emperor, I trust that I may be permitted to add the expression of my personal regrets for the loss which the Emperor and the French Nation have sustained. To know Marshal St Arnaud was to like him; for the courtesy and affability of his private life was as remarkable as his courage and firmness in I avail, &c., (Signed) COWLEY.

#### TREASURY WARRANT.

WHEREAS by an Act passed in the fourth year of the reign of Her present Majesty, intituled "An Act for the regulation of the duties of postage," power is given to the Postmaster-General to remit any of the rates of British postage for the time being, payable by law on the transmission of post letters, newspapers, or other printed papers, to such extent as the Lords of the Treasury shall from time to time direct; and power is also given to the Commissioners of Her Majesty's Treasury, from time to time, by Warrant under their hands, to alter and fix any of the rates of British or Inland postage, payable by law on the transmis-sion by the post of Foreign or Colonial letters or newspapers, or any other printed papers, and to subject the same to rates of postage according to the weight thereof, and a scale of weight to be contained in such Warrant.

And whereas it is expedient that Regulations should be made for the transmission by the post

of the letters hereinafter mentioned.

Now we, the Commissioners of Her Majesty's Treasury, in exercise of the power or authority in us for such purpose vested in and by the said Act, and of all other powers enabling us in this behalf, do, by this Warrant (under the hands of two of us, the said Commissioners, by the authority of the Statute in that case made and provided,) order and direct that on every letter not exceeding half an ounce in weight, posted in or addressed to any part of the United Kingdom, and sent from or to any commissioned or non-commissioned officer, serjeant, corporal, drummer, trumpeter, fifer, or private soldier, employed in Her Majesty's regular forces, artillery, or royal marines, in the Kingdom of Greece, or sent from or to any commissioned or warrant officer, midshipman, master's mate, or seaman employed in Her Majesty's Navy, or any of Her Majesty's ships in Greece, transmitted by the Post between any place in the United Kingdom and any port or place in Greece (the conveyance between the United Kingdom and Greece being through France via Marseilles, by the French Mediterranean Packet Boats), there haye felt at such a loss, it is truly, as your Excel- shall be charged and taken, in lieu of any rates of

postage now payable by law on such letters, an

uniform British rate of one penny.

And we direct that on every letter transmitted as is mentioned in this Warrant, exceeding half an ounce in weight, there shall be charged, taken, and paid, progressive and additional rates of postage, as follows; that is to say :-

On every such letter, exceeding half an ounce in weight, and not exceeding one ounce in weight, two rates of postage

On every such letter exceeding one ounce, and not exceeding two ounces in weight, four rates of postage.

On every such letter exceeding two ounces, and not exceeding three ounces in weight, six rates of postage.

And for every ounce in weight above the weight of three ounces, there shall be charged and taken two additional rates of postage; and every fraction of an ounce above the weight of three ounces shall be charged as one additional ounce; and each progressive and additional rate, chargeable under this clause, shall be estimated and charged at the sum which any such letter would be charged with under this Warrant, if not exceeding half an ounce in weight.

And we further direct that in respect of letters sent by any non-commissioned officers, serjeants, corporals, drummers, fifers, private soldiers or sea men, under the regulations of this Warrant, the following conditions shall be observed, (that is to say,) upon each such letter shall be superscribed the name of the writer, and his class or description in the regiment, detachment, or vessel to which he shall belong; and upon every such letter there shall be written in the handwriting of, and signed by, the officer having at the time the command of the regiment, detachment, or vessel, to which the privileged person belongs, the name of such officer, and the name of such regiment, detachment, or

And we further direct that in respect to letters received by the post under this Warrant, by any commissioned or warrant officers, midshipmen, or master's mates, or any non-commissioned officers, private soldiers, or seamen, the following conditions shall be observed, that is to say:—the postage of each such letter posted in the United Kingdom shall be prepaid either in money or by the proper stamp or stamps being affixed thereto, at the time of the same being posted; and as to letters received by any non-commissioned officers, private soldiers, or seamen, each letter shall be directed to the privileged person, specifying on the superscription thereof the regiment, detach-ment, or vessel to which he shall belong.

And we further direct that if in any case the conditions hereinbefore prescribed be not complied with, the letter shall be charged with the same rates of postage as if this Warrant had not been

signed.

And we further direct that all letters which shall be sent by the post under the regulations of this Warrant, shall be subject, in addition to the British rates hereby fixed, to the payment of any Foreign postage which may be chargeable thereon.

And we further direct that the several terms and expressions used in this Warrant shall be construed to have the like meaning, in all respects, as they would have had if inserted in the said recited

Provided lastly, and we hereby declare and direct that it shall be lawful for the Commissioners for the time being of Her Majesty's Treasury, or

any two of them, by Warrant under their hands, at any time hereafter to alter or repeal any of the rates hereby altered, or the regulations hereby made, and to make and establish any new or other rates or regulations in lieu thereof, and from time to time to appoint at what time the rates that may be payable are to be paid.
