WAR-DEPARTMENT, January 12, 1855.

IIIS Grace the Duke of Newcastle has this day received a Despatch, of which the following is a copy, addressed to His Grace by Field-Marshal the Lord Raglan, G.C.B.

My Lord Duke, Before Sevastopol,
December 30, 1854.

SINCE I wrote to your Grace on the 26th, the weather has been somewhat more propitious; but the state of the ground is hardly more satisfactory.

The 18th Regiment has arrived, and I have likewise the honour to inform you that we are daily receiving vast supplies of ammunition, warm clothing, and luts for the Army. The utmost efforts will be made to disembark all those stores; but the difficulty of effecting this desirable object is very great, owing to the very limited extent of the harbour, its crowded state, and the narrow entrance to the town, and want of space on the beach, the rocks on the north side rising directly out of the water, and there being, consequently, no accommodation but on one side.

The Russians continue to withdraw from the Valley of the Tchernaya, whilst they have constructed defensive works on the heights above, which would imply a difficulty of maintaining their troops in the field.

A reconnoissance was sent out this morning by General Canrobert towards the river, in co-operation with a portion of Major-General Sir Colin Campbell's force on the extreme right of Balaklava, the result of which is not yet known.

(Copy.)

(Translation.) My Lord,

London, January 6, 1855.

According to the instructions of my Government, I have the honour to acquaint your Excellency that the Minister of Marine at the Hague has received a notice that on the 1st September last the light of the fourth size, situate at the 4th angle of the Strait of Sunda (East Indies), was extinguished, and would be replaced by a light of greater power (that is to say, of the second size), and that due notice will be given of the time at which this light will be exhibited.

Queen has been pleased to grant unto Richard Fellowes, of Englefield House, in the county of Berks, Esquire, in the commission of the Peace for the said county, third but second surviving son of William Henry Fellowes, late of Ramsey Abbey, in the county of Huntingdon, Esquire, by Emma his wife, fourth daughter of Richard Benyon, sometime of Gidea Hall, in the county of Essex, and afterwards of Englefield House aforesaid, Esquire, and sister and co-heir of Richard Benyon de Beauvoir, late also of Englefield House, Esquire, all deceased, Her royal licence and authority that he and his issue may, in compliance with a proviso contained in a settlement made pursuant to the last will and testament of his said maternal uncle, Richard Benyon de Beauvoir (formerly Richard Benyon), take and henceforth use the surname of Benyon only, instead of that of Fellowes, and that he and they may bear the arms of Benyon quarterly with his and their own family arms, such arms being first duly exemplified according to the laws of arms, and recorded in the Heralds' Office, otherwise the said royal licence and permission to be void and of none effect:

And also to command that the said royal concession and declaration be registered in Her Majesty's College of Arms.

WHITEHALL, January 11, 1855.

The Queen has been pleased to grant unto private Andrew Anderson, of the Sappers and Miners, Her royal licence and permission that he may accept and wear the Order of the Medjidie, which the Sultan has been pleased to confer upon him, in approbation of his distinguished bravery and good conduct at the passage of the Danube, on the 7th July last, and subsequently in rescuing the body of his commanding officer, Lieutenant Burke, after he had fallen; and that he may enjoy all the rights and privileges thereunto annexed; provided, nevertheless, that Her Majesty's said licence and permission doth not authorize, and shall not be deemed or construed to authorize the assumption of any style, appellation, rank, precedence, or privilege appertaining unto a Knight Bachelor of these realms:

And also to command that Her Majesty's said concession and especial mark of Her royal favour be registered, together with the relative documents, in Her Majesty's College of Arms.

TREASURY WARRANT.

Whereas by an Act passed in the fourth year of the reign of Her present Majesty, intituled "An Act for the regulation of the duties of postage," power is given to the Commissioners of Her Majesty's Treasury, from time to time, by Warrant under their hands, to alter and fix any of the rates of British or Iuland postage payable by law on the transmission by the post of Foreign or Colonial letters or newspapers, or any other printed papers, and to subject the same to the rates of postage according to the weight thereof, and a scale of weight to be contained in such Warrant.

And whereas it is expedient that Regulations should be made for the transmission by the post of the letters hereinafter mentioned.

Now we, the Commissioners of Her Majesty's Treasury, in exercise of the power or authority in us for such purpose vested in and by the said Act, and of all other powers enabling us in this behalf, do, by this Warrant, under the hands of two of us, the said Commissioners, by the authority of the Statute in that case made and provided, order and direct that on every letter not exceeding half an ounce in weight, posted in the United Kingdom, addressed to any seaman employed in Turkey or the Black Sea, on board any transport or ship chartered or hired for Her Majesty's service, and on every letter not exceeding half an ounce in weight, sent by any such seaman from Turkey or the Black Sea to the United Kingdom, (the conveyance of such respective letters between the United Kingdom and Turkey or the Black Sea being by packet-boat direct, or via Malta, and such respective letters being on the private concerns of any such seamen,) there shall be charged and taken, in lieu of any rates of British postage now payable by law on such respective letters, an uniform rate of British postage of one penny. But we declare that the letters of Officers or Mates on board of any such transports or ships are not included in this provision.

And with respect to letters sent by any such seaman, the following conditions shall be observed; that is to say: the postage of each letter shall be paid by means of a postage stamp, on being put into a post-office established under the authority of the Postmaster-General; and upon such letter shall be superscribed the name of the writer, and

his description as a seaman in the transport or ves sel to which he shall belong; and upon every such letter there shall be written, in the handwriting of, and signed by the officer having at the time the command of the transport or vessel to which the seaman belongs, the name of such officer, and the name of such vessel.

And with respect to letters received by the post by any such seaman, the following conditions shall be observed: The postage of each letter, posted within the United Kingdom, shall be duly and properly paid upon putting it into a post-office established under the authority of the Postmaster-General, and it shall be directed to such seaman, specifying on the superscription thereof the trans-port or vessel to which he shall belong, and such letter shall be delivered only to the seaman to whom it shall be directed, or to some person appointed to receive the same, by writing under the hand of the officer in command; and whenever the letters sent by any such seaman shall be sent without the said postage of one penny being prepaid, every such letter shall be charged to the party receiving the same in the United Kingdom with a rate of twopence, and any letters received by the post under this Warrant by any such seaman, which may have been redirected, shall not be charged any postage on or in respect of such redirection.

And we further declare that the said privilege shall not extend to any letters sent through France or any other Foreign Country.

And we further direct that the several terms and expressions used in this Warrant shall be construed to have the like meaning in all respects as they would have had if inserted in the said Act passed in the fourth year of the reign of Her present Majesty.

Provided lastly, and we hereby declare and direct that it shall be lawful for the Commissioners for the time being of Her Majesty's Treasury, or any two of them, by Warrant under their hands, at any time hereafter to alter or repeal any of the rates hereby altered, or the regulations hereby made, and to make and establish any new or other rates or regulations in lieu thereof, and from time to time to appoint at what time the rates that may be payable are to be paid.
