His Highness considers that the success of the construction of this bridge is in great measure attributable to their well-planned dispositions, which, although executed with limited means, proved fully effective to resist the storms and strong currents of the Danube.

He desires me to say that he is fully satisfied with the zeal and indefatigable energy of this detachment of Her Majesty's fleet under the able direction of Lieutenant Glyn, whom he considers a very promising officer, and entirely worthy of the confidence of your Lordship.

His Highness desires me to add that it would be very gratifying to him if Her Majesty could in some way reward these officers for the able services they have rendered to the Ottoman Army and the

common cause.

My Lord Duke,

Before Sevastopol, January 27, 1855.

I HAVE the satisfaction to acquaint your There Grace that the weather continues fine. are severe frosts at night; but the sun shines brightly through the day, and there is an absence of wind, which, whilst it continued, added considerably to the sufferings of the troops.

Every exertion is making, by public transport and individually, in getting buts up; but this is a most difficult operation, and the ground is still so rotten that it is a most arduous labour to pass

The extremely confined space of Balaklava, and the vast accumulation of stores, has obliged me to erect huts at some distance outside the town for their reception.

I enclose the Lists of Casualties to the 25th instant inclusive.
