ORD PANMURE has this day received a Despatch and its Enclosures, of which the following are Copies, addressed to His Lordship by Field-Marshal the Lord Raglan, G.C.B.:—

Before Sevastopol, March 10, 1855.

I HAVE really nothing to report to your Lordship this day.

MY LORD,

I am happy however to be able to inform you that the weather is exceedingly fine; and that I entertain great hopes, derived from the reports of the principal Medical Officer, that the sick will materially benefit by the improvement in the temperature.

Our advanced batteries are making considerable progress.

Every effort is directed to the maintenance of the camps in a healthy state, which, as the warm weather approaches, becomes daily more import-

I enclose the Return of Casualties to the 8th

I received on the evening of the 6th instant a telegraphic Despatch from Lord John Russell, dated Berlin, the 2d, announcing the death of the Emperor of Russia, at twelve o'clock on that day.

According to the information of deserters the event has not been promulgated at Sevastopol.
