L ORD PANMURE has received from the Earl of Clarendon a Letter and its Enclosure, of which the following are Copies, addressed to Lord Clarendon by Major-General Cannon (Ottoman Army) :---

MY LORD, Georgevo, August 1, 1854. I HAVE the honour to forward to your Lordship copy of a Despatch dated 10th July, which I addressed to His Highness Omer Pasha after the action of the 7th July, at Rouschouk, and the passage of the Danube.

I take the liberty earnestly to recommend to your Lordship's most favourable notice the three surviving British Officers therein named, who served under my orders on that day, and I say it without fear of contradiction, that had they not, by their gallantry and firmness, led on the Turkish troops in the manner they did, the fate of that eventful day might have proved to be widely different.

Their names are Lieutenant-Colonels Balfour Ogilvy, Hinde, and Ballard, all of the Indian Army. I have, &c.

HIGHNESS, Rouschouk, July 10, 1854. It being my duty to bring under your Highness' favourable notice the conduct of the British officers engaged in the action of the 7th instant, and the passage of the Danube, I have the honour to state that 1 crossed the river on that morning, with the first body of troops, under the command of Ferik Beker Pasha, accompanied by Captain Bent, of the Royal Engineers, and Lieutenant Ballard, of the Bombay Engineers. These two officers were conspicuous for their gallantry in leading on our light infantry troops against the Russians, and successfully carried everything before them, until strong reinforcements of the enemy arrested their progress. At this critical moment my Aidede Camp, Lieutenant-Colonel Youer Bey (Balfour Ogilvy), who had crossed higher up the river, with a body of 500 men, arrived, and with him Lieutenant-Colonel Beyzad Bey (Hinde). These two officers fought their way in the most gallant and spirited manner, and succeeded in forming a timely junction with the main body of our troops.

It is with pain that I have to inform your Highness that Lieutenant Burke, of the Royal Engineers, was killed whilst acting with a detached body of our troops. I have also the melancholy duty to record the death of Captain Arnold, of the 3d Regiment Madras Light Infantry, and Lieutenant Meynell, of Her Majesty's 75th Regiment of Foot, both serving on my personal Staff. These two brave British officers fell in a desperate conflict with the enemy, and their remains now rest on the spot ennobled by their fall. I am much indebted to all these officers for their valuable services on that day; and when I remind your Highness that the following named officers—Lieutenant-Colonels Youer Bey (Balfour Ogilvy) and Beyzad Bey (Hinde), Captains Arnold, Ballard, and Meynell, were all volunteers, freely and gratuitously giving their services in the just cause of His Imperial Majesty the Sultan, I feel confident your Highness will permit me to recommend the survivors—Lieutenant-Colonels Youer Bey (Balfour Ogilvy), Beyzad Bey (Hinde, 65th Regiment Bengal Infantry), and Captain Ballard, to your Highness' most favourable consideration.

GALLANT REPULSE OF THE ENEMY FROM EUPATORIA, IN NOVEMBER LAST.

> Britannia, in the Archipelago, December 30, 1854.

Eupatoria, November 15, 1854.

I HAVE the honour to inform you, that en-couraged by the catastrophe * mentioned in my other letter of this day's date, and our rockets having been blown down, a large body of the enemy's cavalry, hetween seven and eight thou-sand, supported by sixteen guns of horse artillery, made an attack on us at 3.45 P. M.

. They planted their guus (under cover of the mills) at about a thousand yards in front of our upper rocket battery, where we had two rockets, one 12-pounder howitzer, and an 18-pounder iron carronade, procured from a merchant ship.

They commenced a heavy fire of shot and shell, and with sufficiently good practice to fall very thick around us, and many shot lodged, and several shell exploded, in the parapet of the redoubt. Their fire was returned with great spirit on our side by the two rocket batteries, the upper one commanded by Lieutenant Lambert, of the Spiteful, and Mr Lake, midshipman of the Leander; Lieutenant Hood, of the Arethusa, attended the lower battery, with Mr Mitchell, mate of the Leander, where were two 12-pounder Nigvus and three rockets, one 24-pounder, and two

Having no marines and but few seamen, I reinforced both batteries with fifty Arab troops, who however, as the enemy did not approach within musket shot, had no opportunity of doing anything, though, from their behaviour under fire, they seemed to promise well. The fire was kept up with animation on both sides for nearly an hour, without any casualties amongst us, except one man's thumb slightly wounded; although it seemed wonderful that no one was struck by the shot and shell, which flew pretty thickly. The enemy's cavalry was drawn up in dense masses in the rear and on each flank of their artillery, and though an occasional shot or rocket fell amongst them and disturbed their formation, they seemed to be in excellent order. Both our officers and men seemed animated with the highest spirit, and, considering the immensely superior force on the enemy's side, their firmness merited my warmest approbation. My attention was devoted to the upper battery, being nearest the enemy, and whence I could best observe his movements. Some of our rockets were beautifully directed by Lamb,* gunner's mate of the Arcthusa, and Ball, quartermaster of the Leander, and appeared to fall amongst the horse artillery, and I have no doubt contributed to hasten their retreat, which they did at about 4.40.

I may add that the officers and men did their duty with alacrity, and seemed anxious to have an opportunity of meeting the enemy, I have particularly to call your attention to the steady and cool conduct of Lieutenant Hood, who rode over the field this morning, after the action, and ascertained that our shot and rockets were well directed, and appeared to fall exactly in the right place ; he has recovered many of our shot at a time when we most need them. I have likewise great satisfaction in bringing before your notice the zeal and intelligence of Mr Brine, mate of the Leander, in charge of two 18-pounder merchant ship's guns, at the Hospital-post, and he has reported to me the good conduct of James Montgomery, leading seaman of Her Majesty's ship Leander; I beg to recommend him to your favourable consideration. The Tartars say the Russians lost many men, as they saw many saddles vacant.

I have great pleasure in particularizing the con-duct of Mr Hamilton, senior lieutenant of the Leander, from whom I have received the most efficient assistance throughout these trying times to both officers and men, as well as that of Messrs Irvine, mate of the Megæra, Dupuis, midshipman of the Leander, Phillips, master's assistant of the Megæra, who has acted as my aide-de camp, Ductor Blake, assistant-surgeon of the Leander, and the Rev. S. Robson, of the same ship, whose manifold services in the field, as well as his own duties, have merited great praise. Assistant-Commissary-General Gardiner I have found a most able assistant in every thing connected with his duty. I respectfully trust that, in the defence of this town that you have done me the honour to entrust me with, I have, as far as my limited means will allow, carried your wishes into effect.

I DO myself the honour to transmit to your Lordship a Letter from the Inspector-General of Hospitals, forwarding the Weekly Return of Sick to the 17th instant.

The number of Sick is not diminished, but the cases are lighter, and every day the men in camp exhibit a more healthy appearance.

Before Sevastopol, March 19, 1855.

In transmitting the weekly state of sick of the Army to the 17th instant, I have the honour to state that though the sickness still amounts to 14.31 per cent., the mortality does not exceed 0.51 per cent., which is a proof that the diseases are milder in character; and I think I may safely say the general health and appearance of the men is greatly improved; and had not the duty, by the unavoidable operations of the siege going on, been increased of late, I think the sick list would have been still more diminished, as the men's condition is in every other way so much improved both in diet, dress, and accommodation.

It has been proposed by the Minister at-War to give the men Tea, Coffee, and Cocoa on alternate mornings, and to morrow your Lordship will receive the report of the Medical Board ordered to consider the subject. The two first I think good, and the change will be both agreeable and beneficial to the men, but cocoa I am afraid requires too much preparation to be usefully adopted in the Army under present circumstances. The prevailing diseases are fevers of a low typhoid

The prevailing diseases are fevers of a low typhoid form in some instances, and in others assuming an intermittent and remittent type, and bowel complaints.

Fevers have been rather on the increase of late, but bowel complaints have become much fewer in number and milder in character.

Scurvy too, though the number appears large in the Return, is on the decrease; and I can assure your Lordship, from recent personal inspection of the men of the different Divisions, that the generality of the cases returned under that head are of the most triffing character, and under the use of the present change of diet I am in hopes the disease will soon totally disappear from our list.

In the 1st Division, the Brigade of Guards continues to improve in health and appearance, from its change of situation; and the Brigade of Highlanders is also efficient. The 79th and 93d are influenced by the locality of their camps, which cannot well be changed, and have more sickness than the 42d, which are more favourably placed, and in this regiment the most scrupulous attention is paid to the sanitary condition of their camp.

is paid to the sanitary condition of their camp. To show how locality affects the health of the men, I may mention the wing of the 2d battalion of the Rifle Brigade which occupies the high promontory of the southern extremity of the Balaklava lines overlooking the sea ; and here, though

the men are exposed, and the duty is as severe as in any other part of the camp, there is little or no disease.

In the 2d Division, the 41st and 95th Regiments have been more unhealthy than the rest, and have had a larger number of fever cases than others admitted into hospital, and many of them have been of a serious character. It is difficult to account for this, as there is nothing in the locality of the ground occupied by these two regiments different from that of the rest of the Division. Perhaps their tents were a little more crowded than the rest, and the bospital huts, from the pressure of sickness, had more men in them than was advisable; but this I directed to be remedied when I visited the hospitals a few days ago. The health of the 3d Division is improved, de-

The health of the 3d Division is improved, decidedly so in some of the regiments; and the health of the 4th and Light Divisions is improved also.

The cavalry, with the exception of the 2d Dragoons, is in good health, and the health of the 2d, the Superintending Medical Officer seems to think, has been influenced by local causes that are now in course of removal.

The health of the artillery has been tolerably good during the week, and the cases under treatment, both in the general and convalescent hospitals at Balaklava, have progressed favourably; and when the remainder of the hospital huts at the Castle come into use, I expect great advantage from their occupation, both by convalescents and wounded men, should we unfortunately have any.

Before Sevastopol, March 20, 1855.

IN my Despatch of the 17th instant I reported to your Lordship the progress made in forming the parallel constructed to unite the right of our right attack with the left of the French on the Inkerman heights.

The contest of the latter with the enemy for the possession of the Rifle pits in their immediate front was renewed after dark on that night, and was continued for several hours, the fire being excessively heavy, particularly of musketry, and considerable loss must have been sustained by our Allies I fear, as well as by the enemy, who continue to hold the ambuscades; but the French persevere, notwithstauding, in working forward, and are approaching the mamelon, on which the Russians are busily engaged in building a formidable work, though frequently interrupted by our batteries and those of the French.

batteries and those of the French. On the night of the 17th the English parallels were not attacked, but the fire to which I have above alluded was so continuous that the whole force was either under arms or ready to turn out.

I enclose the Returns of Casualties to the 18th instant.

It was currently reported yesterday that Prince Menchikoff had died on his way to Moscow. I have not been able to ascertain if this report be founded; but it was so fully credited as to have been despatched to Constantinople.

Prince Gortchakoff is stated to have arrived at Bachshi Sarai, and to have assumed the command of the army.

Reinforcements are reported to be on their way from Russia, and the 9th Division to have reached the neighbourhood of Eupatoria. The position of the Russian troops in the vicinity of the Tchernaya remains unaltered.

The progress of the railway continues to be satisfactory, and we are already enabled to use it with considerale advantage, both for the conveyance of supplies and hutting, so far as the high ground some way on this side of Kadikoi.

Mr Beattie's exertions deserve every commendation.

TREASURY WARRANT.

WHEREAS by an Act passed in the fourth year of the reign of Her present Majesty, intituled "An Act for the regulation of the Duties of Postage, power is given to the Postmaster-General to remit any of the rates of British postage for the time being, payable by law on the transmission of Post Letters, newspapers, or other printed papers, to such extent as the Lords of the Treasury shall from time to time direct; and power is also given to the Commissioners of Her Majesty's Treasury from time to time, by Warrant under their hands, to alter and fix any of the rates of British or Inland postage, payable by law on the transmission by the Post of Foreign or Colonial letters or newspapers, or any other printed papers, and to subject the same to rates of postage according to the weight thereof, and a scale of weight to be contained in such Warrant.

And whereas it is expedient that regulations should be made for the transmission by the Post of the letters hereinafter mentioned.

Now we, the Commissioners of Her Majesty's Treasury, in exercise of the power or authority in us for such purpose vested in and by the said Act, and of all other powers enabling us in this behalf, do, by this Warrant, (under the hands of two of us, the said Commissioners, by the authority of the Statute in that case made and provided,) order and direct that on every letter not exceeding one quarter of an ounce in weight, posted in or addressed to any part of the United Kingdom, and sent from or to any commissioned Officer employed in Her Majesty's regular Forces, Artillery, or Royal Marines, in the Baltic Sea or the adjacent waters, or sent from or to any commissioned or warrant officer, midshipman, or master's mate, employed in Her Majesty's Navy, or any of Her Majesty's ships in the Baltic Sea or the adjacent waters, transmitted by the post between any place in the United Kingdom and any port or place in the Baltic or the adjacent waters, either by packet-boat, or viâ Bel-gium and Prussia, or by any other route, there shall be charged and taken in lieu of any rates of postage now payable by law on such letters, a uni-form rate of three pence, (which shall include any Foreign postage that may be payable thereon.)

And we further order and direct that on every letter not exceeding one quarter of an ounce in weight, posted in or addressed to any part of the United Kingdom, and sent from or to any noncommissioned officer, serjeant, corporal, drummer. trumpeter, fifer, or private soldier, employed in Her Majesty's regular Forces, Artillery, or Royal Marines, in the Baltic Sea or the adjacent waters, or sent from or to any seaman employed in Her Majesty's Navy, or any of Her Majesty's ships in the Baltic Sea or the adjacent waters, transmitted by the post between any place in the United Kingdom, and any port or place in the Baltic Sea or the adjacent waters, via Belgium and Prussia, there shall be charged and taken, in lieu of any rates of postage now payable by law on such letters, a combined British and Foreign rate of three pence.

And we direct that on every letter transmitted as is mentioned in this Warrant, exceeding a quarter of an ounce in weight, there shall be charged, taken, and paid, in lieu of any rates of postage now payable by law on such respective letters, progressive and additional rates of postage as follows; that is to say :

- On every letter, exceeding a quarter of an ounce in weight, and not exceeding half an ounce in weight, two rates of postage.
- On every letter exceeding half an ounce in weight, and not exceeding three quarters of an ounce in weight, three rates of postage.
- On every letter exceeding three quarters of an ounce in weight, and not exceeding one ounce in weight, four rates of postage.
- And for every quarter of an ounce in weight above the weight of one sunce, there shall be charged and taken one additional rate of postage ; and every fraction of a quarter of an ounce above the weight of one ounce shall be charged as an additional quarter of an ounce ; and each progressive and additional rate chargeable under this clause, shall be estimated and charged at the sum which any such letter would be charged with under the provisions hereinbefore contained, if not exceeding one quarter of an ounce in weight.

And we further direct that in respect of letters sent by any non-commissioned officers, serjeants, corporals, drummers, fifers, private soldiers, or seamen, under the regulations of this Warrant, the following conditions shall be observed ; that is to

say :---upon each such letter shall be superscribed | the name of the writer, and his class or description in the regiment, detachment, or vessel to which he shall belong; and upon every such letter there | shall be written in the handwriting of, and signed by the officer having at the time the command of the regiment, detachment, or vessel to which the privileged person belongs, the name of such officer, and the name of such regiment, detachment, or vessel.

And we further direct that in respect to letters received by the Post under this Warrant, by any commissioned or warrant officers, midshipmen, or master's mates, or any non-commissioned officers, private soldiers, or seamen, the following conditions shall be observed; that is to say :--the postage of each such letter posted in the United Kingdom shall be prepaid either in money or by the proper stamp or stamps being affixed thereto at the time of the same being posted ; and as to letters received by any non-commissioned officers, private soldiers, or seamen, each letter shall be directed to the privileged person, specifying on the superscription thereof the regiment, detachment, or vessel to which he shall belong.

And we further direct that if the postage of any such letter posted in the United Kingdom shall not be prepaid either in money or by stamps when posted, the same shall not be forwarded by the post; and that if in any case any other of the conditions hereinbefore prescribed be not complied with, the letter shall be charged with the same rates of postage as if this Warrant had not been signed.

And we further direct that the several terms and expressions used in this Warrant shall be construed to have the like meaning in all respects as they would have had if inserted in the said recited Act.

Provided lastly, and we hereby declare and direct that it shall be lawful for the Commissioners for the time being of Her Majesty's Treasury, or any two of them, by Warrant under their hands, at any time hereafter to alter or repeal any of the rates hereby altered, or the regulations hereby made, and to make and establish auy new or other rates or regulations in lieu thereof, and from time to time to appoint at what time the rates that may be payable are to be paid.
