MY LORD, Before Sevastopol, May 19, 1855. I HAVE the honour to enclose the copy of a letter from Captain Montagu, of the Royal Engineers, prisoner of war, dated Simpheropol, April 28, 1855, transmitting a list of British Prisoners who died either there or on their road from Sevastopol.

I beg to forward this Return in duplicate.

Your Lordship will see with satisfaction that the British Prisoners who are sick in the hospital at Simpheropol receive equal, if not greater attention than the Russian soldiers from the Authorities, and are constantly receiving presents from visitors. I have, &c. RAGLAN.

SIR, Simpheropol, April 28, 1855. I HAVE the honour to enclose the accompanying list of Prisoners who died either here or on their road from Sevastopol. There are some others dead, but Thomas Verry, 8th Hussars, who furnished me with this list, could not remember the names of the rest. I have &c.,

I have been given to understand that the Prisoners who are sick in hospital have received equal if not even greater attention than their own soldiers from the Authorities, and are constantly receiving presents, &c., from visitors. There are five or seven men who will be sent the first opportunity to Odessa, for the purpose of being forwarded to England, they being incapable of serving again.

#### DOWNING-STREET, May 30, 1855.

The Queen has been pleased to appoint Major-General Edward Wells Bell to be Lieutenant-Governor of the Island of Jamaica.

Her Majesty has further been pleased to appoint Henry Augustus Tudor, John James Haddock, and Charles Lloyd Pedder, Esquires, to be Non-elective Members of the Legislative Council of the Virgin Islands.

#### TREASURY WARRANT.

Whereas by an Act passed in the fourth year of the reign of Her present Majesty, initialed "An Act for the regulation of the duties of postage," power is given to the Commissioners of Her Majesty's Treasury, from time to time, by Warrant under their hands, to alter and fix any of the rates of British or Inland postage payable by law on the transmision by the Post of Foreign or Colonial letters or newspapers, or any other printed papers, and to subject the same to rates of postage according to the weight thereof, and a scale of weight to be contained in such Warrant.

And whereas it is expedient that regulations should be made for the transmission by the Post of the letters hereinafter mentioned.

Now we, the Commissioners of Her Majesty's Treasury, in exercise of the power or authority in us for such purpose vested in and by the said Act, and of all other powers enabling us in this behalf, do, by this Warrant, under the hands of two of us the said Commissioners, by the authority of the Statute in that case made and provided, order and direct that on every letter not exceeding half an ounce in weight transmitted by the Post between any place in the United Kingdom and the Colony of Van Dieman's Land (direct or through any other Colony, or through any Foreign Country), there shall be charged and taken in lieu of any rates of British postage now payable by law on such letters, an uniform British rate of sixpence.

And we direct that on every letter not exceeding half an ounce in weight, transmitted by the Post between Van Dieman's Land and any other of Her Majesty's Colonies, or any Foreign Country through the United Kingdom (whether through any Colony or Foreign Country or not,) there shall be charged and taken in lieu of any rates of British postage now payable by law on such letters, the rates of British postage following; that is to say :-

For the conveyance of every such letter between Van Dieman's Land and any part of the United Kingdom a rate of sixpence, and for the conveyance of every such letter between the port in the United Kingdom of the departure or arrival of the packet or ship conveying the same, and the Colony or Foreign Country to or from which the same shall be forwarded, such a further or additional rate of postage as shall from time to time be charged and payable for British postage on letters posted or delivered at the port in the United Kingdom of the departure or arrival of the packet or ship conveying the same, and trans-mitted direct between such port and any such Colony or Foreign Country.

And we direct that on every letter transmitted as is mentioned in this Warrant, exceeding half an ounce in weight, there shall be charged, taken, and paid, progressive and additional rates of postage as

NEWSPADE ory such letter exceeding half an ounce in weight and not exceeding one ounce in Weight, two rates of postage.

- On every such letter exceeding one ounce and not exceeding two ounces in weight, four rates of postage.
- On every such letter exceeding two ounces and not exceeding three ounces in weight, six rates of postage.
- And on every such letter exceeding three ounces and not exceeding four ounces in weight, eight rates of postage.
- And for every ounce in weight above the weight of four ounces there shall be charged and taken two additional rates of postage, and every fraction of an ounce above the weight of four ounces shall be charged as one additional ounce, and each progressive and additional rate chargeable under this clause shall be estimated and charged at the sum which any such letter would be charged with under this Warrant if not exceeding half an ounce in weight.

And we direct that in all cases in which any letter, in respect of which any rate of postage is chargeable by this Warrant, shall pass through a Foreign Country, any Foreign postage payable thereon shall be charged and paid thereon in addition to the British postage. And we further direct that nothing in this

Warrant contained shall be deemed or construed to Extend to any letters posted in or addressed to France, or any Foreign Country through France, and transmitted between France or Foreign Countries (through France) and Van Dieman's Land; all which last-mentioned letters shall be charged and chargeable with the same rates of postage as if this Warrant had not been signed.

And we further direct that nothing herein contained shall be deemed or construed to annul, prejudice, or affect any of the exemptions and privileges granted by or under the said recited Act, or by or under any other Acts of Parliament relating to the Post-Office, and that all such exemptions and privileges shall remain in full force.

And we further direct that the term "by the Post," used in this Warrant, shall, as to the sea conveyance, include the conveyance by any British, or Colonial, or Foreign packet-boat, (packet-boats belonging to or employed by or under the Government or Post-Office of the United States of America and French Mediterranean packet-boats excepted,)

and also the sea conveyance by any private ship. And we further direct that this Warrant shall come into operation on the 1st day of August 1855, so far as respects letters transmitted from the United Kingdom addressed to Van Dieman's Land, and on the 1st day of October 1855 so far as respects letters transmitted from Van Dieman's

Land to the United Kingdom. Provided lastly, and we hereby declare and direct that it shall be lawful for the Commissioners for the time being of Her Majesty's Treasury, or any two of them, by Warrant under their hands, at any time hereafter, to alter or repeal any of the rates hereby altered, or the regulations hereby made, and to make and establish any new or other rates or regulations in lieu thereof, and from time to time to appoint at what time the rates that may be payable are to be paid. The Lords of the Committee of Privy Council for Trade have addressed the following letter to the Commissioners of Customs, on the subject of continuing for a limited period the system of regis-tration, de novo, in this country, of Colonial ships, as practised before the Merchant Shipping Act, 1854, came into operation. The Commissioners of Customs have issued the subjoined Order on the subject.

# Office of Committee of Privy Council for Trade, Marine Department, May 25, 1855.

VARIOUS communications having been made to my Lords concerning the inconvenience sustained with respect to ships registered in the British Possessions abroad, in consequence of the mode in which the changes effected by the Merchant Shipping Act have been brought into operation, I and directed to bring the subject to the notice of the Commissioners of Customs, and to request their attention to the following observations and suggestions :--

#### The cases complained of are twofold-

SIR,

1. Where a ship being registered in a Colony, a Bill of Sale, or a Power of Attorney to execute a Bill of Sale, have been sent by the registered owner to the United Kingdom.

2. Where a ship being registered in a Colony, the registered owner is in the United Kingdom, and wishes to sell her here.

In both these cases, the registrars of shipping would, before the 1st of May, have registered the ship de novo, without waiting to ascertain the state of the Colonial register ; whilst, since the 1st of May, they have refused to register the ship de novo in this Country, and the Commissioners of Customs have supported them in such refusal.

This Board entirely concur with the view which the Commissioners have thus taken of the principles on which the system of ship registry should be carried into effect.

One of the most important objects of the system introduced by the recent Act is to prevent a ship from being disposed of in two places to two differ-ent persons at the same time; and to effect this object it is necessary that all dealings with the register of the ship should either be effected at her port of registry, or appear on the register book kept at that port.

If it is wished to sell or mortgage the ship in any part of the Empire other than that in which the ship is registered, Statutory Powers of Attorney for the purpose (called in the Act " Certificates of Sale or Mortgage,") can be procured at the port of regis-try. These Certificates will confer a perfect title on those who take under them; whilst, as they will be good a position, so far as regards registry, as they entered on the register book at the port of regis could have enjoyed under the former practice; try, persons who might desire to purchase or lend whilst they will have the additional advantage

money on the ship there, will have full notice of their existence.

My Lords consider it of very great importance for the interests of shipping that these Certificates should be brought into use as quickly and as universally as possible, and that nothing should be done which would have the effect of permanently infringing the principles of the new system, or of inducing persons concerned in shipping to believe that it will henceforth be possible to confer a title to a ship by any means except those which the Act, and the Regulations which have been issued under it, point out as necessary.

But since it appears that it has under former Acts been the practice to register Colonial ships de novo in this country, upon the production of duly executed Bills of Sale, without first ascertaining the State of the Colonial Register; and since it further appears that many ships have lately been sent, and are now being sent from the Colonies, for the purpose of being sold in this country, according to the practice which has heretofore prevailed, and that considerable inconvenience would be caused if the new system were brought suddenly into stringent operation :

My Lords wish to suggest to the Commissioners the expediency of adopting the following relaxations, to take effect at once, and to last during such time only as may be necessary to bring the new system into complete operation.

1. Ships registered in the Colonies may, for such time as hereinafter mentioned, be registered de novo in this country, upon the production of such documents or evidence of title as the registrars have heretofore been in the habit of receiving as sufficient.

2. In all such cases the vendor or his agent shall give to the registrar security that the transaction shall be completed, and that the registrar and the Commissioners shall be kept harmless from any loss or damage which they might incur if it were to happen that the ship was in the meantime disposed of in the Colony. A suggested form of bond for this purpose is enclosed.

3. The vendor or his agent must fill up, and sign and deliver to the registrar at the port of registry, de novo, a form of application to the registrar at the port of original registry in the Colony, calling for a transfer of the registry under the provisions of the Act. This application the registrar at the port of registry, de novo, will for-ward with the old Certificate of Registry to the Colony. A suggested form of application is enclosed, with forms of letters from the registrar in this country to the Colonial registrar, and of the reply to be sent by the latter.

4. On registering the ship de novo, the registrar will insert in his book the words " registry to be transferred from the Port of and on receiving the requisite information from the Colonial registrar, he will write under those words, "registry completed by transfer from the Port of ," with the date. Port of

5. The relaxation is to take effect at once, and to last, as to ships registered in the American Colonies, until the end of September, and as to ships registered in more distant Colonies, until the end of February next.

The effect of the relaxation will be to place the persons who accept the title in this country in as (which they could not have had under former Acts) that their equitable title to the ship will, under the provisions of the new Act, be perfectly good.
