NOTICE is Hereby Given, that Her Majesty will hold a Levee at St James's-Palace on Wednesday the 27th instant, at Two o'clock.

REGULATIONS TO BE OBSERVED AT THE QUEEN'S LEVEE AT ST JAMES'S-PALACE.

The Noblemen and Gentlemen who purpose to attend Her Majesty's Levee at St James's-Palace are requested to bring with them two large cards, with their names *clearly written* thereon, one to be left with the Queen's Page in attendance in the Ante-Room, and the other to be delivered to the Lord Chamberlain, who will announce the name to Her Majesty. Those Gentlemen who are to be presented are

Those Gentlemen who are to be presented are hereby informed it is absolutely necessary that their names, with the name of the Nobleman or Gentleman who is to present them, should be delivered at the Lord Chamberlain's Office before twelve o'clock on the Monday previous to the Levee, or upon any earlier day, between the hours of eleven and four, in order that they may be submitted for the Queen's approbation; it being Her Majesty's command that no presentation shall be made at the Levee but in conformity with the above Regulations.

It is particularly requested that in every case the names be very distinctly written upon the cards to be delivered to the Lord Chamberlain, in order that there may be no difficulty in announcing them to the Queen.

The State Apartments will not be open for the reception of Company coming to Court until half-past one o'clock.

Notice is hereby given, that all persons having Petitions or Addresses to present to Her Majesty at the Levee, are to send a card (having on it their names, a statement of the object of such Petitions or Addresses, and the names of the persons from whom they come,) to the Lord Chamberlain's Office before twelve o'clock on the Monday previous to the Levee ; and that two other cards, having on them precisely what is written upon that sent to the Lord Chamberlain's Office, are to be taken to the Levee ; one of the two cards to be delivered to the Page in the AnteRoom, and the other to the Lord Chamberlain, who will read its contents to Her Majesty; and on these occasions no other statement is to be addressed to Her Majesty.

A Deputation to present an Address is not to exceed four persons.

THE REPORT OF THE PATRIOTIC FUND COMMISSIONERS.

To The QUEEN's Most Excellent Majesty.

WE, your Majesty's Commissioners for the formation and application of a Patriotic Fund for the relief of the Widows and Orphans of the Soldiers, Sailors, or Marines who may be killed or may die on active service during the present war, now humbly beg to present to your Majesty a First Report of our proceedings, and of the arrangements which we have deemed it expedient to make for giving an early effect to your Majesty's gracious intentions.

Measures taken for Collecting fund.

2. Acting under the sanction of one of your Majesty's Secretaries of State, our Honorary Secretaries proceeded at once, on the promulgation of the Royal Commission in the London Gazette of the 16th October 1854, to communicate with the Commissioners in Aid, both at home and abroad, and to request their assistance for the formation of Local Committees to collect and transmit the gifts and voluntary subscriptions of your Majesty's loyal subjects to the Patriotic Fund. To facilitate those measures our Honorary Secretaries issued the notice (A.) in the Appendix.

Amount collected, and the classes from whom received.

3. The unprecedented amount which, in the short space of six months, has been contributed in answer to that appeal is a most satisfactory proof of the eagerness with which your Majesty's subjects have embraced an occasion of testifying at once their loyal support of the great contest in which our country is engaged, and their recognition of the claims of those gallant men who may unhappily fall in it. A sum exceeding a Million sterling has now been paid into the Bank of England to our account. Every class of the

community has contributed liberally to the Fund. On the one hand, the nobility, the gentry, the great corporate mercantile bodies of the kingdom, have proportioned their donations to the greatness of the occasion, and to their large share of the blessings bestowed by Providence upon this favoured land. On the other, we have found that the brilliant deeds of our countrymen in arms have awakened equal sympathy in every class of humble life, even among those whose generous impulses can be gratified only at the cost of pri-vation and self-denial. Contributions of large amount have been received from agricultural districts and rural parishes, swelled by the spontaneous bounty of the peasantry, artizans, domestic servants, workpeople, labourers, individually and in associations, have felt a patriotic pride and a generous satisfaction in answering their Sovereign's appeal. In one striking instance the inmates of the Reformatory Asylum, Smith Street, Westminster, having literally nothing of their own to give, denied themselves a meal, that its value might be offered as their gift. We deem it a fact deserving your Majesty's notice that even the children of the poorer classes have very generally contributed their "mite" to enlarge the amount of the Nation's bounty.

Sums collected from Colonies, English residents abroad, and from Foreigners.-Collections from Foreign Countries.

4. It will be our duty hereafter to submit to your Majesty as detailed a statement as may be practicable of the sources from which the Patriotic Fund has been derived. Your Majesty will be gratified to hear that the contributions have not been confined to Great Britain, or even to your Majesty's subjects. Very large sums have been received from British residents abroad. Your Majesty's representatives in the colonies, acting as Commissioners in Aid, have been warmly seconded by the loyal feelings of your Majesty's colonial subjects, in proof of which we can point to magnificent contributions from India, from the North American colonies, from Australia, and in fact from nearly every British possession; amongst other contributions may be mentioned that of the Six Nation Indians, who have subscribed the sum of £100. Your Majesty's Consuls-General, Consuls, and other influential British subjects also, in all parts of the world, have manifested a laudable zeal in contributing themselves, and in encouraging and collecting contributions to the National We have peculiar pleasure in reporting Fund. to your Majesty that the natives of many foreign countries also have spontaneously and largely contributed, and have accompanied their donations with kind expressions of sympathy for the sufferers, and testimony to their sense of the justice of the war in which your Majesty and Allies are engaged.

Amount of Fund.

5. We beg to submit, in Appendix B, a detailed account of the sums received in each month since the opening of the subscription, and a statement of the mode in which they have been invested.

Distribution of Relief by Honorary Secretaries.

6. Appointment of Finance Committee.

7. In conformity with the authority given to us, we proceeded at once to nominate an Executive and Finance Committee, composed of the following :-

Having selected the Lord St Leonards as their Chairman, this Committee has since held regular meetings, and has made us two reports, of which we have approved, and which we humbly submit to your Majesty in Appendix D, 1 and 2.

Powers conferred by the Commission.—Claims of Widows of Superior Officers deferred.— Amateur Artists' Fund, Burlington House.

8. Upon a careful consideration of our powers, we are led to the conclusion that while they do not exclude the Widows and Orphans of Commissioned Officers of the Army, Navy, and Marines, yet, inasmuch as a provision has been made by your Majesty's pension warrant and compassionate allowances for the relief of claimants of that class, they cannot in general be considered as primary objects of the royal commission. Consequently, we have deferred for the most part the claims of this class till the number and urgency of those of the primary classes, viz.—those of Widows and Orphans of Non-commissioned and Petty Officers, Private Soldiers, Seamen, and Marines, for whom no such provision exists, should be known and provided for. We are happy, however, to be able to report, that through the instrumentality of the Committee of Amateur Artists, several sums of money have already been placed at our disposal for immediate distribution amongst the Widows and Orphans of all classes of Officers. We have already offered our warm acknowledgments to the Committee ; and we have to report to your Majesty that the money has been applied in the relief of several pressing claims, and has elicited very grateful acknowledgments from the recipients.

Applications of Officers' Widows and Orphans.

9. Omitting, from motives of delicacy, the names of the Applicants, we submit to your Majesty, in Appendix E, the cases of all those ladies who have applied for assistance, as an index to the circumstances in which it is too probable that many gallant Officers may leave their Widows and Families in the event of their falling in the present war.

First Estimate of the Number of Widows and Orphans.

to collect, that the naval and military operations in which the country had then been engaged, had already thrown upon the bounty of the country 2,000 widows and 3,400 orphans, and on this supposition the first scale of allowance that we sanctioned was framed; but, finding the estimate of numbers, especially in the case of orphans, was excessive, we have been induced to substitute an amended scale. These are given in Appendices F and G. How many may be added to these should the war unhappily be prolonged, it is impossible for us to conjecture. It cannot be doubted, however, that the number will be considerable. Each week, under present circumstances, from 70 to 80 widows are added to the number receiving relief, not in many cases from the recent death of their husbands, but from the fact that they have not been previously informed of their bereavement.

Number of Widows and Orphans now receiving Relief.

11. The total number of widows of the primary class, who have actually applied for and received relief up to the 10th of May 1855, falls considerably short of the number we estimated for above; it is 1,487; and in connection with them are 1,802 children, exclusive of 33 children who have lost both parents. The table in Appendix H shows the districts in which they are residing, and the numbers belonging to the army and navy respectively.

Resolutions for the guidance of the Finance Committee.

12. We beg humbly to lay before your Majesty, in a concise form, a series of resolutions we have come to for the present guidance of our Executive Committee in the distribution of the Fund to the primary classes, and which your Majesty will find in Appendix I.

Measures with reference to Education.

13. In the enumeration of the benevolent objects promoted by your Majesty's Royal Commission, a prominent place is given to the all-important boon of education. To this object we have directed our careful attention. In the great uncertainty which must prevail for some time to come as to the number of orphan children of any class who may look to us for protection, it would be premature to originate any large or general measure. In many cases benevolent individuals have undertaken the charge and education of orphan children. Some of the principal Orphan Asylums have offered to provide for others; and our Executive and Finance Committee has given a general notice that it will defray the small weekly charge incurred by sending any of the children of mothers relieved from the Fund to the ordinary schools of their localities, having due regard to the religious opinions of the children or of their parents. We have further authorized this Committee to place orphans for education in any asylum, industrial school, or other establish-ment for receiving orphans or destitute children, which offers itself in their neighbourhood ; but for the present we have thought it desirable not to authorize the Committee to purchase perpetual rights of presentation, or to endow or enlarge any such establishments.

The Offices of the Royal Commissioners of the "Patriotic Fund" are for the present at No. 16A, Great George Street, corner of Parliament Street, Westminster.

The "Commissioners in Aid" of the "Patriotic Fund" are earnestly requested, without further notice, to take immediate steps for giving publicity within their several jurisdictions to the Royal Commission, in order that Local Committees be formed, wherever practicable, with the least possible delay.

"Local Committees" will, according to their discretion, obtain contributions to the Patriotic Fund either by public meetings, establishing subscription lists, or otherwise.

The acknowledgment of individual donations, where obtained through the "Commissioners in Aid" or by "Local Committees," must in all cases, to avoid error and expence, be left exclusively to the "Local Committees."

Local Committees are requested to make up their first subscription lists and accounts in or before the first week in December next, and to remit the amounts in or before the following week, by drafts payable to the "Patriotic Fund," crossed "Bank of England," to the Secretaries of the Commission, or direct to the Bank of England.

direct to the Bank of England. Total amounts only, as transmitted by Local Committees, will be acknowledged at fixed periods in two London daily newspapers.

Donations, subscriptions, and contributions to the "Patriotic Fund," other than those paid to Local Committees, will be received by the Secretaries at the offices of the Royal Commission as above, at the Bank of England, and by all London Bankers. Acknowledgments of the receipt will appear from time to time in the London papers above mentioned; but it is hoped that no separate receipts or acknowledgments will be required from the Honorary Secretaries, whose duties will be otherwise sufficiently laborious.

WAR-DEPARTMENT, June 18, 1855.

Despatches and their Enclosures, of which the following are Copies, addressed to His Lordship by Field-Marshal the Lord Raglan, G.C.B.-

My Lord.

Before Sevastopol, June 5, 1855.

I AM deeply concerned to have to inform your Lordship that Rear Admiral Boxer died on board the Jason last night, outside the harbour of Balaklava, after a very short illness. He was removed to that ship in the hope that

the pure sea air might prove beneficial to him ; but this expectation was not fulfilled. His malady made rapid progress, and early in the afternoon of yesterday it was intimated to me that his life was despaired of.

His nephew died of cholera last week, and this melancholy event so deeply affected him that his health at once gave way, and he sunk under the same disease.

It is well known that this Officer devoted his whole life to the public service. Since he under-took the appointment of Admiral Superintendent of the harbour of Balaklava, he has applied him-self incessantly to the discharge of his arduous duties, exposing himself in all weathers; and he has rendered a most essential service to the Army by improving the landing-places and establishing wharves on the west side of the port, whereby the disembarkation of stores and troops has been greatly accelerated, and communications with the shore have been rendered much easier.

My Lord,

Before Sevastopol,

I HAVE great satisfaction in informing your Lordship that I received intelligence the night before last of the evacuation of Soujak Kali by the Russians on the 28th ultimo.

It appears that previously to their retirement from the place the troops destroyed the principal buildings and the armament, which consisted of about sixty heavy guns and six mortars, and it is concluded that they have joined the garrison of Anapa, from whence many of the inhabitants have removed.

Sir Edmund Lyons has been so good as to send me the detached report of the naval operations in the Sea of Azof, which will reach England either before or at the same time as this Despatch. They reflect the highest credit on Captain Lyons of the Miranda, and the officers and men serving under his orders, and are remarkable for the intelligence, gallantry, and judgment with which they have been conducted ; and it is a matter of much gratulation, which will be peculiarly felt by Her Majesty, that whilst great injury has been inflicted on the enemy in the loss of resources of every description, the most brilliant and unwonted success has been achieved in an incredibly short time, with only one casualty, and that not of a serious nature.

These gallant exploits of the Navy have spread joy in our camps, and afforded vast satisfaction to every individual in the Army.

A body of French troops under the command of General Morris and General Canrobert, and a column of the Sardinian Corps under General La Marmora, made a reconnaissance on Baidar, on the morning of the 3d.

The former proceeded along the Woronzow road, and pushed their cavalry several miles beyond Baidar; the latter operated on the left through a mountainous district, and advanced into Baidar, after a fatiguing march ; only a small number of Cossacks showed themselves.

Nothing has occurred in front of the town.

> Before Sevastopol, June 5, 1855.

MY LORD, June 5, 1855. I HAVE the honour to enclose a letter from the Inspector - General of Hospitals, forwarding the Weekly State of the Sick of the Army.

The cholera has sensibly diminished in the camps before Sevastopol, but it has attacked the Guards and the 31st Regiment, near Balaklava, and some of the new batteries, as well as the followers of the Army in that town. It is hoped that the disease will pass from them as it has from the stations where it first appeared.

I am grieved to have to say that it has fallen heavily on the Sardinian Contingent, and that General La Marmora is in great anxiety about it. I am rendering him all the assistance in my power. Whilst writing to your Lordship, an Officer has brought me a letter from him, announcing that his brother, General La Marmora, who commands his second division, has been very severely attacked. He has been accommodated with a quarter at Kadikoi, and every attention shall be paid him.
