THIS Morning, at Half-past Seven, Her Most Gracious Majesty THE QUEEN, accompanied by His Royal Highness The PRINCE ALBERT, and Their Royal Highnesses The PRINCE of WALES, The PRINCESS-ROYAL, PRINCESS ALICE, PRINCE ALFRED, PRINCESS HELENA, and The PRINCESS LOUISA, and Suite, left Her Majesty's Royal Palace of Holyrood *en route* for Windsor Castle, where they arrived at Forty-five Minutes past Seven P.M.

On Her Majesty's departure a Royal Salute was fired from the Guns of the Castle.
