ORD PANMURE has this day received a Despatch and its Enclosures, of which the following are Copies, addressed to his Lordship by General Sir James Simpson, G.C.B.:—

Sevastopol,

MY LORD,

October 27, 1855.

I HAVE the honour to transmit a copy of a letter I have received from Brigadier-General the Honourable A. Spencer, informing me of the return of the force under his command to Kinburn, after having made a short reconnaissance.

As it has been decided that the French will garrison the Fort, the English troops will return here, and I expect them about the 3d November.

I have to report the arrival, on the 25th instant, of a detachment of prisoners, to the number of 132, from Odessa, where the greatest part of them arrived on the 24th September.

Amongst them is Lieutenant James, of the Royal Engineers, who was taken on the night of the 2d of July; he has been kept at Reazan, and reports having been very well treated by the Russians.

The prisoners have been kept at Voronetz on the Don, and, when they left, there were only two remaining, who were sick, and fifty-one deserters. I transmit the nominal list of the men.

The force from Eupatoria, under the command of General D'Allonville, made a recounaissance on the 22d instant. They fell in with a large force of the enemy and offered them battle. The Russians, however, retreated before them after an exchange of a few rounds with the Horse Artillery.

I beg to enclose a copy of the report of Brigadier-General Lord George Paget, in command of the English cavalry at that place.

I have the honour to report the departure of all the Turkish force that were here, for Asia, with the exception of some Artillery, which has been transferred to the Contingent.

The weather continues magnificent, and the health of the troops all that can be desired.

Kinburn, October 24, 1855.

I HAVE the honour to report, for the information of the Commander-in-Chief, that the troops under my command, as per margin, \* returned yesterday evening from the reconnaissance they made in company with the French Army.

The force left Kinburn on the 20th instant, bivouacked that night and the following at the village of Patowffka (8 miles), proceeded from thence to the village Schadoffka, which the Allies burnt. A good many farms, all deserted, and a great quantity of hay were also destroyed.

On our return yesterday about 250 of the enemy's

cavalry menaced our rear.

The troops are very healthy.

At a conference held to-day, it has been determined that the Fort of Kinburn is to be occupied for the winter by French troops, and it is expected that the English troops will embark for the Crimea on the 1st of November.

SIR, October 25, 1855.

I HAVE the honour to report that the Allied Troops stationed here, under the command of General of Division D'Allonville, marched from

Eupatoria on Monday morning the 22d instant.

The force advanced in two columns, the details of which are in the margin,\* the one taking a northerly direction, and skirting towards the east of the Lake Susik Guiloie, until it arrived at the siller of Karanta the state of the same and the siller of the same and the siller of the same and the siller of the same and the the village of Karagurt; the other proceeding by the strip of land between that lake and the sea, to the town of Sak.

The Light Cavalry Brigade and troop of Horse Artillery, under my command, formed part of the first-mentioned column, which was commanded by General D'Allonville himself.

We marched at daybreak, and arrived at Karagurt (18 miles) about 4 P.M., when we bivouacked for the night, and which, before leaving, we destroyed.

When we had advanced within about three miles of this village we came in presence of a force of about twenty squadrons of Russian cavalry, who retired before us after some shots from the French Horse Artillery, which told with some effect.

On the evening of the 23d we proceeded, at daybreak, in a southerly direction, passing close to the village of Temesh, where we came in sight of a body of Russian cavalry, considerably superior in numbers to that we had seen the evening before, a strong force of guns, and, I believe, some battalions of infantry.

This body also retired before us, at a considerable distance, while we continued our advance to the village of Tuzla, on a rising ground to the left of which village General D'Allonville took up a position and offered battle, Captain Thomas's troop of Horse Artillery firing several rounds with precision, which were answered by the enemy without effect.

After waiting here for two hours, and seeing that the enemy were effecting a further retreat, General D'Allonville formed a junction with the column under Mushir Achmet Pasha, at the town of Sak, where we bivouacked, destroying the town and considerable Russian cantonments.

On the 24th instant, yesterday, we returned to Eupatoria by the sea coast road.

On the first day's march the French cavalry were in front, the English cavalry in support; the Turkish cavalry on our left flank. On the second day, the cavalry under my command were in advance, supported by the French cavalry, the Turkish cavalry on our left flank.

I have great satisfaction in stating that General D'Allonville expressed to me his approval of the

manner in which the cavalry I have the honour to command manœuvred in the field, as likewise of the good practice of our Horse Artillery; and I may perhaps be permitted to express my acknowledgments of the courtesy evinced towards me, and the troops under my command, by the General during the time we were in the field, and since we landed at Eupatoria.

I beg to enclose a Return of Casualties,\* caused by exhaustion from the want of water, of which

there was a very great scarcity everywhere.

Captain Hamilton, Royal Navy, has requested me to inform you that the French brig of war Allouette, and Her Majesty's ship Diamond, cooperated with the troops on this occasion; but that he, finding a sailing vessel unhandy on this service, placed the guns and men of the Diamond on board the steam transport Oneida, from which he fired on the flanks, and on some advanced picquets of the enemy. THE Earl of Clarendon has received a Despatch from Major-General Williams, Her Majesty's Commissioner with the Turkish Army in Asia, of which the following is a Copy:-

Kars, October 3, 1855.

MY LORD,

I HAD the honour to announce to your Lordship, on the evening of the 29th ultimo, the glorious victory gained on the morning of that day by the Sultan's troops on the heights above Kars, over the Russian Army commanded by General Muravieff, and I now beg to furnish your Lordship with the principal incidents of that sanguinary battle.

Your Lordship will perhaps recollect that in my Despatch, No. 123, of the 28th of June, I stated that the Russian General, after his second demonstration against the southern face of our intrenchments, which is flanked by Hafiz Pasha Tabia and Kanli Tabia, marched south, and established his camp at Bugah Tikmé, a village situated about four miles from Kars. Knowing that General Muravieff served in the army which took Kars in 1828, I conceived his last manœuvre to be preparatory either to a reconnaissance or an attack upon the heights of Talmasb, from whence the Russians successfully pushed their approaches in

the year above cited.

Whilst, therefore, the enemy's columns were in march towards Bugah Tikmé, I visited those heights with Lieutenant-Colonel Lake, and after studying the ground decided upon the nature of the works to be thrown up; these were planned and executed by Lieutenant-Colonel Lake with great skill and energy. I enclose for your Lordship's information a plan made by that officer of the town and its neighbouring heights, which are situated on the opposite side of the river of Kars Chai, over which three temporary bridges had been thrown to keep up our communications. As all verbal descriptions, or bird's-eye views of ground, convey but an imperfect idea of any locality, I beg to enclose a sketch made by Mr Churchill, which will, I trust, tend to elucidate my description.

Your Lordship will observe that whilst our camp and magazines in the town were rendered as safe as circumstances would allow, the hills above Kars commanded all, and were therefore the keys of our position.

The intrenchments of Tahmasb, being those nearest the enemy's camp, demanded the greatest vigilance from all entrusted in their defence; General Kmety, a gallant Hungarian officer, commanded the Division which occupied this emi-nence, he was assisted by Major-General Hussein Pacha and his aide-de-camp Major Teesdale who has acted as his Chief of the Staff.

Throughout the investment, which has now lasted four months, the troops in all the redoubts and intrenchments have kept a vigilant look-out during the night, and at their appointed stations, stood to their arms long before day dawn. In my Despatch, No. 155, of the 29th ultimo, I informed your Lordship of the arrival of the news of the fall of Sebastopol, and of the landing of Omar Pacha at Batoom. I also acquainted your Lordship with the fact that the Russian General was engaged in sending off immense trains of heavy baggage into Georgia, and showing every indication of a speedy retreat; this in nowise threw us off our guard, and Lieutenant-Colonel Lake was directed to strengthen many points in our extensive and undermanned lines. and amongst other works, the Tabia bearing my name was constructed.

At four o'clock on the eventful morning of the 29th the enemy's columns were reported to be advancing on the Tahmasb front. They were They were three in number, supported by 24 guns; the first or right column being directed on Tahmasb Tabia, the second on Yukseh Tabia, and the third on the breastwork called Rennison Lines. As soon as the first gun announced the approach of the enemy the reserves were put under arms in a central position, from which succours could be despatched either to Tahmasb or the English lines.

The mist and imperfect light of the dawning day induced the enemy to believe that he was about to surprise us; he advanced with his usual steadiness and intrepidity; but on getting within range he was saluted with a crushing fire of artillery from all points of the line. This unexpected reception, however, only drew forth loud burrahs from the Russian infantry as it rushed up the hill on the redoubts and breastworks. works poured forth a fire of musketry and rifles, which told with fearful effect on the close columns of attack, more especially on the left one, which, being opposed by a battalion of 450 Chassenrs, armed with Minié rifles, was, after long and desperate fighting, completely broken, and sent headlong down the hill, leaving 850 dead on the field, besides those carried off by their comrades.

The central column precipitated itself on the redoubts of Tahmasb and Yuksek Tabias, where desperate fighting occurred and lasted for several hours, the enemy being repulsed in all his attempts to enter the closed redoubts, which mutually flanked each other with their artillery and musketry, and made terrible havoc in the ranks of the assailants; and it was here that Generals Kmety and Hussein Pacha, together with Major Teesdale, so conspicuously displayed their courage Lieutenant-General Kereen Pasha and conduct. also repaired to the scene of desperate strife to encourage the troops, and was wounded in the shoulder, and had two horses killed under him.

The right column of the Russian infantry, supported by a battery, eventually turned the left flank of the intrenched wing of the Tahmasb defences, and whilst the Russian battery opened in the rear of the closed redoubt at its salient angle, their infantry penetrated considerably behind

our position.

Observing the commencement of this movement, and anticipating its consequences, Lieutenant-Colonel Lake, who had taken the direction of affairs in the English Tabias, was instructed to send a battalion from Fort Lake to the assistance of the defenders of Tahmash, and at the sametime two battalions of the reserves were moved across the flying bridge and upon the rocky height of Laz Jeppé Tabia. These three reinforcing columns met each other at that point, and being hidden from the enemy by the rocky nature of the ground, confronted him at a most opportune moment; they deployed, opened their fire, which stopped and soon drove back the enemy's reserves, which were then vigorously charged with the bayonet, at the same moment when General Kmety and Major Teesdale issued from the redoubts at Tahmasb and charged the assailants. The whole of that portion of the enemy's infantry and artillery now broke and fied down the heights under a murderous fire of musketry; this occurred at half-past eleven, after a combat of seven hours.

In this part of the field the enemy had, including his reserves, 22 battalions of infantry, a large force of dragoons and cossacks, together with 32 guns.

Whilst this struggle, which I have attempted to describe, was occurring at Tahmash, a most severe combat was going on at the eastern position of the line, called the English Tabias.

About half-past five o'clock A.M., a Russian column, consisting of 8 battalions of infantry, 3 regiments of cavalry, and 16 guns, advanced from the valley of Tehakmak, and assaulted those small redoubts, which, after as stout a resistance as their unavoidably feeble garrisons could oppose, fell into their hands, together with the connecting breastworks, defended by townsmen and mountaineers from Lazistan, whose clannish flags, according to their custom, were planted before them on the epaulments, and consequently fell into the enemy's hands; but ere the firing had begun in this portion of the field, Captain Thompson had received orders to send a battalion of infantry from each of the heights of Karadagh and Arap Tabia to reinforce the English lines. This reinforcement descended the deep gully through which flows the Kars River, passed a bridge recently thrown across it, and ascended the opposite precipitous bank by a zigzag path which led into the line of works named by the Turks, Ingliz Tabias (the English Batteries). Their arrival was as opportune as that of the reserves directed towards Tahmash, which I have had the honour to describe in the former part of this Despatch. These battalions, joined to those directed by Lieutenant-Colonel Lake, gallantly attacked and drove the Russians out of the redoubts at the point of the bayonet, after the artillery of the enemy had been driven from those lines by the cross-fire directed from Fort Lake and from Arab Tabia and Karadagh, by Captain Thompson. This officer deserves my best thanks for baving seized a favourable moment to remove a heavy gun from the eastern to the western extremity of Karadagh, and with it inflicted severe loss on the enemy.

After the Russian infantry was driven from the English redoubts, the whole of their attacking force of cavalry, artillery, and infantry, retreated with precipitation, plied with round shot from all the batteries bearing on their columns. amongst our horses from famine prevented our withdrawing from their advanced positions. He also carried off his wounded, and many of his dead; yet he left 363 of the latter within and in front of these intrenchments; and his retreat occurred at least an hour before the assailants of Tahmasb were put to flight.

During this combat, which lasted nearly seven hours, the Turkish infantry, as well as artillery, fought with the most determined courage; and when it is recollected that they had worked on their intrenchments, and guarded them by night throughout a period extending to nearly four months, I think your Lordship will admit that they have proved themselves worthy of the admiration of Europe, and established an undoubted claim to be placed amongst the most distinguished of its troops.

With regard to the enemy, as long as there was a chance of success he persevered with undaunted courage, and the Russian officers displayed the greatest gallantry. Their loss was immense; they left on the field more than 5,000 dead, which it took the Turkish infantry four days to bury. Their wounded and prisoners in our possession amount to 160, whilst those who were carried off are said to be upwards of 7,000.

As the garrison was afflicted with cholera, and I was apprehensive of a great increase of the malady should this melancholy duty of the burial of the dead be not pushed forward with every possible vigour by our fatigued and jaded soldiers, I daily visited the scene of strife to encourage them in their almost endless task; and I can assure your Lordship that the whole battle-field presented a scene which is more easy to conceive than to describe, being literally covered with the enemy's dead and dying.

The Turkish dead and wounded were removed on the night of the battle. The dead numbered 362, the wounded 631. The town's people, who also

fought with spirit, lost 101 men.

His Excellency the Mushir has reported to his Government those officers who particularly distinguished themselves—a difficult task in an army which has shown such desperate valour throughout the unusual period of seven hours of uninterrupted combat.

And His Majesty the King of Prussia, His Privy Councillor and Chamberlain, Albert Count of Bernstorff, Envoy Extraordinary and Minister Plenipotentiary to Her Britannic Majesty, Knight Grand Cross of the Order of the Red Eagle, and of the Orders for Civil Merit of the Bavarian Crown, of St Januarius of the Two Sicilies, and of St Stanislaus of Russia, Knight Commander of the Order of Christ of Portugal;

Who, after having communicated to each other their respective full powers, found in good and due form, have agreed upon and concluded the following Articles:-

#### ARTICLE I.

It is agreed that all books, prints, and drawings published within the dominions of any other State that has concluded or may conclude, or which has acceded or may accede to a Copyright Convention with Great Britain, shall, if exported from Prussia, Saxony, Saxe-Weimar, Saxe-Meiningen, Saxe-Altenburg, Saxe Coburg-Gotha, Brunswick, Anhalt-Dessau-Cöthen, Anhalt-Bernburg, Schwarzburg-Rudolstadt, Schwarzburg-Sondershausen, or Reuss, be considered, for the purposes of this Convention, to have been exported from the country of their publication.

#### ARTICLE II.

The protection granted by the Convention which was concluded between the High Contracting Parties on the 13th of May 1846, to original works, is extended to translations; it being, however, clearly understood that the intention of the present Article is simply to protect a translator in respect of his own translation, and that it is not intended to confer upon the first translator of any work the exclusive right of translating that work, except in the case and to the extent provided for in the following Article.

#### ARTICLE III.

The author of any work published in either of the two countries, who may choose to reserve the right of translating it, shall, until the expiration of five years from the date of the first publication of the translation thereof authorised by him, be, in to articles of political discussion.

the following cases, entitled to protection from the publication in the other country of any translation of such work not so authorised by him:

§ 1. If the original work shall have been registered and deposited in the one country within three months after its first publication in the other.

§ 2. If the author has notified on the title-page of his work his intention to reserve the right of

translating it.

§ 3. Provided always, that at least a part of the authorised translation shall have appeared within a year after the registration and deposit of the original, and that the whole shall have been published within three years after the date of such

§ 4. And provided that the publication of the translation shall take place within one of the two countries, and that it shall be registered and de-posited in conformity with the stipulations of Article II of the Convention of the 13th of May

With regard to works which are published in parts, it shall be sufficient if the declaration of the author that he reserves the right of translation shall appear in the first part. But with reference to the period of five years limited by this Article for the exercise of the exclusive right of translation, each part shall be treated as a separate work, and each part shall be registered and deposited in the one country within three months after its first publication in the other.

#### ARTICLE IV.

The stipulations of the preceding Articles shall also be applicable to the representation of dramatic works, and to the performance of musical compositions, in so far as the laws of each of the two countries are or shall be applicable in this respect to dramatic and musical works first publicly represented or performed therein.

In order, however, to entitle the author to legal protection in regard to the translation of a dramatic work, such translation must appear within three months after the registration and deposit of the

original.

It is understood that the protection stipulated by the present Article is not intended to prohibit fair imitations, or adaptations of dramatic works to the stage in England and Prussia respectively, but is only meant to prevent piratical translations.

The question whether a work is an imitation or a piracy, shall in all cases be decided by the Courts of Justice of the respective countries, according to

the laws in force in each.

#### ARTICLE V.

Notwithstanding the stipulations of Article I of the Convention of the 13th of May 1846, and of Article II of the present additional Convention, Articles extracted from newspapers or periodicals published in either of the two countries, may be republished or translated in the newspapers or periodicals of the other country, provided the source from whence such articles are taken be acknowledged.

Nevertheless, this permission shall not be construed to authorize the republication or translation in one of the two countries, of articles from newspapers or periodicals published in the other country, the authors of which shall have notified in a conspicuous manner in the journal or periodical in which such articles have appeared, that they

forbid the republication thereof.

This last stipulation shall not, however, apply

#### ARTICLE VI.

This present Additional Convention shall come into operation as soon as possible after the exchange of the ratifications thereof. Due notice shall be given beforehand in each country by the Government of that country, of the day which may be fixed upon for its so coming into operation, and its stipulations shall apply only to works published after that day.

#### ARTICLE VII.

The present Additional Convention shall have the same duration as the Convention of the 13th of May 1846. It shall be ratified, and the ratifications shall be exchanged at London as soon as may be within two months from the date of signature.

In witness whereof the respective Plenipotentiaries have signed the present Convention, and have affixed thereto the seal of their arms.

WHEREAS a Convention, bearing date the thirteenth of May one thousand eight hundred and forty-six, was concluded between Her Majesty and His Majesty the King of Prussia, whereby due protection was secured within the Prussian dominions for the authors of books, dramatic works, or musical compositions, and the inventors, designers, or engravers of prints and articles of sculpture, and the authors, inventors, designers, or engravers of any other works whatsoever of literature and the fine arts, first published in the dominions of Her Majesty, or of His said Majesty respectively, in which the laws of Great Britain and of Prussia did then or might thereafter give their respective subjects the privilege of copyright; and by the said Convention lawful representatives or assigns of such authors, inventors, designers, or engravers, with regard to any such works first published within the dominions of Her Majesty, were to be treated on the same footing as the authors, inventors, designers, or engravers themselves.

And whereas an Order of Her Majesty in Council, dated the twenty-seventh day of August one thousand eight hundred and forty-six, was, by virtue of the authority committed to Her by an Act passed in the session of Parliament holden in the seventh and eighth years of Her reign, intituled "An Act to amend the law relating to "International Copyright," made, by and with the advice and consent of Her Privy Council, for giving effect to the said Convention.

And whereas His Majesty the King of Saxony, His Royal Highness the Grand Duke of Saxe-Weimar, their Royal Highnesses the Dukes of Saxe-Meiningen, Saxe-Altenburg, and Saxe-Co-burg-Gotha, His Royal Highness the Duke of Brunswick, their Royal Highnesses the Dukes of Anhalt-Dessau and Anhalt-Bernburg, and their Serene Highnesses the Princes of Schwarzburg-Schwarzburg-Sondershausen, Rudolstadt and Reuss-Greitz, Reuss-Lobenstein-Ebers-Dorf, and

Reuss-Schleitz, subsequently acceded to the said Convention, and thereby became parties thereto.

And whereas Orders of Her Majesty in Council, dated respectively the twenty-sixth day of September one thousand eight hundred and forty-six, the twenty-fourth day of April one thousand eight hundred and forty-seven, the tenth day of August one thousand eight hundred and forty-seven, and the eleventh day of March one thousand eight hundred and fifty-three, were, by virtue of the authority aforesaid, and by and with the advice and consent aforesaid, made for giving effect to such accessions.

Now therefore Her Majesty, by and with the advice and consent of Her Privy Council, and by virtue of the authority committed to Her by an Act passed in the Session of Parliament holden in the fifteenth and sixteenth years of Her Majesty's reign, intituled "An Act to enable Her Majesty "to carry into effect a Convention with France "on the subject of copyright, to explain and ex-tend the International Copyright Acts, and to "explain the Acts relating to copyright in engrav-ings," doth order, and it is hereby ordered, that the authors of any books published, or of any dramatic pieces first publicly represented within the dominions of Prussia, Saxony, Saxe-Weimar, Saxe-Meiningen, Saxe-Altenburg, Saxe-Coburg-Gotha, Brunswick, Anhalt-Dessau-Cöthen, Anhalt-Bernburg, Schwarzburg-Rudolstadt, Schwarzburg-Sondershausen, or Reuss, at any time after the day next after the day of the publication hereof in the London Gazette, who may choose to reserve the right of translating such books or dramatic pieces, their executors, administrators, and assigns, shall, until the expiration of five years from the date of the first publication of the translations authorized by them respectively, of such books, or from the time at which the translations authorized by them of such dramatic pieces are first published or publicly represented, be, subject to the provisions mentioned in the said last mentioned Act, empowered to prevent the publication in the British dominions of any translation of such books or dramatic pieces, and the representation therein of any translation of such dramatic pieces not so respectively authorized by them.

And the Right Honourable the Lords Commissioners of Her Majesty's Treasury are to give the necessary directions herein accordingly.

expedient.

And, with reference to such proposed powers, it is intended to enact, that the said Bonds may be transferred, and that they may be renewed, and that they and transferences thereof shall be registered; and also that it shall be lawful for the Lord Provost, Magistrates, and Council, to redeem the same; and provision will also be made for furthering such redemption.
