NOTICE is Hereby Given, that pending the N ratification of the Treaty of Peace, an armistice by sea, as well as by land, has been agreed upon between Great Britain and Her Allies on the one part, and Russia on the other; and that consequently orders have been given for immediately raising the Blockade of Russian ports.

At the Court of Buckingham Palace, the 9th day of April 1856, PRESENT,

The QUEEN's Most Excellent Majesty in Council. Whereas a Treaty of Peace and Friendship has be signed between Her Majesty and the Emperor of all the and Her A Russias, it is t. day ordered by Her Majesty, by and with the acvice of Her Privy Council, that the Order made by Her Majesty in Council, bearing date the twenty-ninth day of March one thousand eight hundred and fifty-four, by which it is directed (that no chiral or records belonging is directed "that no ships or vessels belonging "to any of Her Majesty's subjects be permitted to "enter and clear out for any of the ports of Russia "until further order; and that a general embargo or stop be made of all Russian ships and vessels "whatsoever, now within, or which shall hereafter "come into any of the ports, harbours, or roads "within any of Her Majesty's dominions, together with all persons and effects on board the said ships or vessels;" and such parts of any other Orders in Council as prohibit trade with Russia, be henceforth revoked and discharged.

And the Right Honourable the Lords Commissioners of Her Majesty's Treasury, the Commissioners for executing the office of Lord High Admiral of Great Britain, and the Lord Warden of the Cinque Ports, are to give the necessary directions herein as to them may respectively appertain.
