PRESENT,

The QUEEN'S Most Excellent Majesty in Council.

WHEREAS by the "Burial Grounds (Scot-land) Act, 1855," it is enacted that it shall be lawful for Her Majesty, from time to time, by Order in Council, upon a Representation of one of Her Principal Secretaries of State, that a copy of an Interlocutor of a Sheriff of a County in Scot-land, under certain provisions of the said Act, has been received by him, in pursuance thereof to order that no new Burial Ground shall be opened within certain limits specified in such Order, save with the previous approval of one of such Secretaries of State, or (as the case may re-quire,) that, after a time mentioned in the Order, Burials within certain limits, or in certain Burial Grounds or Places of Burial, shall be Discontinued wholly, or subject to any exceptions or qualifica-tions mentioned in such Order; and such Order in Council shall thereupon have like force and effect as if the same were embodied in the said Act: Provided always, that notice of such Representa-tion, and of the time it shall please Her Majesty to Order the same to be taken into consideration by the Privy Council, shall be transmitted to the Crown Agent in Edinburgh, and the Sheriff-Clerk of the County in which such Burial Ground is situated, and the same shall be by them respectively pub-lished in the Edinburgh Gazette, and fixed on the doors of the Church of, or on some other conspicu-ous places within, the Parishes affected by such Representation, one month before such Representation is so considered ;

And Whereas the Right Honorable Sir George Grey, Bart., one of Her Majesty's Principal Secretaries of State, has made a Representation to Her Majesty in Council that he had received a copy of an Interlocutor pronounced by the Sheriff of the Sheriffdom of Dumbarton and Bute, setting forth certain proceedings had under the provisions of the said Act, and finding the allegations of a Petition presented to him by James Blair Risk, Merchant in Dumbarton, and fourteen other persons, (being all persons assessed for Relief of the Poor within the Parish of Dumbarton,) that the BURIAL GROUND of the Burgh and Parish of DUMBARTON was dan-gerous to health, and offensive or contrary to deconcy, to be proved ; and the said Representation recommended that no new Burial Ground should be opened within the said Burgh and Parish without the previous approval of one of Her Majesty's Principal Secretaries of State, and that Burials should be DISCONTINUED in the aforesaid Burial Ground :

And Whereas Notice of the said Representation, and of the time when it pleased Her Majesty to order the same to be taken into consideration by Her Privy Council, has been duly published in the Edinburgh Gazette, and has been fixed as required by the said Act ;-

Now therefore Her Majesty, by and with the advice of Her Privy Council, is pleased to Order, and it is hereby ordered, that no new Burial Ground shall be opened in the Burgh and Parish of DUM-BARTON without the previous approval of one of Her Majesty's Principal Secretaries of State; and that, from and after the 1st day of January 1857, Burials in the Burial Ground of the said Burgh and Parish shall be wholly DISCONTINUED : Provided, nevertheless, that this Order shall not affect a small piece of non-parochial ground situate on the east side of the above-mentioned Burial Ground, but separated therefrom by a high wall, and which ground was purchased in the year 1847 by Robert Napier, Engineer, of Glasgow, and Humphrey Walter Campbell, late Sheriff-Substitute of Dumbartonshire.

The Right Honourable the Lords of the Com-mittee of Privy Council for Trade and Plantations have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Acting Consul-General at Buenos Ayres, enclosing a copy of a translation of a Decree of the Buenos Ayrean Government, (an extract from which is subjoined,) respecting the new Pilotage Regulations.

(Copy.)

Extract from Decree issued by Buenos Ayrean Government, dated July 30, 1856.

ART. 1.-The profession of branch pilot is declared free, in accordance with the constitution in all the ports, roads, coasts, and rivers of the State, said profession being open to companies as well as single pilots, without power of interference on the part of the Government in their scale of pilotage, with the only obligation of publishing said scale by officially communicating the same at the office of the Captain of the Port.

ART. 2.-To be a branch pilot the same conditions are requsite as those of a port pilot, under regulation of Art. 7, of Decree January 22, 1854.

The diploma of pilot shall be granted from the Marine Department.

ART. 3.-No vessel shall be obliged to take a pilot on entering or leaving the port, thereby being exempt from the payment of the half pilotage recoverable in accordance with the Decree dated 8th July 1830, the captain being now at liberty to take or refuse a pilot on board.

Whenever any number of licenses ART. 4.pilots should desire to form a Company, they must notify the same at the Captain of the Port's Office with a statement of the rules and scale of charges to be put in force.

ART 5.—Branch pilots in their profession are subject to the maritime laws and regulations of subject to the maritime laws and regulations of the State, and in case of action at law will be judged by commercial, private, marine, and general naval code.

ART 6.—Let this be published and communicated and given to the Official Register.
