The Right Honourable the Lords of the Committee of Privy Council for Trade and Plantations have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Consul-General at Tunis, reporting that the Bey of Tunis has abandoned the Government monopoly of the Oil Presses in that country, and that the export duty upon oil has been fixed at 10 per cent.; the amount of duty chargeable in the case of the oil being exported by Foreigners to be deposited with the Consul of their Nation.

> DECREE No. 1.—The admission of bar-iron, under the provisions of the Decree of the 17th October 1855, is restricted to bars of the following dimensions :—

> Flat bars, of the width multiplied by the thickness, of 458 milimètres, or more.

Square bars, measuring 22 milimètres or more on each face.

Round bars, measuring more than 15 milimètres or more in diameter.

Flattened iron, of irregular shape, and similar to the above, will enjoy the same freedom from duty.

With the following exceptions, the undermentioned articles will not be admitted in discharge of the Custom's Warrants :---

Articles manufactured from iron bars of irregular form, except those of similarly irregular shape to the bars from which they are manufactured.

Articles manufactured from round bar iron, except those which are obviously manufactured from round bar iron.

Wrought iron, except such is of more than two milimètres in thickness, or articles of wrought iron not exceeding that thickness.

The provisions of the Decree are extended only to shipbuilders, or manufacturers of articles required for the fitting out or rigging ships.

The period fixed by Article 2, of the Decree of the 17th October 1855, for permitting the nationalization of Foreign sea-going vessels, whether sailing or steam, on payment of 10 per cent. on the value, is prolonged until the 17th October 1858.

DECREE No. •2.—The undermentioned articles will be admitted, under the following conditions, free of import duty, conformably with Article 5 of the Law of the 5th July 1836, if imported for masters of forges, builders, or manufacturers, who can certify to Foreign orders :

Rough cast iron, bar iron, wrought iron, gutters and T pieces (cornières), steel in bars, and copper laminated, pure or with alloy, imported from abroad, to be re-exported after having been applied in French manufactories, &c., to the construction of iron ships or boats, or machines or apparatus, whether for railways or for other works.

The above named metals must be imported either under the French flag, or under that of the country of production.

The regulations respecting the importations of iron bars, &c., under the provisions of this Decree, are similar to those contained in Decree No. 1, having reference to the same Articles.

Importers must give real security either to reexport or to return to the depôt, within a period not exceeding six months, the articles manufactured from metals admitted under the present Decree, no deduction for difference of weight being allowed.

In none of the above cases will metals be permitted to be imported, or the articles manufactured from them to be exported, otherwise than through the established entrepôts, or through the Custom-Houses, whether those of transit or those opened for merchandise rated at more than 20 francs the 100 kilogrammes. Manufactured articles, which, instead of being placed in depôt are at once exported, should be forwarded either under the general transit regulations, or under Articles 61 and 62 of the Law of the 21st April 1818, accordingly as they may be despatched by land or by sea.
