Her Majesty's Most Gracious Speech to both Houses of Parliament, on Thursday, December 3, 1857.

#### My Lords and Gentlemen,

Circumstances have recently arisen connected with the Commercial Interests of the Country, which have induced Me to call Parliament together before the usual time.

The failure of certain Joint-stock Banks and of some Commercial Firms produced such an extent of distrust as led Me to authorise My Ministers to recommend to the Directors of the Bank of England the adoption of a course of proceeding which appeared necessary for allaying t prevalent alarm. As that course has involved a parture from the existing law, a bill for indem fying those who advised, and those who adopted it, will be submitted for your consideration.

I have observed with great regret that the disturbed state of commercial transactions in general has occasioned a diminution of employment in the manufacturing districts, which, I fear, cannot fail to be attended with much local distress. I trust, however, that this evil may not be of long duration; and the abundant harvest with which it has graciously pleased Divine Providence to bless this land will, I hope, in some degree mitigate the sufferings which this state of things must unavoidably produce.

While I deeply deplore the severe suffering to which many of My subjects in India have been exposed, and while I grieve for the extensive bereavements and sorrow which it has caused, I have derived the greatest satisfaction from the distinguished successes which have attended the heroic exertions of the comparatively small forces which have been opposed to greatly superior numbers, without the aid of the powerful reinforcements despatched from this Country to their assistance.

The arrival of those reinforcements will, I trust, speedily complete the suppression of this widely spread revolt.

The gallantry of the troops employed against the mutineers, their courage in action, their endurance under privation, fatigue, and the effects of climate, the high spirit and self-devotion of the officers, the ability, skill, and persevering energy of the commanders, have excited My warmest admiration; and I have observed with equal gratification that many civilians, placed in extreme difficulty and danger, have displayed the highest qualities,

including, in some instances, those that would do honour to veteran soldiers.

It is satisfactory to know that the general mass of the population of India had taken no part in the rebellion, whilst the most considerable of the Native Princes have acted in the most friendly manner, and have rendered important services.

I have given directions that papers relating to these matters shall be laid before you.

The affairs of My East Indian dominions will require your serious consideration, and I recommend them to your earnest attention.

The Nations of Europe are in the enjoyment of the blessings of peace, which nothing seems likely to disturb.

The stipulations of the Treaty which I concluded with the Shah of Persia have been faithfully carried into execution, and the Persian forces have evacuated the territory of Herat.

#### Gentlemen of the House of Commons,

I have given directions that the Estimates for the next year shall be prepared, for the purpose of being laid before you. They will be framed with a careful regard to the exigencies of the Public Service.

#### My Lords and Gentlemen,

Your attention will be called to the laws which regulate the Representation of the People in Parliament, with a view to consider what amendments may be safely and beneficially made therein.

Measures will be submitted for your consideration for simplifying and amending the laws relating to Real Property; and also for consolidating and amending several important branches of the Criminal Law.

I confidently commit to your wisdom the great interests of My Empire; and I fervently pray that the blessings of Almighty God may attend your counsels, and may guide your deliberations to those ends which are dearest to My heart,—the happiness and prosperity of My loyal and faithful people.

WHEREAS by an Act of Parliament passed in the 54th year of the reign of His late Majesty King George the Third, chapter 159, intituled "An Act for the better regulation of the several ports, harbours, roadsteads, sounds, channels, bays, and navigable rivers in the United Kingdom, and of His Majesty's docks, dockyards, arsenals, wharfs, moorings, and stores therein, and for repealing several Acts passed for that purpose," it is enacted (among other things) that no person or persons shall take any ballast or shingle from the shores or banks,

or any portion of the shores or banks, of any port, harbour, or haven of this Kingdom, from which the Commissioners for executing the office of Lord High Admiral of the United Kingdom for the time being shall find it necessary for the protection of such port, harbour, or haven, or the works thereof, by order, under their hands, or the hand of their Secretary, and published in the London Gazette, shall prohibit the taking or removing of such shingle or ballast upon pain of forfeiting for every such offence the sum of ten pounds.

And whereas we, as Commissioners for executing the Office of Lord High Admiral of the United Kingdom, have found it necessary for the protection of the harbour and port of Exeter, in the county of Devon, to prohibit the taking or removing of any ballast or shingle from the shores or banks at the back of a place called the Warren Sand, on the south side of the channel of the River Exe, between two posts erected about 900 feet apart, and from the shores or banks on the north side of the channel of the River Exe, between two posts erected about 5100 feet apart. And we do therefore hereby order that no person or persons shall take or remove any ballast or shingle from such shores or banks, or any portion of such shores or banks aforesaid.

(No. 44.) SCOTLAND-NORTH-WEST COAST.

THE Commissioners of Northern Lighthouses have given notice, that on and after the 10th day of November 1857, lights would be exhibited from lighthouses recently erected as follows :--

#### Fixed Red Light at Ru Ushenish, South Uist.

Ru Ushenish light-tower stands on the easternmost headland on the east side of the Island of South Uist, in the Hebrides, and would exhibit a dioptric or refracting *fixed red* light of the first order, at an elevation of 176 feet above high water, which should be visible from the deck of a vessel in clear weather at a distance of 18 miles. The tower is 39 feet high from the base to the top of the lantern, and coloured white.

#### Flashing Light at South Rona.

South Rona lighthouse is a tower of masonry  $41\frac{3}{4}$  feet high and painted white, erected on a peak at the north-east point of the Island of South Rona, between the west coast of Ross-shire and the Isle of Skye.

The light is a catadioptric or reflecting holophotal white light of the second order, emitting a flash every 12 seconds, at an elevation of 222 feet above high water, and which may be seen in clear weather at a distance of about twenty miles.

#### Fixed Light at Kyle Akin, Loch Alsh.

A lighthouse has been erected on a point of rock covered at high-water spring tides, projecting from the western extremity of Gillean Island or Eilean Dool, at the western entrance of the narrows leading to Loch Alsh.

The light is an azimuthal condensing fixed light, appearing white in the fairway of the Inner Sound or Sound of Applecross to the southward as far as Paba Island, and also in the fairway of Loch Alsh.

From Paba Island to the south-ward, and eastward along the shore of Skye to the south of the fairway of Loch Alsh, and to the north eastward of the fairway of the Inner Sound, it appears as a *red* light.

To the northward of the fairway of Loch Alsh the light is not to be seen.

The light is at an elevation of 53 feet above high water, and visible in clear weather 10 miles distant.

The light-tower stands at about 53 yards seaward of high-water mark, spring tides, and is connected with Gillean Island by a bridge of five spans. It is built of masonry,  $69\frac{1}{2}$  feet in height, and coloured white.

#### Fixed Light at Isle Ornsay, Sleat Sound.

Ornsay light-tower stands on a low point at the south-eastern extremity of the Island of Ornsay, in Sleat Sound or Sound of Skye, and from it would be exhibited an azimuthal condensing light, white, fixed, 58 feet above the sea at high water, and visible in clear weather at a distance of 12 miles. The tower is of masonry, 63 feet in height, and coloured white.

#### Fixed light in the Sound of Mull.

A lighthouse has been erected on a small rock at Ru na Gall, on the south shore of the Sound of Mull, Argyllshire, and about a mile to the northward of Tobermory.

The light is an azimuthal condensing *fixed* light, appearing *red* to the northward out to sea; *green* towards the New rocks, Red rocks, and Stirk rocks; and *white* to the southward in the Sound of Mull. It is at an elevation of about 55 feet above high water, and should be seen from the deck of a small vessel in clear weather at a distance of about 12 miles.

The light-tower is 63 feet high, built of masonry, and painted white. It stands at about 50 yards seaward of high-water mark, and is connected with the shore by a bridge of two spans.

Fixed Light at Block Island, Rhode Island.

The United States' Lighthouse Board has given notice that on and after the 28th day of October 1857, a single light would be exhibited from the lighthouse recently built on the extreme north point of Block Island, at the entrance to Long Island Sound, Rhode Island, to replace the two lights which were shown at one-third of a mile to the southward of this position, when the temporary light exhibited during the erection of the new building would be discontinued.

The light is a *white fixed* light, at an elevation of 60 feet above the sea at bigh water; it illuminates an arc of the horizon from E.S.E. round northerly to S.W. by S., being intercepted by the island for the remaining points of the compass, and it should be visible from the deck of a vessel in ordinary weather at a distance of 13 miles.

The illuminating apparatus is a Fresnel lens of the fourth order.

The light tower is 14 feet square, with its base 10 feet above high water, and has a keeper's house of two stories attached. The whole building is of brick, and coloured white.

(No. 47.) MEDITERRANEAN.—COAST OF TUSCANY. Lights on the Breakwater at Leghorn.

The Grand Ducal Government of Tuscany has given notice that on and after the 1st day of December 1857, the following lights will be exhibited from the breakwater and jetty now in course of construction at the port of Livorno or Leghorn.

1. A fixed *red* light will be shown at the southern head of the curved breakwater, at 43 yards to the northward of the outer blocks of stone which appear above water. It will bear from the present Faro or light tower of the port W. 7° N. or W.  $\frac{2}{3}$  N. distant 440 yards.

A fixed green light will be shown at the north end of the same curved breakwater, which will bear from the existing mole head of the port N. 53° ½ W. or N. W. ⅔ W. distant 480 yards.
 A fixed white light will be shown from the south-west extremity of the straight jetty which

3. A fixed *white* light will be shown from the south-west extremity of the straight jetty which is now in course of erection on the north side of the port of Leghorn ; it will be moved outwards as the works advance.

All the above lights will be lighted from sunset to sunrise, except when the state of the sea will not admit of access to the heads of the unfinished jetties. In this special case a single fixed white light will be exibited from the head of the present Mole, which, with the existing Faro, will indicate the points which serve as a base to determine the position of the ends of the above-mentioned curved breakwater.

The illuminating apparatus of the four lights will be dioptric or by lenses, but the order or

strength of the lights, and their heights respectively above the level of the sea, are not yet determined upon.

#### (No. 48.) SHETLAND ISLES.-NORTH UNST.

#### Fixed White Light on Muckle Flugga.

The Commissioners of Northern Lighthouses have given notice that on and after the 1st day of January 1858, a permanent light will be established in the light tower recently erected on the holm or islet, called Muckle Flugga, at the northend of the Island of Unst, forming the northwestern extremity of the Shetland Isles.

The light will be a *fixed* white light placed at an elevation of about 230 feet above the mean level of the sea, and should be visible from the deck of a ship in ordinary weather at a distance of 21 miles all round the horizon, excepting for an arc of 31 degrees, between S.S.E.  $\frac{1}{2}$  E. and S.E. by E.  $\frac{1}{4}$  E., within which arc the light will be *red*. South-eastward of the Scaw the red light will be masked by the high land of Unst.

The illuminating apparatus is dioptric, or by a lens of the first order. The light tower is of masonry, 64 feet in height, and painted white. It stands in lat.  $60^{\circ}$  51' N. long.  $0^{\circ}$  53' west of Greenwich nearly.

On the exhibition of the new light the present temporary light will be discontinued.

Caution.---Vessels in rounding the Scaw of Unst should avoid seeing the red light, by keeping the white light in sight.

Mariners are reminded that the small rock called the Out Stack, which is the floot northern rock of the Shetland Isles, bears from the lighthouse about E. by N.  $\frac{1}{2}$  N., and is distant about half a nautic mile.
