NEW REGULATIONS

TO BE OBSERVED WITH REGARD TO THE QUEEN'S LEVEES AT ST JAMES'S PALACE,

Issued by Her Majesty's Command, February 6, Ĭ858.

The Noblemen and Gentlemen who propose to attend Her Majesty's Levees at St James's Palace, are requested to bring with them two large cards, with their names clearly written thereon, one to be left with the Queen's Page in attendance in the Corridor, and the other to be delivered to the Lord Chamberlain, who will announce the name to the Queen.

PRESENTATIONS.

Any Nobleman or Gentleman who proposes to be presented to the Queen must leave at the Lord Chamberlain's Office, before twelve o'clock, two clear days before each Levee, a card, with his name written thereon, and with the name of the Nobleman or Gentleman by whom he is to be presented. In order to carry out the existing regulation, that no presentation can be made at a Levee excepting by a person actually attending that Levee, it is necessary that a letter from the Nobleman or Gentleman who is to make the presentation, stating it to be his intention to be present, should accompany the presentation card above referred to, which will be submitted to the Queen, for Her Majesty's approbation. It is Her Majesty's command that no presentations shall be made at the Levees, except in accordance with the above regulations.

It is particularly requested that in every case the names be very distinctly written upon the cards to be delivered to the Lord Chamberlain,

in order that there may be no difficulty in announcing them to The Queen.

Notice is Hereby Given, that all persons having Petitions or Addresses to present to Her Majesty at the Levees are to send a card having on it their names, a statement of the object of such Petitions or Addresses, and the names of the persons from whom they come, to the Lord Chamberlain's Office, before twelve o'clock on the day but one previous to each Levee; and that two other cards, having on them precisely what is written upon that sent to the Lord Chamberlain's Office, are to be taken to the Levee; one of the two cards to be delivered to the Page in the Corridor, and the other to the Lord Chamber-lain, who will read its contents to Her Majesty; and on these occasions no other statement is to be addressed to Her Majesty.

A Deputation to present an Address is not to exceed four persons.

The State Apartments will not be open for the reception of Company coming to Court until halfpast one o'clock.

TREASURY WARRANT.

Whereas by an Act passed in the fourth year of the reign of Her present Majesty, intituled "An Act for the regulation of the duties of postage, it is enacted that it shall be lawful for the Commissioners of Her Majesty's Treasury, from time to time, and at any time after the passing of that Act, by Warrant under their hands, to alter and fix any of the rates of British postage or inland postage, payable by law on the transmission by the post of foreign or colonial letters or newspapers, or of any other printed papers, and to subject the same to rates of postage according to the weight thereof, and a scale of weight to be contained in such Warrant.

And whereas another Act of Parliament was passed in the eleventh year of the reign of Her present Majesty, intituled "An Act for giving further facilities for the transmission of letters by post, and for the regulating the duties of postage thereon, and for other purposes relating to the Post office,

And whereas it is expedient that further regulations should be made for the transmission by the post of the letters hereinafter mentioned.

Now we, the Commissioners of Her Majesty's Treasury, in exercise of the powers vested in us in and by the said recited Acts, and of all other powers enabling us in this behalf, do, by this Warrant (under the hands of two of us, the said Commissioners, by the authority of the Statute in that esse made and provided), order and direct as [

h On every letter not exceeding half an ounce in weight, transmitted by the post between any place in the United Kingdom and any Foreign port on the western coast of Africa (the sea couveyance being by British packet boat), there shall be charged and taken a uniform British rate of eixpence.

2. On every letter not exceeding half an ounce in weight, transmitted by the post between any Foreign port on the western coast of Africa and any of Her Majesty's Colonies, or any Foreign Country through the United Kingdom (whether through any Colony or Foreign Country or not), the conveyance between any such Foreign port and the United Kingdom being by British packet boat, there shall be charged and taken the rates of British postage following; that is to say:

For the conveyance of every such letter between the Foreign port on the western coast of Africa and any part of the United Kingdom, a rate of sixpence; and for the conveyance of every such letter between the port in the United Kingdom of the departure or arrival of the packet or ship conveying the same, and the Colony or Foreign Country to or from which the same shall be forwarded, such a further or additional rate of postage as shall, from time to time, be charged and payable for British postage on letters posted or delivered at the port in the United Kingdom of the departwre or arrival of the packet or ship conveying the same, and transmitted direct between such port and any such Colony or Foreign Country; provided that in all cases where such additional rate includes both inland and sea services, there shall be deducted therefrom the sum of one penny in respect of the inland conveyance, under this clause, of every such letter sent through the United King-

3. On every letter transmitted as is herein-before in this Warrant mentioned, exceeding half an ounce in weight, there shall be charged, taken, and paid, progressive and additional rates of post-

age as follows; that is to say:—
On every such letter exceeding half an ounce in weight, and not exceeding one ounce in

weight, two rates of postage.

On every such letter exceeding one ounce, and not exceeding two ounces in weight, four rates of postage.

On every such letter exceeding two ounces, and not exceeding three ounces in weight, six rates of postage.

And on every such letter exceeding three ounces, and not exceeding four ounces in

weight, eight rates of postage.

And for every ounce in weight, above the weight of four ounces, there shall be charged and taken two additional rates of postage; and every fraction of an ounce above the weight of four ounces shall be charged as one additional ounce; and each progressive and additional rate chargeable under this clause, shall be estimated and charged at the sum which any such letter would be charged with under this Warrant, if not exceeding half an ounce in weight.

4. In all cases in which any fetter, in respect of which any rate of postage is chargeable as hereinbefore mentioned, shall pass through a Foreign Country, any Foreign postage payable thereon shall be charged and paid thereon in addition to the British postage.

5. Nothing hereinbefore contained shall in any-

the said recited Act passed in the fourth year of the reign of Her present Majesty in favour of petitions and addresses forwarded to Her Majesty by the post, nor the privilege granted by the same Act to Members of each House of Parliament to receive by the post petitions and addresses to Her Majesty, and petitions addressed to either House of Parliament, not exceeding thirty-two ounces in weight, exempt from postage; nor shall anything in this Warrant contained in anywise prejudice or affect the privileges which seamen and soldiers employed in Her Majesty's service, and seamen and soldiers employed in the service of the East India Company, now by law enjoy, of sending and receiving by the post letters not exceeding half an ounce in weight, subject to the regulations and restrictions in respect of the same.

6. Nothing hereinbefore contained shall be deemed or construed to extend to any letters posted in or addressed to France, or any Foreign Country through France, and transmitted between France or Foreign Countries through France, and any Foreign port on the western coast of Africa, all which last-mentioned letters shall be charged and chargeable with the same rates of postage as

if this Warrant had not been signed.

And whereas the Commissioners of Her Majesty's Treasury, in exercise of the powers reserved to them in and by the said hereinbefore recited Acts, and of all other powers enabling them in that behalf, did, by a certain Warrant in writing, under the hands of two of them, the said Commissioners, and by the authority of the Statute in that case made and provided, bearing date the 21st day of July 1857, order and direct that all packets consisting of books, publications, or works of literature or art, whether British, Colonial, or Foreign, and all packets consisting of printed votes and proceedings of the Imperial Parliament, or the Colonial legislatures, might be transmitted by the post between any part of the United Kingdom, and any part of the several places mentioned and set forth in the Schedule A. to the said now reciting Warrant annexed, and that all such respective packets should be so transmitted in conformity with, and under and subject to the several regulations, orders, directions, and conditions thereinafter mentioned and contained. And that the single rate of postage for the transmission thereof should be that which was mentioned and set forth against the said places respectively in the said Schedule A. And that all such respective packets so transmitted should be subject to the several progressive and additional rates of postage thereinafter mentioned.

And whereas it is expedient to extend the provisions of the said recited Warrant of the 21st day of July 1857, except as hereinafter mentioned, to packets of a like kind to be transmitted by the post between any part of the United Kingdom and any Foreign port on the western coast of Africa, the sea conveyance being by British

packet boat.

7. Now we, the Commissioners of Her Majesty's Treasury, in further exercise of the powers reserved to us in and by the said two hereinbefore recited Acts of Parliament, or either of them, and of all other powers enabling us in this behalf, do, by this Warrant, under the hands of two of me the said Commissioners, by the authority of the Statute in that case made and provided, order and direct as follows :-

All packets consisting of books, publications, or works of literature or art, whether British, Colonial, or Foreign, and all packets consisting of wise prejudice or affect the privilege granted by printed votes and proceedings of the Imperial

Parliament, or any of the Colonial Legislatures, may be transmitted by the post between any part of the United Kingdom and any Foreign port on the Western coast of Africa (the sea conveyance being by British packet boat). And that, on every such packet so transmitted under this clause, if not exceeding four ounces in weight, there shall be charged, taken, and paid, for the transmission thereof as aforesaid, the uniform single rate of postage of threepence; and that on every such packet exceeding four ounces in weight, there shall be charged, taken, and paid, such progressive and additional rates of postage as are directed to be charged, taken, and paid, on and in respect of the several packets mentioned and contained in, and authorised to be transmitted by the post, under the provisions of the said recited Warrant of the 21st day of July 1857.

8.
