THE following Address of Congratulation to the Queen, on the occasion of the Marriage of Her Royal Highness the Princess Royal with His Royal Highness Prince Frederick William of Prussia, having been transmitted to the Right Honourable the Secretary of State for the Home Department for presentation, has accordingly been presented by him to Her Majesty, who has been pleased to receive the same very graciously:—

To The QUEEN's Most Excellent Majesty.

May it please your Majesty,

WE, the Mayor, Aldermen, and Burgesses of the borough of Truro, in the Ancient Duchy of Cornwall, in Common Hall assembled, beg leave most loyally and dutifully to present to your Majesty, and to His Royal Highness the Prince Consort, our most respectful and sincere Congratulations on the auspicious Marriage of the Princess Royal of England with the Prince Frederick William Nicholas Charles of Prussia, the heir presumptive of the Protestant House of Brandenburg, and to express our earnest hope and confident expectation that, under the blessing of Divine Providence, it may not only augment their individual happiness and largely contribute to the felicity of your Majesty and your Royal Consort, but also tend to increase and consolidate the mutual influence and interests of Great Britain and Prussia.
