A PROCLAMATION, In order to the Electing a Peer of Scotland.

VICTORIA, R.

TYPEREAS George Sholto, Earl of Morton, was duly elected and returned to be one of the sixteen Peers of Scotland to sit in the House of Peers in the present Parliament of the United Kingdom of Great Britain and Ireland, and is since deceased: In order to the electing another Peer of Scotland to sit in his room, We do, by the advice of Our Privy Council, issue forth this Our Royal Proclamation, strictly charging and com-manding all the Peers of Scotland to assemble and meet at Holyrood-House, at Edinburgh, on Tuesday the twenty-ninth day of this instant June, between the hours of twelve and two in the afternoon, to nominate and choose another Peer of Scotland to sit and vote in the House of Peers in this present Parliament of the United Kingdom of Great Britain and Ireland, in the room of the said George Sholto, Earl of Morton, deceased, by open election and plurality of voices of the Peers that shall be then present, and of the proxies of such as shall be absent (such proxies being Peers, and producing a mandate in writing, duly signed before witnesses, and both the constituent and proxy being qualified according to law): and the Lord Clerk Register, or such two of the principal Clerks of the Session as shall be appointed by him to officiate in his name, are hereby respectively required to attend such meeting, and to administer the oaths required by law to be taken there by the said Peers, and to take their votes; and immediately after such election made and duly examined, to certify the name of the Peer's o elected, and to sign and attest the same in the presence of the said Peers the electors, and return such certificate into Our High Court of Chancery of Great Britain: And We strictly charge and command that this Our Royal Proclamation be duly published at the Market-Cross at Edinburgh, and in all the county towns of Scotland, ten days at least before the time hereby appointed for the meeting of the said Peers to proceed on such election.

Given at Our Court at Buckingham Palace, this fifth day of June, in the year of our Lord one thousand eight hundred and fiftyeight, and in the twenty-first year of Our reign.

REGULATIONS

TO BE OBSERVED WITH REGARD TO THE QUEEN'S LEVEE AT ST JAMES'S PALACE.

By Her Majesty's Command.

The Noblemen and Gentlemen who propose to attend Her Majesty's Levee at St James's Palace, are requested to bring with them two large cards, with their names clearly written thereon, one to be left with The Queen's Page in Attendance in the Corridor, and the other to be delivered to the Lord Chamberlain, who will announce the name to the Queen.

PRESENTATIONS.

Any Nobleman or Gentleman who proposes to be presented to the Queen must leave at the Lord Chamberlain's Office, before twelve o'clock, two clear days before the Levee, a card with his name written thereon, and with the name of the Nobleman or Gentleman by whom he is to be presented. In order to carry out the existing regulation that no presentation can be made at a Levee excepting by a person actually attending that Levee, it is also necessary that a letter from the Nobleman or Gentleman who is to make the presentation, stating it to be his intention to be present, should accompany the presentation card above referred to, which will be submitted to the Queen for Her Majesty's approbation. It is Her Majesty's command that no presentations shall be made at the Levee except in accordance with the above regulations.

It is particularly requested that in every case the names be very distinctly written upon the cards to be delivered to the Lord Chamberlain, in order that there may be no difficulty in announcing them to The Queen.

The State Apartments will not be open for the reception of Company coming to Court, until half-past one o'clock.

Addresses.

Notice is hereby given, that all persons having Petitions or Addresses to present to Her Majesty at the Levee are to send a card chaving on it their names, a statement of the object of such Petitions or Addresses, and the names of the

persons from whom they come, to the Lord Chamberlain's Office, before twelve o'clock on the day but one previous to each Levee; and that two other cards, having on them precisely what is written upon that sent to the Lord Chamberlain's Office, are to be taken to the Levee; one of the two cards to be delivered to the Page in the Corridor, and the other to the Lord Chamberlain, who will read its contents to the Queen; and on these occasions, no other statement is to be addressed to Her Majesty.

A Deputation to present an Address is not to

While we pray for the prolongation of a life so precious in the estimation of all the inhabitants of this great Empire, we gladly embrace this opportunity of transmitting our fervent congratulations to your Majesty, and to His Royal Highness the Prince Consort, on the late auspicious occasion of the Marriage of the eldest born of the Royal Family, the Princess Royal, to a Prince whose high character and distinguished endowments have secured for him the enthusiastic admiration and affection of the inhabitants of this United Kingdom, as well as of his native land. We cordially participate in the delight which this conjugal union must have yielded to the parental hearts of your Majesty and the Prince Consort, and we cannot for a moment doubt that in this loyal feeling the hearts of our fellow-subjects universally sympathise.

We earnestly trust that the prospects of domestic felicity arising from this matrimonial union will be amply realised, and that, along with the fulfilment of a hope so pleasing, other beneficial results may be anticipated, having a direct tendency to work out and to perpetuate many great social advantages. The example of an amiable Princess, trained up in the fear of the Lord, adorned by the meekness of wisdom, and familiar with the gentle offices of humanity, and all the choice graces of the female character residing in the heart purified by faith, can scarcely fail ultimately to diffuse a

salutary influence, especially when encouraged and aided by the co-operation of a kindred spirit, equally intent on forwarding every undertaking calculated to promote the improvement and happiness of the great family of mankind, along with the more limited interests of country and home, which every patriotic heart refuses to let go. It is our earnest prayer and hope that, through the mercy of the Most High, the Prince and Princess of Prussia may live long in peace and unity, as heirs together of the grace of life, and that, in their days, the Lord God may cause righteousness and praise to spring forth before all the Nations, so that they may not only witness, but efficiently advance the growth of civilization and sound policy, of legislative wisdom, social order, enlightened education, and religious liberty, with all the hallowed influences which nourish the growth of genuine piety, and insure the removal of long-cherished prejudices, and the disarming of inveterate jealousies, thus persevering in the hallowed endeavour to keep the unity of the Spirit in the bond of peace, with such abundant success as to heal the wounds and abolish the enmities of alienated kingdoms, until, in the fulness of the time of the triumphant reign of the Messiah, wars shall cease, and there shall be nothing to hurt or to destroy, for the earth shall be filled with the knowledge of the Lord as the waters cover the sea.

CRIMEAN AND BALTIC MEDALS. AGENTS OF TRANSPORTS IN THE BLACK SEA AND

BALTIC.

Department of the Accountant-General of the Navy, Admiralty, Somerset House, 3d June 1858.

The Lords Commissioners of the Admiralty have been pleased to take a favourable view of the claims of the Officers who served as agents for transports during the late war, with reference to their having awarded the Crimean and Baltic Medal. Such Officers therefore as served as agents for transports in the Black Sea, between the 14th September 1854 and the 9th September 1855, or who served in the Baltic during the operations in that sea in the years 1854 and 1855, should make application to the Accountant-General of the Navy (producing a certificate of identity, and specifying the period during which they were employed in the Black Sea or in the Baltic, as the case may be), when, if their claims be satisfactorily established, the medal will be awarded to them.

WAR-OFFICE, June 2, 1858.

THE Queen has been graciously pleased to signify Her intention to confer the Decoration of the Victoria Cross on the undermentioned Officers and Non-Commissioned Officers of Her Majesty's Army, who have been recommended to Her Majesty for that Decoration, in accordance with the rules laid down in Her Majesty's Warrant of the 29th of January 1856, on account of Acts of Bravery performed by them in the Crimea during the late War, as recorded against their several names; viz.—

Regiment or Corps.	Rank and Name.	Act of Bravery for which recommended.
2d Dragoons	Date of Act of Bravery, 26th October 1854	For having, at the battle of Balaklava, galloped out to the assistance of Private McPherson, of the same Regiment, on perceiving him surrounded by seven Russians, when, by his gallantry, he dispersed the enemy and saved his comrade's life. For having, on the same day, when the Heavy Brigade was rallying, and the enemy retiring, finding his horse would not leave the ranks, dismounted and brought in a prisoner from the Russian lines. Also for having dismounted on the same day, when the Heavy Brigade was covering the retreat of the Light Cavalry, and lifted from his horse Private Gardiner, who was disabled from a severe fracture of the leg by a round shot. Serjeant Ramage then carried him to the rear from under a very heavy cross fire, thereby saving his life, the spot where he must inevitably have fallen having been immediately afterwards covered by the Russian cavalry.
3d Regiment, late of the 30th Regiment	Brevet-Major Mark Walker Date of Act of Bravery, 5th November 1854	For having, at Inkerman, distinguished himself in front of his Regiment, by jumping over a wall, in the face of two battalions of Russian infantry, which were marching towards it,—for the purpose of encouraging his comrades by his example to advance against such heavy odds,—which they did, and succeeded in driving back both battalions.
57th Regiment	Gardiner Date of Acts of Bravery, 22d March and 18th June 1855	For distinguished coolness and gallantry upon the occasion of a sortie by the enemy, and when he was acting as Orderly Serjeant to the Field Officers of the trenches,—Left Attack upon Sevastopol,—in having rallied the covering parties which had been driven in by the Russians, thus regaining and keeping possession of the Trenches. Also, for unflinching and devoted courage in the attack on the Redan, on the 18th June 1855, in having remained, and encouraged others to remain in the holes made by the explosion of shells, from whence, by making parapets of the dead bodies of their comrades, they kept up a continuous fire until their ammunition was exhausted, thus clearing the enemy from the parapet of the Redan. This was done under a fire in which nearly half the officers, and a third of the Rank and File of the Party of the Regiment were placed hors de combat.
Late of 6th Dragoons	Surgeon James Monat, C.B., (now Deputy Inspector-General of Hospitals) Date of Act of Bravery, 26th October 1854	17th Lancers, who was lying dangerously

Royal Engineers	Captain Howard Craufurd Elphinstone Date of Act of Bravery, 18th June 1855	For fearless conduct, in having, on the night after the unsuccessful attack on the Redan, volunteered to command a party of volunteers, who proceeded to search for and bring back the scaling ladders left behind after the repulse; and while successfully performing this task of rescuing trophies from the Russians, Captain Elphinstone conducted a persevering search, close to the enemy, for wounded men, twenty of whom he rescued and brought back to the trenches.
Royal Engineers	Colour - Serjeant Henry McDonald Date of Act of Bravery, 19th April 1855	For gallant conduct when engaged in effecting a lodgement in the enemy's Rifle Pits, in front of the Left advance of the Right Attack on Sevastopol; and for subsequent valour, when, by the Engineer Officers being disabled from wounds, the command devolved upon him, and he determinately persisted in carrying on the sap, notwithstanding the repeated attacks of the enemy.
Royal Engineers	Colour-Serjeant Peter Leitch Date of Act of Bravery, 18th June 1855	For conspicuous gallantry in the assault on the Redan, when, after approaching it with the leading ladders, he formed a caponnière across the ditch, as well as a ramp, by fearlesssly tearing down gabions from the parapet, and placing and filling them, until he was disabled from wounds.

TREASURY WARRANT.

Whereas by an Act passed in the fourth year of the reign of Her present Majesty, intituled "An Act for the regulation of the duties of postage," power is given to the Commissioners of Her Majesty's Treasury, from time to time, by Warrant under their hands, to alter and fix any of the rates of British or inland postage payable by law on the transmission by the post of foreign or colonial letters or newspapers, or any other printed papers, and to subject the same to rates of postage according to the weight thereof, and a scale of weight to be contained in such Warrant, and from time to time, by Warrant as aforesaid, to alter or repeal any such altered rates, and to make and establish any new or other rates in lieu thereof.

And whereas it is expedient that regulations should be made for the transmission by the post of the letters hereinafter mentioned.

Now we, the Commissioners of Her Majesty's Treasury, in exercise of the power or authority in us for such purpose vested in and by the said Act, and of all other powers enabling us in this hehalf, do, by this Warrant (under the hands of two of us, the said Commissioners, by the authority of the Statute in that case made and provided), order and direct that on every letter not exceeding half an ounce in weight, transmitted by the post between any place in the United Kingdom and the islands of Martinique, Guadaloupe, and Curaçoa respectively (direct or through any foreign country), there shall be charged and taken in lieu of any rates of British postage now payable by law on such letters, an uniform British rate of six pence.

And we direct that on every letter not exceeding half an ounce in weight, transmitted by the post between the said islands of Martinique, Guadaloupe, and Curaçoa, or any of them, and any of Her Majesty's colonies, or any foreign country through the United Kingdom (whether through any colony or foreign country or not), there shall be charged and taken in lieu of any rates of British postage now payable by law on such letters, the rates of British postage following (that is to say)—

For the conveyance of every such letter between the islands of Martinique, Guadaloupe, and Curaçoa, or any of them, and any part of the United Kingdom, a rate of sixpence; and for the conveyance of every such letter between the port in the United Kingdom of the departure or arrival of the packet or ship conveying the same and the colony or foreign country to or from which the same shall be forwarded, such a further or additional rate of postage as shall from time to time be charged and payable for British postage on letters posted or delivered at the port in the United Kingdom of the departure or arrival of the packet or ship conveying the same, and transmitted direct between such port and any such colony or foreign country.

And we direct that on every letter transmitted as is mentioned in this Warrant, exceeding half an ounce in weight, there shall be charged, taken, and paid, progressive and additional rates of postage as follows, that is to say:—

On every such letter exceeding half an ounce in weight and not exceeding one ounce in weight, two rates of postage.

On every such letter exceeding one ounce and not exceeding two ounces in weight, four rates of postage.

On every such letter exceeding two ounces and not exceeding three ounces in weight, six rates of postage.

And on every such letter exceeding three ounces and uot exceeding four ounces in weight, eight rates of postage.

And for every ounce in weight above the weight of four ounces, there shall be charged and taken two additional rates of postage; and every fraction of an ounce above the weight of four ounces shall be charged as one additional ounce, and each progressive and additional rate, chargeable under this clause, shall be estimated and charged at the sum which any such letter would be charged with under this Warrant, if not exceeding half an ounce in weight.

And we direct that in all cases in which any letter in respect of which any rate of postage is chargeable by this Warrant shall pass through a foreign country, any foreign postage payable thereon shall be charged and paid thereon in addition to the British postage.

And we further direct that nothing in this Warrant contained shall in anywise prejudice or affect the privilege granted by the said recited Act, in favour of petitions and addresses forwarded to Her Majesty by the post, nor the privilege granted by the same Act to members of each House of Parliament to receive by the post petitions and addresses to Her Majesty, and petitions addressed to either House of Parliament, not exceeding thirty-two ounces in weight, exempt from postage; nor shall anything in this Warrant contained, in anywise prejudice or affect the privilege which seamen and soldiers employed in Her Majesty's Service, and seamen and soldiers employed in the service of the East India Company, now by law enjoy, of sending and receiving by the post letters not exceeding half an ounce in weight, subject to the regulations and restrictions in respect of the same.

And we further direct that nothing in this Warrant contained shall be deemed and construed to extend to any letters or packets posted in or addressed to France, or any foreign country through France, and transmitted between France or foreign countries through France and the islands of Martinique, Guadaloupe, and Curaçoa, or either of them, all of which last-mentioned letters and packets shall be charged and chargeable with the same rates of postage as if this Warrant had not been signed.

And we further direct that the term "by the post," used in this Warrant, shall, as to the sea conveyance, include the conveyance by any British packet-boat, and the said term shall also include the sea conveyance by any private ship.

And we further direct that this Warrant shall come into operation on the 1st day of July 1858.

Provided lastly, and we hereby declare and direct, that it shall be lawful for the Commissioners for the time being of Her Majesty's Treasury, by Warrant duly made, at any time hereafter to alter or repeal any of the rates hereby altered, or the regulations hereby made, and to make and establish any new or other rates or regulations in lieu thereof, and from time to time to appoint at what time the rates that may be payable are to be paid.

LISBON, May 28, 1858.

THE QUEEN, Sovereign of the Most Noble Order of the Garter, having been pleased, by a Commission under Her Majesty's Sign Manual and the Great Seal of the Order, to constitute and appoint the Most Honourable John Alexander, Marquess of Bath, Her Majesty's Envoy Extraordinary and Minister Plenipotentiary, on a Special Mission to this Court, and Sir Charles George Young, Knight, Garter Principal King-of-Arms, to be Her Majesty's Plenipotentiaries for Investing His Most Faithful Majesty, Pedro 5th, King of Portugal and the Algarves, Duke of Saxony, with the Ensigns and Habit of that Most Noble Order, the said Plenipotentiaries embarked at Plymouth on the 11th instant, on board Her Majesty's Frigate Diadem, (accompanying the Squadron escorting the Queen of Portugal to Lisbon,) together with their respective Suites, and landed in this city on the 17th instant.

On the 20th instant the Marquess of Bath was honoured with an audience of His Most Faithful Majesty at the Palace of Belem, at which Garter and the respective Suites were presented. Their Majesties the King and Queen afterwards held a General Reception, at which the Plenipotentiaries and respective Suites were presented to Her Majesty the Queen, and to His Majesty the King, Don Ferdinand.

The requisite arrangements for His Majesty's Investiture having been made, His Majesty was pleased to appoint Thursday the 27th instant for that purpose.

At four o'clock on that day the several persons appointed to carry the Insignia assembled at the residence of the Marquess of Bath, and from thence proceeded to the Royal Palace of Belem in the following Order:—

Lieutenant-General Sir Harry W. Smith of Aliwal, Bart., G.C.B., bearing the Hat and Star of the Order in like manner. Captain George Stoney Swinny, Aide-de-Camp to Sir Harry W. Smith, Bart., bearing the Sword of the Order in like manner.

Lieutenant - Colonel Lord Burghersh, C. B., bearing the Collar of the Order in like manner.

James Robinson Planché, Rouge Croix Pursuivant of Arms, in his Tabard, and bearing the Garter and the Ribbon and George of the Order, in like manner.

William Courthope, Esq., Somerset Herald, Secretary of the Commission, in his Tabard and Collar of SS., and carrying in his hand the Sovereign's Commission.

Sir Charles George Young, Knight, Garter, Principal King of Arms, in his Mantle, Chain, and Badge, bearing his Sceptre, and the Sovereign's Letters of Credence. Henry Percy Anderson, Esq., Secretary to the Special Mission, bearing the Mantle and Cordon of the Order, on a Velvet Cushion.

His Excellency John Alexander, Marquess of Bath, Her Majesty's Envoy Extraordinary and Minister Plenipotentiary, on a Special Mission.

Advancing into the Royal Presence, with due reverences, the Mission was received by His Most Faithful Majesty, surrounded by the Ministers of State and Great Officers of the Court.

The Gentlemen bearing the Insignia divided to the right and left, the Plenipotentiaries advancing between them; the Secretary of the Commission, Somerset Herald, remaining near to the Plenipotentiaries, to deliver to them the Insignia.

The First Plenipotentiary, the Marquess of Bath, then made an Address to His Majesty, declaratory of the object of the Mission, to which His Majesty made a most gracious reply, then delivered to his Lordship the Letters of Credence, which his Lordship presented to the king who delivered the same to the Marquess de Loulé, President of the Council and Minister of Affairs. The Statutes were then in like manner presented to the King, and next the Commission, both of which were delivered by His Majesty to the Marquess de Loulé, by whom the latter was subsequently returned to Garter.

Garter then taking the Garter, delivered it to the Marquess of Bath, who buckled the same around His Majesty's left leg; Garter reading the Admonition in Latin.

His Majesty was next invested with the Riband and George appendant, Garter reading the Admonition.

The King then delivered his Sword, which Garter received, and retained as an ancient Fee appertaining to his office; and His Majesty was invested with the Sword of the Order.

His Majesty being then divested of the Riband and George, which was received by an Officer of the Court, Garter presented to the Marquess of Bath the Mantle, with which His Majesty was invested by the Plenipotentiaries.

His Majesty was in like manner invested with the Collar of the Order; Garter then delivered to the Marquess of Bath the Hat and Feathers, which were presented by his Lordship to the King, and his Lordship immediately after delivered the Star of the Order to His Majesty.

The King then delivered to the Marquess of Bath His Majesty's Nomination of a Proxy under the Royal Signet and Sign Manual, in the event of an Installation in the Royal Chapel of St George at Windsor.

The ceremony of Investiture being completed, the Plenipotentiaries, with their respective Suites making their reverences, withdrew from the Royal Presence, and were re-conducted to the Saloon, whence they had advanced to the presence of His Majesty.

There were present during the Investiture, Her Majesty the Queen; His Majesty The King Don Ferdinand; the Infanta Dona Isabel Maria; the Infants Don Louis and Don John; the Queen's Brother, the Prince of Hohenzollern; the Marquess de Loulé, President of the Council and Minister of Foreign Affairs; the Minister of Public Works, Commerce, and Industry; the Minister of War; the Duke of Saldanha, Grand Marshal of the Court; the Duke of Terceira, Grand Equerry; the Viscount de Carreira, Great Chamberlain to the King; the Patriarch of Lisbon; the Marquess de Fronteira, Great Chamberlain to the Queen; the Marquess of Bemposta Subserra, Introducer of Ambassadors, and other Officers of the Household; the Councillors of State; Henry Howard, Esquire, British Minister at the Court of Lisbon; the British Consul; the Foreign Ministers at the Court of Lisbon, and other distinguished Personages; as also Rear-Admiral Sir Henry D. Chads, K.C.B., and the Captains in command of Her Majesty's Ships in the Tagus.

A splendid Banquet was afterwards given, at which were present their Majesties the King and Queen, His Majesty wearing the Ensigns of the Order of the Garter; the King Don Ferdinand; the Infanta Dona Isabel Maria, and the Infants Don Louis and Don John; the Queen's Brother, the Prince of Hohenzollern; the Plenipotentaries and their Suites; the Ministers of State and Great Officers of the Court; the British Minister, and other Persons of Distinction.

After the Banquet their Majesties held a Circle, at which the Plenipotentiaries and their Suites took leave of the Court, the Mission having throughout been received with the greatest attention and condescension by their Majesties and Royal Family.

Board of Trade, Whitehall, June 2, 1858.

The Right Honourable the Lords of the Committee of Privy Council for Trade and Plantations have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Ambassador at Paris, inclosing copy of a French Imperial Decree authorising the negotiation in France of Foreign Railway Shares, and of which the following is a translation:—

Art. 1.—The negotiation at the Paris and Provincial Bourses, of Shares issued by Railway Companies on account of railways constructed beyond the French territory, is regulated by the laws and regulations applicable to the negotiation of French securities of a similar nature, subject, however, to the conditions mentioned in the following Articles:—

Art. 2.—The Companies must prove that they are constituted in conformity with the laws of the country where they are formed.

For this purpose they must remit to the Minister of Finance, and to the Syndical Chamber of Sharebrokers (Agents de Change), authentic copies of:—

1st. The authorised public Acts by which their formation has been sanctioned, and which have empowered them to construct a railway or railways

ways.

2d. The statutes, statements of special conditions (cahiers de charges), and in general all the decree.

documents by which they have been regulated or modified.

Art. 3. The Companies are obliged to show that their shares, as also their bonds, if they have issued any, are officially recognised (estées) in the country to which the railways belong.

Art. 4. The shares must not be of less than 500 francs. All those which have been issued should be paid up to the extent of seven-tenths.

They will not be authentically placed upon the list of the French Bourses until they have given rise to operations sufficiently numerous for their course to be appreciated.

Art. 5. The bonds can be negotiated and quoted in France when the capital (capital social), or that portion of such capital which is represented by shares shall have been paid up, and the issue in France of such bonds shall have been authorised by the Ministers of Finance, of Agriculture, of Commerce, and of Public Works.

Art. 6. It is forbidden to any sharebroker to assist to negotiate the shares of Foreign Companies previous to their being admitted by the Syndical Chamber of Sharebrokers as negotiable.

It is equally prohibited before such admission has been signified, either to publish the course of these shares in France, or to announce subscriptions open in France for shares and bonds of Foreign Companies.

Art. 7. Nothing is to prejudice any authorisation granted previously to the promulgation of this decree.
