Fixed Light on Favignana Island.

(No. 84.) NORTH ATLANTIC-NEWFOUNDLAND.

Revolving Light on Bacalháo Island.

The Board of Works, Newfoundland, has given notice, that on and after the 20th of December 1858, a light will be exhibited from the lighthouse recently erected on Bacalháo Island, between

Trinity and Conception Bays, eastern coast of New foundland.

The light will be a white revolving light, showing a bright face every twenty seconds, piaced at an elevation of 380 feet above the sea at high water, and in clear weather should be seen from a distance of 30 miles; but when the southern end of the island bears N.N.E., distant less than 8 miles, the light will not be visible.

The illuminating apparatus is dioptric, or by

lenses of the first order.

The light tower is of brick, and stands on the northern end of the island, in about lat. 48° 9' N. long. 52° 51' West of Greenwich. The keeper's dwelling is a detached square building, painted white, with the roof red.
