The QUEEN'S Most Excellent Majesty in Council.

WHEREAS by the "Passengers Act, 1855," it is amongst other things enacted, as before any passenger ship shall be cleared at the Emigration Officer at the port of clears shall satisfy himself that there is on board cleint quantity of pure water, carried in ...s or casks, to secure, throughout the intended voyage, the issue of three quarts daily to each statute adult, for the use of the passengers, exclusive of the quantity prepared for cooking; and whereas it is also enacted that it shall be lawful for Her Majesty, by any Order in Council, to prescribe such rules and regulations as to Her Majesty may seem fit, for permitting the use on board passenger ships of an apparatus for distilling water, and for defining in such case, the quantity of fresh water to be carried in tanks or casks for the passengers.

Now, therefore, Her Majesty doth, by and with

the advice of Her Privy Council, and in pursuance and in exercise of the authority vested in Her by the said "Passengers Act, 1855," hereby

order as follows:

Any passenger ship may be cleared out and proceed on her voyage, having on board, in tanks or casks, only half the quantity of pure water required by the control of the process of the pr required by the said Act to be carried for the use

of the passengers, provided

1. That there be on board such passenger ship an efficient apparatus for distilling fresh water from salt water, of the description commonly known as Normandy's Patent, or of such other description as may, with the sanction of one of Her Majesty's Principal Secretaries of State, be notified in the London Gazette as having been approved by the Emigration Commissioner. approved by the Emigration Commissioner.

2. That the owners, charterers, or masters of the ship, before clearance, lodge with such Emigration Officer a certificate from some competent person, to be named by the Emigration Officer, declaring that the apparatus is one of the descriptions above specified, and that it has been, within the seven days immediately preceding the date of such certificate, examined by a competent person, and is then in good working condition, and stating the number of imperial gallons of pure fresh water which it is capable of producing in

every twenty-four hours.
3. That the Emigration Officer is satisfied that this number of gallons is not less than the whole number of persons about to proceed on the intended voyage of such ship; that is to say: the whole number of cabin passengers, passengers,

and crew.

4. That there is rated on the ship's articles and on board the ship, some person or persons who, to the satisfaction of the said Emigration Officer, shall be competent for the proper management and

repair of such distilling apparatus.

And to prevent all doubts on the construction of this Order in Council, it is hereby further ordered that the terms "Passenger Ship," "Emiordered, that the terms "Passenger Ship," "Emigration Officer," "Statute Adult," and "Master," shall herein have the same significations as are assigned to them respectively in the said "Passengers Act, 1855.

NOTIFICATION.

WITH reference to the Notification which appeared in the Gazette of the 10th of September last, that a Convention had been concluded between Her Majesty and the Emperor of Brazil, for the settlement of all outstanding claims of subjects of either party upon the Government of the other, by means of a Mixed Commission, and that Commissioners were about to meet at Rio de Janeiro for the purpose of carrying out the stipulations of such Convention.:

Notice is hereby given, that the Commissioners held their first meeting on the 10th ultime; and that all persons, subjects of Her Majests, who may have claims to prefer upon the Government of Brazil, arising out of transactions prior to the 9th of September 1858 (the date of the exchange of the ratifications of the Convention), should forthwith transmit the particulars of the same to Her Majesty's Principal Secretary of State for Foreign Affairs, or to Her Majesty's Minister at the Court of Brazil, together with the requisite evidence in support thereof, for the purpose of being submitted to the Commissioners.

Notice is also hereby given, that in conformity with the following stipulation of the third Article

of the Convention:

" Every claim shall be presented to the Commission within twelve months from the day of its first meeting, unless in any case where reasons for delay shall be established to the satisfaction of the Commission, or of the Arbitrator or Umpire in the event of the Commissioners differing in opinion thereupon; and then and in any such case, the period for presenting the claim may be extended to any time not exceeding six months longer:"-

Every claim which may not be presented to the Commission before the 10th of March 1860 will be inadmissible, unless reasons for delay be established to the satisfaction of the Commissioners, or of the Arbitrator or Umpire; and that every claim which shall not be presented to the Commissioners before the 10th of September 1860 will, in conformity with the fifth article of the Convention, be considered and treated as finally settled, barred, and thenceforth inadmissible.

NOTICE TO MARINERS.

(No. 15.) MEDITERRANEAN.—ARCHIPELAGO. Light on Andros Island.

With reference to Notice to Mariners, No. 11, of 10th of March 1859, information has been received at the Admiralty that the light on Andros, one of the western Isles of the Archipelago, or Ægean Sea, is not placed on Cape Kabanos, the northern extreme of the island, (as stated in the Official Notice from the Minister of Marine of Greece,) but upon Cape Fassa.

The light is a fixed light, varied by a flash every three minutes, and is intended as a guide to the Doro Channel. It is placed at an elevation of 708 English feet above the level of the sea, and in clear weather should be visible from a distance of

30 miles.

The illuminating apparatus is dioptric or by

lenses, and of the first order.

The light tower is about 70 feet in height, and stands upon a bluff point called Cape Fassa, at the north-west extremity of the island. Its correct position is in lat. 37° 57' 30" N., long. 34° 42' 30" East of Greenwich, nearly.

(No. 16.) GULF OF MEXICO.—UNITED STATES.

Revolving Light on Cape San Blas.

The United States Lighthouse Board has given notice, that on and after the 1st of May 1859 a light would be exhibited from the new lighthouse on Cape San Blas, Florida.

The new light is a revolving white light, showing every $1\frac{1}{2}$ minutes, placed at an elevation of 96 feet above the level of the sea, and in ordinary weather should be visible from a distance of 16 miles.

The illuminating apparatus is dioptric, by a

Fresnel lens, of the third order.

The light tower is of brick, and coloured white, with a small building of two stories attached to the eastern side. It stands in lat. 29° 41′ 41" N., long. 85° 24′ 34" West of Greenwich, according to the United States Coast Survey.

Beacon Light at Corpus Christi.

The light is a fixed white light, placed at an elevation of 77 feet above the sea, and in clear weather should be seen from the distance of 14 miles.

of the fifth order. The lautern is on the keeper's dwelling, which is built of brick, and coloured white. The building stands at the north end of Corpus Christi bluff.
