THE following Addresses of Congratulation to the Queen having been transmitted to the Right Honourable the Secretary of State for the Home Department for presentation, have accordingly been presented by him to Her Majesty, who has been pleased to receive the same very graciously.

*May it please your Majesty,*

WE, your Majesty's most dutiful and loyal subjects, the Ministers and Elders of the Church of Scotland, met in General Assembly, beg leave to approach the Throne with our humble but warm and affectionate Congratulatory on the recurrence of the day which gave your Majesty birth.

We account it a special blessing to the British Empire that it has pleased God to raise up and to preserve, in the person of your Majesty, a Sovereign, whose public administration of Government, and whose private virtues have secured the continued admiration, respect, and love of Her subjects.

That your Majesty may be long spared to receive from year to year expressions of devoted attachment to your Majesty's person and Government; that the children whom God has given you may adorn their exalted station, and minister largely to your Majesty's domestic comfort, and that of His Royal Highness the Prince Consort, by their exhibition of all Royal and Christian graces; and that after a prosperous reign on earth, your Majesty may inherit the kingdom that passeth not away, are the fervent prayers of,

We deeply deplored the treachery and barbarity of the late revolt in India, which occasioned, as is well known, profound grief to your Majesty. The war which followed was distinguished by innumerable proofs of the bravery of your Majesty's troops, the heroism and patient endurance of your faithful subjects, and finally, the complete success which, through the blessing of Almighty God, crowned your Majesty's arms.

It is with unfeigned satisfaction that we tender to your Majesty our heartfelt Congratulatory on the happy issue, and our fervent hope that the peace and order which now prevail in India may long continue under your Majesty's benignant rule.

That it may please the Father of all our mercies to lift on the British Empire, and all its dependencies, the light of His gracious countenance, and to preserve the life of your Majesty to reign long over a free, a loyal, and a religious people, is the sincere prayer of,

*May it please your Majesty,*

WE, your Majesty's most dutiful and loyal subjects, the Ministers and Elders of the Free Church of Scotland, in General Assembly convened, rejoice in the opportunity which the return of this auspicious day affords of approaching your Majesty's Throne with renewed assurances of attachment to your Majesty's person, of loyalty to your Majesty's Government, and of regard for every Member of your royal house.

Although no longer connected with the State as an Ecclesiastical Establishment, we remain unchanged in our devotion to the great principles of the British Constitution, and give thanks to God for the civil and religious freedom which are thereby secured to all your Majesty's dutiful subjects.

We congratulate your Majesty on the termination of the war in India, on the success of your



Majesty's Arms in suppressing rebellion throughout that wide region of your Majesty's dominions, and on the restoration of peace under circumstances which have so manifestly called for hearty thanksgiving to Almighty God.

It is our joy that we are warranted to hope that both India and China, through the changes which have recently occurred in our relations to those Continents, have now been opened up, as they never were before, to the extensive introduction of "the glorious Gospel of the grace of God."

We watch with deep anxiety the progress of that war which the Almighty, in His sovereign providence, has permitted to break forth on the Continent of Europe; and while acknowledging with grateful and adoring hearts the Lord's mercy to this Nation in so often, in former conflicts, keeping the battle from our gates, we rejoice to learn the determination of your Majesty, in full accordance with the will and wishes of your people, to maintain a strict neutrality between the Contending Powers; and we doubt not that your Majesty, while thus abstaining from all armed intervention, will seize every opportunity of employing the whole influence and moral power of this Country for the purpose of restoring peace to Europe, and at the same time securing the blessings of freedom of conscience to those who, in Italy, have so long groaned under civil oppression and ecclesiastical tyranny.

That your Majesty's precious life may be long spared; that spiritual and eternal blessings may richly endow you; and that, when you have finished your course on earth, you may receive that crown which the Lord the Righteous Judge alone can give, is the earnest and united prayer of,

DUBLIN CASTLE, May 24, 1859.

This day His Excellency the Grand Master (by Her Majesty's command,) held a Chapter of the Most Illustrious Order of St Patrick, at the Castle of Dublin.

The following Knights Companions, in their Mantles, Stars, and Collars, assembled in the Robing Room, viz.:—The Marquess of Clanricarde, the Marquess of Headfort, the Marquess of Conyngham, the Earl of Howth, the Earl of Rosse, and Lord Gough, attended by the following Officers of the Order:—His Grace the Archbishop of Dublin, Chancellor; Lowry V. Townley Balfour, Esq., Secretary; George L'Estrange, Esq., Usher of the Black Rod; Sir Bernard Burke, Ulster King of Arms, Knight Attendant on the Order; Molyneux Betham, Esq., Cork Herald; and Sheffield Betham, Esq., Dublin Herald.

At Three o'Clock P.M. the Knights Companions were called over by Ulster, and proceeded to the presence of the Grand Master, who was seated in the Chair of State in the Throne Room, and they, with their usual reverences, took their respective seats at the table, according to their stalls.

His Excellency then commanded Ulster to read Her Majesty's Letter authorizing the Chapter to

be held, and also Her Majesty's Letter appointing George L'Estrange, Esq., to be Usher of the Black Rod of the said Most Illustrious Order; which being done, George L'Estrange, Esq., was introduced by Ulster, and having made and subscribed the necessary Declaration, was invested with the Ribbon and Badge of Usher of the Black Rod to the said Most Illustrious Order.

The Most Honourable the Marquess of Downshire was then introduced by the Gentleman Usher, and kneeling, received the honour of Knighthood, and retired.

His Excellency the Grand Master then communicated to the Chapter that Her Majesty had been pleased to nominate Sir Arthur Wills Blundell Sandys Trumbull Windsor Hill, Knight, Marquess of Downshire, to be a Knight Companion of the said Most Illustrious Order, and to command that his Lordship be invested with the Ribbon and Badge.

By command of the Grand Master the two Junior Knights present proceeded to the door of the Chapter Room, and (Ulster bearing the insignia of the Order before them on a velvet cushion) conducted the Marquess of Downshire between them to the right of the Chair of State, where His Lordship made and subscribed the Declaration appointed by the Statutes; and His Excellency the Grand Master, assisted by the two Senior Knights Companions present, put the Ribbon with the Badge over the Marquess's right shoulder, pronouncing the admonition, after which the Marquess was congratulated by His Excellency and the Knights present, and took his seat at the table.

Ulster, Knight Attendant, then called over the names and titles of the Knights Companions present, who each rose from his seat on the pronunciation of his name, and retired with the usual reverences, whereupon the Chapter broke up.

At Edinburgh, the Fourth Day of May, Eighteen hundred and Fifty-nine years.

THE COMMISSIONERS appointed and acting under the Authority of an Act passed in the Twenty-first and Twenty-second Years of Her Majesty's Reign, Chapter Eighty-three, intituled, 'An Act to make Provision for the better Govern-ment and Discipline of the Universities of Scot-land, and improving and regulating the Course of Study therein; and for the Union of the Two Universities and Colleges of Aberdeen,'

Statute and Ordain as follows:—

*Primo*, That the Provisions of the said Act shall, as regards the University of Glasgow, come into Operation and receive Effect from and after the Fifteenth Day of October in this present Year.

And whereas, by the said Act, it is enacted, that from and after the Date, at which the said Act shall come into Operation in the said University of Glasgow, there shall be constituted therein a University Court, consisting of, among other Members, a Rector, to be elected by the Matriculated Students, voting by Nations as at present, subject to any Re-distribution of Nations or other Regulations to be made by the said Commissioners: And whereas, by the said Act, it is also enacted that there shall be in the said University a General Council, which shall assemble twice every Year, on such Days as may be fixed by the said Commissioners, subject to Alteration thereafter from Time to Time by Resolution of the said Council, with the Approval of the University Court: And whereas the said Commissioners are empowered by the said Act to make Rules for the Management and Ordering of the several Universities of Scotland, the Manner and Conditions in and under which Students shall be admitted thereto, and as to the Amount and Exaction of Fees therein, and also, subject to the Provisions of the said Act, to make Regulations as to Time, Place, and Manner of presenting and electing all University Officers:

The said Commissioners further Statute and Ordain:—

*Secundo*, That in the Election of Rector in the said University of Glasgow, the Matriculated Students shall vote, as at present, in Four Nations, the *Natio Glottiana*, the *Natio Transforthana*, the *Natio Rothseiana*, and the *Natio Loudoniana*; and, in case of an equal Number of Nations voting for Two or more Candidates, the Rector shall be chosen from among such Candidates by the Chancellor of the said University, who shall intimate his Choice personally, or by Letter addressed to the Senatus Academicus, within Twenty-one Days from the Day of Election, and failing such Intimation, then the Rector shall be chosen from among such Candidates by the Principal.

*Tertio*, That the Nations shall be constituted as follows:—

The *Natio Glottiana* shall consist of all Matriculated Students born within the County of Lanark:

The *Natio Transforthana* shall consist of all Matriculated Students born within any of the Counties of Orkney and Shetland, Caithness, Sutherland, Ross, Inverness, Cromarty, Moray,

*Nairn, Banff, Aberdeen, Perth, Forfar, Kincardine, Clackmannan, Fife, Kinross, Argyll, Stirling, and Dumbarton :*

The *Natio Rothseiana* shall consist of all Matriculated Students born within any of the Counties of *Bute, Renfrew, and Ayr :*

The *Natio Loudoniana* shall consist of all Matriculated Students not included in any of the other Nations.

*Quarto*, That the Senatus Academicus of the said University of *Glasgow* shall appoint one or more of their Number to preside and take the Votes in each Nation, and shall make such Arrangements for the assembling of the Nations, and the taking of the Votes of the Students, and otherwise for keeping Order at the Election, as may seem to them expedient.

*Quinto*, That from and after the Fifteenth Day of October in this present Year, there shall be, in the said University of *Glasgow*, One Matriculation only of each Student for each Session of Attendance ; and such Matriculation shall, like the Matriculation or Enrolment now in Use at the Library in the said University, be compulsory on all Students, and shall, for the Session in respect of which it takes Place, entitle Students to the Use of the Library and all the Privileges of Matriculated Students ; and the Matriculation Fee for the Winter Session shall be Ten Shillings, and for the Summer Session Five Shillings.

*Sexto*, That the Election of Rector by the Matriculated Students in the said University of *Glasgow* shall, in the present Year, and thereafter, so often as a Vacancy in the Office of Rector shall occur, take Place on the Fifteenth Day of November, except when the same shall be Sunday, in which Case the Election shall take Place on the following Day.

*Septimo*, That the Two Ordinary Meetings of the General Council of the said University of *Glasgow* shall, subject to such Alteration as by the said Act is provided, be held respectively on the Friday immediately preceding the Second Day of May and the Friday immediately preceding the First Tuesday of November in each Year.

*Tertio*, That the Senatus Academicus of the said University of *St Andrew's* shall appoint One or more of their Number to preside at the Election and take the Votes of the Students, and shall make such Arrangements for this Purpose, and for keeping Order at the Election, as may seem to them expedient.

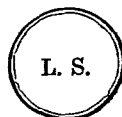
