ST JAMES'S PALACE, June 11, 1859.

This day the Right Honourable the Lord Mayor, the Aldermen, Recorder, Sheriffs, Common Council, and Officers of the City of London, waited upon Her Majesty with the following Address, which was read by Russell Gurney, Esq. the Recorder, and which Her Majesty was graciously pleased to receive upon the Throne:—

To The QUEEN'S Most Excellent Majesty.

Most Gracious Sovereign,

WE, your Majesty's dutiful and loyal subjects, the Lord Mayor, Aldermen, and Commons of the City of London, in Common Council assembled, approach the Throne with the strongest feelings of attachment to your Majesty's Person and Government.

We rejoice that under your Majesty's mild and happy rule this Nation enjoys the inestimable blessings of peace, and that your Majesty receives from Foreign Powers assurances of their desire to maintain with this Country the most friendly relaions.

It is however with deep sorrow that we have learned that war has been commenced on the Continent of Europe, and that some of its fairest provinces are likely to be the battle-fields of contending armies.

We desire to offer to your Majesty our hearty thanks for the assurance afforded by your Majesty's Royal Proclamation, that a strict and impartial Neutrality will be observed by this Country throughout the impending contest, and are anxious to express our decided conviction that a neutral policy, consistent with the security and honour of the Nation, will be conducive to the best interests of this Country, and calculated to promote the cause of humanity and peace.

We earnestly hope that an opportunity may speedily be afforded for your Majesty to again offer your friendly mediation between the hostile Powers, and thereby to restore to Europe the blessings of a general peace, consistent with the honour of your Majesty's Allies, and conducive to the happiness and independence of Nations.

To which Address Her Majesty was pleased to return the following most gracious answer :-

- "I thank you for your loyal and dutiful Address, and for the renewed assurances of your attachment to my Person and Government.
- "I have viewed with deep regret the war which has commenced on the Continent of Europe. It will be my earnest endeavour to maintain a strict neutrality between the contending Powers.
- "Confiding in the attachment of my People and the support of my Parliament, I shall adopt such measures as may enable me effectually to uphold the dignity of my Crown, and may afford to this Kingdom, under the blessing of Providence, the best assurance for the maintenance of peace."

They were all received very graciously, and the Lord Mayor and the Mover, and Seconder, had the honour of kissing Her Majesty's hand.

TREASURY WARRANT.

Whereas by an Act of Parliament passed in the fourth year of the reign of Her present Majesty, intituled "An Act for the regulation of the duties of postage," power is given to the Commissioners of Her Majesty's Treasury, from time to time, by Warrant under their hands, to alter and fix any of the rates of British postage alter and fix any of the rates of British postage payable by law on the transmission by the post of Foreign or Colonial letters or newspapers, or of any other printed papers, and to subject the same

to rates of postage according to the weight thereof, and a scale of weight to be contained in such Warrant.

And whereas further powers are given to the Commissioners of Her Majesty's Treasury by another Act of Parliament passed in the eleventh year of the reign of Her present Majesty, intituled "An Act for giving further facilities for the transmission of letters by post, and for the regulating the duties of postage thereon, and for other purposes relating to the Post-Office."

And whereas certain powers are also given to the Commissioners of Her Majesty's Treasury by another Act of Parliament passed in the eighteenth year of the reign of Her present Majesty, intituled "An Act to amend the laws relating to the stamp duties on newspapers, and to provide for the transmission by post of printed periodical publications."

And whereas a Treaty hath been lately entered into between Her Majesty and the King of Portugal and the Algarves, for regulating the communications by post between their respective dominions, and it is expedient, for the better carrying out of the same, that certain regulations should be made in the manner hereinafter mentioned.

Now we, the Commissioners of Her Majesty's Treasury, in exercise of the powers reserved to us in and by the said hereinbefore recited Acts, and every of them, and of all other powers enabling us in this behalf, do, by this Warrant, under the hands of two of us, the said Commissioners, by the authority of the Statute in that case made and provided, order, direct, and declare as follows:—

- 1. On every letter not exceeding one quarter of an ounce in weight, posted in the United Kingdom, addressed to Portugal, Madeira, the Azores, the Cape de Verd Islands, or any other Portuguese possessions on the coast of Africa, when conveyed direct by British packet-boat, there shall be charged, taken, and paid, a British rate of postage of four pence.
- 2. On every such letter, when conveyed viâ France and Spain, there shall be charged, taken, and paid, a combined British and Foreign rate of postage of sixpence.
- 3. On every letter not exceeding one quarter of an ounce in weight, posted in Portugal, Madeira, the Azores, the Cape de Verd Islands, or any other Portuguese possessions on the coast of Africa, addressed to the United Kingdom, when conveyed direct by British packet-boat, there shall be charged, taken, and paid, a British rate of postage of eightpence.
- 4. On every such letter, when conveyed viâ France and Spain, there shall be charged, taken, and paid, a combined British and Foreign rate of postage of sixpence.
- 5. All such letters so transmitted as hereinbefore in the first, second, third, and fourth clauses of this Warrant mentioned, if exceeding one quarter of an ounce in weight, shall be subject to the several further and additional and progressive rates of postage hereinafter mentioned; that is to say:—
 - On every letter so transmitted, if exceeding one quarter of an ounce in weight, and not exceeding one half of an ounce in weight, there shall be charged, taken, and paid, two rates of postage.

And on every letter so transmitted, if exceeding one half of an ounce, and not exceeding three quarters of an ounce in weight, three rates of postage.

And on every letter so transmitted, if exceeding three quarters of an ounce, and not exceeding one ounce in weight, four rates of postage.

And for every additional quarter of an ounce in weight of any letter so transmitted respectively as aforesaid, above the weight of one ounce, there shall be charged, taken, and paid, one additional rate of postage; and every fractional part of such additional quarter of an ounce in weight shall be charged as an additional quarter of an ounce in weight; and each progressive and additional rate chargeable under this clause shall be estimated and charged at the sum which any such letter would be charged with under this Warrant, if not exceeding one quarter of an ounce in weight.

6. On every letter not exceeding one half of an ounce in weight, posted in the United Kingdom, addressed to Portugal, Madeira, the Azores, the Cape de Verd Islands, or any other Portuguese possessions on the Coast of Africa, when conveyed by private ship, there shall be charged, taken, and paid, a British rate of postage of fourneence.

7. On every letter not exceeding one half of an ounce in weight posted in Portugal, Madeira, the Azores, the Cape de Verd Islands, or any other Portuguese possessions on the Coast of Africa, addressed to the United Kingdom, when conveyed by private ship, there shall be charged, taken, and paid, a British rate of postage of eightpence.

8. All such respective letters so transmitted as hereinbefore, in the 6th and 7th clauses of this Warrant mentioned, if exceeding one half of an onnce in weight, shall be subject to the several further and additional progressive rates of postage hereinafter-mentioned; that is to say:—

On every letter so transmitted, if exceeding one half of an ounce in weight, and not exceeding one ounce in weight, there shall be charged, taken, and paid, two rates of postage.

And on every letter so transmitted, if exceeding one ounce, and not exceeding two ounces in weight, four rates of postage.

And on every letter so transmitted, if exceeding two ounces, and not exceeding three ounces in weight, six rates of postage.

And for every additional ounce in weight of any letter so transmitted above the weight of three ounces, there shall be charged, taken, and paid, two additional rates of postage, and every fractional part of such additional ounce in weight, shall be charged as an additional ounce in weight, and each progressive and additional rate chargeable under this clause, shall be estimated and charged at the sum which any such letter would be charged with under this Warrant, if not exceeding one half of an ounce in weight.

9. The postage of every letter posted in the United Kingdom, under the provisions of this Warrant, shall be paid at the time of the letter being posted, and if any letter shall be posted in the United Kingdom without any postage being paid thereon, or with a postage paid thereon less in amount than one rate of postage payable thereon under this Warrant, every such letter shall and may be detained and opened, and shall be returned or given up to the sender thereof, and if any letter shall be posted in the United Kingdom with a postage paid thereon less in amount than the full amount of postage payable thereon, but equal in amount to one rate of postage payable thereon under this Warrant, every such letter shall and may be forwarded, charged with the difference
