THE following Addresses to the Queen, on the occasion of the assumption of the direct government of India by Her Majesty, having been transmitted to the Right Honourable the Secretary of State for India, have accordingly been presented by him to Her Majesty, who has been pleased to secret the same very graciously:—

To Her Most Excellent Majesty The Queen, &c., &c., &c.

May it please your Majesty,

As the descendant of one of the oldest reigning Princes in India, and a faithful ally of the British Government, I beg leave, in my own name, and in the names of my nephews in succession, respectfully, and with every sentiment of sincerity, devotion, and loyal attachment, to congratulate your Majesty upon your assumption of the royal prerogative over the territories of this vast Empire.

I feel assured that the future government of this country will be stamped with those high and refined principles of impartiality, liberality, and justice, which have ever adorned the British Crown; and it shall always be my pride and ruling passion not early to religiously conform to the articles of the treaty entered into with the Honourable East India Company, your Majesty's late trustees for the government of India, but to the utmost of my power to uphold the dignity and supremacy of the British Throne, and faithfully to inculcate the same sentiments of regard and respect which I entertain for your Majesty's person and government into the uninds of all my native subjects, assuring them in return of your Majesty's gracious protection.

I beg leave humbly to convey to your Majesty the expression of my deep and lively appreciation of your Majesty's kind and benevolent sentiments in respect to the dignity and honour of the native Princes of India, as well as your Majesty's gracious resolution to permit no aggression to be made upon them, but to secure them in the enjoyment of their ancient rights, usages, and customs. Whilst acknowledging with heartfelt gratitude the justice and liberality of these intentions, I beg to express my firm confidence that my sovereign rights and privileges could not be in better keeping than in your royal lands, and that, under your Majesty's wise and enlightened sway, they will be scrupulously recognised.

I beg, at the same time, to represent my deepconviction that in your Majesty's rule over these territories will be found the surest guarantee for that prosperity and social advancement which your Majesty is so anxious to promote amongst all classes of your Majesty's Indian subjects.

It is my earnest hope that the benevolent and merciful call, contained in your Majesty's Proclamation, may have the immediate and happy effect of restoring peace and tranquillity in the disturbed provinces of the north-west, and of leading back those misguided chiefs and their followers to a dutiful submission to your Majesty's rule, which cannot fail to ensure their future contentment and happiness.

And lastly, we most humbly beseech your Majesty's permission to join your Majesty in prayer to Almighty God that, by vouchsafing strength and knowledge to all, He may enable your Majesty, and your Majesty's heirs and successors to fulfil and realize the gracious intentions of your Majesty, as contained in your Majesty's most gracious Proclamation aforesaid.

Her Majesty, upon a representation of the Right Honourable the Lords of the Committee of Council on Education, was this day pleased to appoint the Reverend Charles James Robinson, M.A., Curate of Hatfield, in the county of Hertford, to be one of Her Majesty's Assistant InWAR-OFFICE, 6th July 1859.

The Queen having been graciously pleased, by a Warrant under Her Royal Sign Manual, hearing date the 13th of December 1858, to declare that Non-Military Persons who, as Volunteers, have borne arms against the Mutineers, both at Lucknow and elsewhere, during the late operations in India, shall be considered as eligible to receive the Decoration of the Victoria Cross, subject to the rules and ordinances already made and ordained for the government thereof, provided that it be established in any case that the person was serving under the orders of a General, or other Officer in Command of Troops in the Field, when he performed the Act of Bravery for which it is proposed to confer the Decoration;—Her Majesty has accordingly been pleased to signify Her intention to confer this high distinction on the undermentioned Gentlemen, whose claims to the same have been submitted for Her Majesty's approval, on account of Acts of Bravery performed by them in India, as recorded against their names; viz .-

On the 8th of November 1857, Mr Kavanagh, then serving under the orders of Lieutenant-General Sir James Outram, in Lucknow, volunteered on the dangerous duty of proceeding through the City to the Camp of the Commander-in-Chief, for the purpose of guiding the relieving Force to the beleaguered Garrison in the Residency,—a task which he performed with chivalrous gallantry and devotion.

Mr Mangles volunteered and served with the Force consisting of detachments of Her Majesty's 10th and 37th Regiments, and some Native Troops, despatched to the relief of Arrah in July 1857, under the command of Captain Dunbar, of the 10th Regiment. The force fell into an Ambuscade on the night of the 29th of July 1857, and during the retreat on the next morning, Mr Mangles, with signal gallantry and generous self-devotion, and notwithstanding that he had himself been previously wounded, carried for several miles, out of action, a wounded soldier of Her Majesty's 37th Regiment, after binding up his wounds under a murderous fire, which killed or wounded almost the whole detachment; and he bore him in safety to the

Now therefore, Her Majesty, in exercise of the powers vested in her in that behalf by the said Act, by and with the advice of Her Privy Council, is pleased to direct, that on and after the first day of August next there shall be paid, in respect of the mid lighthouse at Douglas Head aforesaid, for every British vessel, and for every Foreign vessel privileged to enter the ports of the United Kingdom, upon paying the same duties as are payable by British vessels which may pass or derive benefit from such light, the toll of eightsixteenths of a penny per ton of the burthen of every such vessel, for every time of passing or deriving benefit therefrom, if on an oversea voyage, and one-sixteenth of a penny per ton for each time of passing or deriving benefit therefrom if on a coasting voyage; and for every Foreign vessel, not privileged in manner hereinbefore mentioned, double the amount of the respective tolls hereinbefore specified, according to the voyage on which she may be employed; and that the said tolls, in respect of the said lighthouse, shall be levied by the Commissioners of Northern Lighthouses, subject to the gross abatement or discount of fifty per cent. on vessels engaged in oversea voyages, and of thirty-five per cent. on vessels engaged in coasting voyages, mentioned in an Order in Council made under the authority of the said recited Act, and dated the second day of February one thousand eight hundred and fifty-nine, and subject also to the regulations and exemptions contained in the Consolidated Tables of Light Duties, sanctioned by an Order in Council dated the twenty-sixth day of June one thousand eight hundred and fifty-five, and to the further exemption sanctioned by an Order in Council dated the twelfth day of April one thousand eight hundred and fifty-nine.

#### TREASURY WARRANT.

WEEREAS by an Act of Parliament passed in the fourth year of the roign of Her present Majesty, intituled "An Act for the regulation of the duties of postage," certain scales of weight and rates of postage were fixed, and were made chargeable and payable upon, for, and in respect of letters, newspapers, Parliamentary proceedings, and printed papers, transmitted and forwarded by the post, and various regulations were ade for facilitating the transmission of such letters and papers by the post; and by the same Act power was given to the Postmaster-General to charge such higher rates of postage on certain letters, newspapers, and other printed papers therein mentioned, as the Commissioners of Her Majesty's Treasury, by Warrant under their hands, should from time to time deem expedient, and also to remit any of the rates of British postage or inhand postage for the time being payable by law on the transmission of post letters, newspapers, or other printed papers, to such extent as the Lords of the Treasury should from time to time direct. And by the same Act power was also given to the Commissioners of Her Majesty's Treasury, from time to time, by Warrant under their hands, to alter and fix any of the rates of British postage or inland postage payable by law on the transmission by the post of Foreign or Colonial letters or newspapers, or of any other printed papers, and to subject the same to rates of postage according to the weight thereof, and a scale of weight to be contained in such Warrant; and from time to time, by Warrant as aforesaid, to alter or repeal any of such altered rates, and make and establish any new or other rates in lieu

And whereas by an Act of Parliament passed in the eighth year of the reign of Her present Majesty, intituled "An Act for the better regulation of Colonial posts," power is also given to the Commissioners of Her Majesty's Treasury, by Warrant under their hands, to alter and fix any of the rates of Colonial postage payable by law for the transmission of letters by the post, and to subject the same to rates of postage according to the weight thereof, and a scale of weight to be contained in such Warrant, and from time to time, by Warrant as aforesaid, to alter or repeal any of such altered rates, and make and establish any new or other rates in lieu thereof.

And whereas further powers are given to the Commissioners of Her Majesty's Treasury, by another Act of Parliament passed in the eleventh year of the reign of Her present Majesty, intituled "An Act for giving further facilities for the transmission of letters by post, and for the regulating the duties of postage thereon, and for other purposes relating to the Post-office."

And whereas certain powers are also given to the Commissioners of Her Majesty's Treasury, by another Act of Parliament passed in the eighteenth year of the reign of Her present Majesty, intituled "An Act to amend the laws relating to the stamp duties on newspapers, and to provide for the transmission by post of printed periodical publications."

And whereas the Commissioners of Her Majorty's Treasury, in exercise of the powers reserved to them in and by the said several before recited Acts, some or one of them, and of all other powers canabing them in that behalf, have, from time to time, by divers Warrants in writing, under their hands duly made, bearing date respectively, at Whiteball, Treasury-Chambers, the 21st day of July 1857, the 2d day of September 1857, the 16th

day of October 1857, the 13th day of April 1858, the 15th day of June 1858, the 19th day of June 1858, and the 3d day of December 1858, made and issued certain regulations, orders, directions and conditions relating to the rates of postage, and the mode and time of payment thereof, and to the weight, size, and dimensions, and the mode and time of sending, under and subject to, and in conformity with which, the several packets consisting of books, publications, or works of literature or art, and the several other packets therein, or in some or one of the said Warrants respectively mentioned, may respectively be transmitted by the post.

And whereas in and by the said recited Warrants, some or one of them, provision is made that where packets transmitted by the post, under the authority of the said respective Warrants, shall not be transmitted in conformity with, and under and subject to the regulations, orders, directions, and conditions therein, or in some or one of them respectively mentioned and contained, such packets shall, in certain cases, be chargeable with certain letter rates of postage therein, or in some or one of the said Warrants respectively mentioned; and it is expedient in all such cases that power should be given to the Postmaster-General to charge such packets with a less amount of postage than such respective letter-rates of postage, in the manner hereafter mentioned.

Now we, the Commissioners of Her Majesty's Treasury, in exercise of the powers reserved to us in and by the said several hereinbefore recited Acts, any or either of them, and of all other powers enabling us in this behalf, do, by this Warraut, under the hands of two of us, the said Commissioners, (by the authority of the Statute in that case made and provided,) order, direct, and declare as follows:—

1.
