The QUEEN'S Most Excellent Majesty in Council.

THEREAS by an Order in Council, bearing V date the 6th day of June last, made under the provisions of the "Burial Grounds (Scotland) Act, 1855," it was ordered that from and after the 15th day of the said month of June, Burials should be Discontinued in the Burial-Ground entering from Nicholson Street, Greenock, commonly called the West Church-Yard, except in certain Family Vaults and Burial-Places in the said Order set forth :

And whereas it has been represented to Her Majesty that certain other Family Burial-Places may be in part excepted from the operation of the said Order.

Now therefore, Her Majesty, by and with the advice of Her Privy Council, is pleased to order, and it is hereby ordered, that the following Family Burial-Places in the Burial-Ground entering from Nicholson Street, Greenock, commonly called the West Church-Yard, be excepted from the operation of the said Order in Council of the 6th of June last, but so far only as regards the persons hereinafter mentioned ; viz. :-

The Family Burial-Place of the late William Hyndman, Hammerman, for the interment therein, when necessary, of the Remains of Mrs Mary Smith;

The Family Burial-Place of the late William Brown, for the interment therein, when neces-sary, of the Remains of Robert Brown, Sea-man, and of Margaret Brown, both of No. 7, Nicholson Street, in Greenock;

The Family Burial-Place of Peter M'Callum, of No. 1, West Stewart Street, Greenock, for the interment therein, when necessary, of the Remains of himself, and of his two sisters, Elizabeth and Janet M'Callum ;—and

The Family Burial-Place of Duncan Brown, of Cathcart Street, Greenock, for the interment therein, when necessary, of his Remains.
