ORDINANCE, SCOTTISH UNIVERSITIES COMMISSION.
No. 8.

Edinburgh, No. 3. At Edinburgh, the Nineteenth Day of March, Eighteen Hundred and Sixty Years.

WHEREAS, by an Act passed in the Twenty-first and Twenty-second Years of Her Majesty's Reign, Chapter Eighty-three, intituled, 'An Act to make Provision for the better Govern-' ment and Discipline of the Universities of Scotland, 'and improving and regulating the Course of Study 'therein; and for the Union of the Two Univer-'sities and Colleges of Aberdeen,' the Commis-sioners for the Purposes of the said Act are empowered amongst other Things to make Rules as to the granting of Degrees, whether in Arts, Divinity, Law, or Medicine, in the several Universities of Scotland; And Whereas, on the Sixth Day of August in the Year Eighteen hundred and Fiftynine, the Commissioners made and published an Ordinance with reference to the granting of Degrees in Medicine in the University of Edinburgh; AND Whereas it is expedient that further Regulations should be made with reference to the granting of such Degrees: The Commissioners statute and ordain, with regard to the University of Edinburgh,

Primo, That the Degrees in Medicine, to be hereafter granted by the University of Edinburgh, shall be divided into three Classes, and be designated respectively, Bachelor of Medicine (M.B.), Master in Surgery (C.M.), and Doctor of Medicine (M.D.).

Secundo, That the Regulations contained in the said Ordinance of the Sixth Day of August Eighteen hundred and Fifty-nine shall be applicable to the granting of the Degrees of Bachelor of Medicine and Master in Surgery: Provided always, that the Degree of Master in Surgery shall not be conferred on any Person, who does not also at the same time obtain the Degree of Bachelor of Medicine.

Tertio, That the Regulation, contained in Section III. of the said Ordinance of the Sixth Day of August Eighteen hundred and Fifty-nine, shall extend to a Degree in Arts conferred by any Colonial or Foreign University, which may, for this Purpose, be specially recognised by the University Court.

Quarto, That the Degree of Doctor of Medicine may be conferred on any Candidate, who has obtained the Degree of Bachelor of Medicine, and is of the Age of Twenty-four Years, and has been

engaged, subsequently to his having obtained the Degree of Bachelor of Medicine, for at least two Years in Attendance on an Hospital, or in the Military or Naval Medical Service, or in Medical and Surgical Practice: Provided always, that the Degree of Doctor of Medicine shall not be conferred on any Person, unless he be a Graduate in Arts of one of the Universities of England, Scotland, or Ireland, or of such other Universities as are above specified, or unless he shall, before or at the Time of his obtaining the Degree of Bachelor of Medicine, or within three Years thereafter, have passed a satisfactory Examination in Greek, and in Logic or Moral Philosophy, and in One at least of the following Subjects, namely, French, German, Higher Mathematics, and Natural Philosophy.

Quinto, That the Medical Examiners for all Candidates for Graduation in Medicine in the said University shall be the Professors in the Faculty of Medicine therein, and, in addition, three Persons to be appointed annually by the University Court, who shall be selected from among the Fellows of the three following Bodies, namely, the Royal College of Physicians of Edinburgh, the Royal College of Surgeons of Edinburgh, and the Faculty of Physicians and Surgeons of Glasgow, or shall be Persons otherwise fully qualified in the Judgment of the University Court; such three Persons to be eligible for Re-election, and each of them to receive a Sum of One hundred Pounds for each Year, in which he shall act as Examiner.

Sexto, That the Studies of Candidates for the Degrees of Bachelor of Medicine and Master in Surgery shall be subject to the following Regulations:—

- (1.) One of the Four Years of Medical and Sargical Study, required by the said Ordinance of the Sixth day of August Eighteen hundred and Fifty-nine, must be in the University of Edinburgh.
- (2.) Another of such Four Years of Medical and Surgical Study must be either in the University of *Edinburgh*, or in some other University entitled to give the Degree of Doctor of Medicine.

(3.) Attendance during at least Six White Months on the Medical or Surgical fractice of a General Hospital, which modates at least Eighty Patients, and Curthe same Period, on a Course of Ladical

- Anatomy, may be reckoned as One of such Four Years, and to that Extent shall be held equivalent to One Year's Attendance on Courses of Lectures, as prescribed by the said Ordinance.
- (4.) One Year's Attendance on the Lectures of Teachers of Medicine in the Hospital Schools of London, or in the School of the College of Surgeons in Dublin, or of such Teachers of Medicine in Edinburgh, or elsewhere, as shall from Time to Time be recognised by the University Court, may be reckoned as One of such Four Years, and to that Extent shall be held as Attendance on Courses of Lectures, as prescribed by the said Ordinance.
- (5.) Candidates may, to the Extent of Four of the Departments of Medical Study required by Section V. Sub-section 1 of the said Ordinance, attend in such Year or Years of their Medical and Surgical Studies, as may be most convenient to them, the Lectures of the Teachers of Medicine specified in Subsection (4.)
- ·(6.) All Candidates, not Students of the University, availing themselves of the Permission to attend the Lectures of Extra-Academical Teachers in Edinburgh must, at the commencement of each Year of such Attendance, enrol their Names in a Book to be kept by the University for that purpose, paying a Fee of the same Amount as the Matriculation Fee paid by Students of the University, and having, in respect of such Payment, a Right to the Use of the Library of the University.
- (7.) The Fee for Attendance on the Lectures of an Extra-Academical Teacher in Edinburgh, with a view to Graduation, shall be of the same Amount as that exigible by Medical Professors in the University.

- (8.) No Teacher shall be recognised, who is at the same time a Teacher of more than One of the prescribed Branches of Study, except in those Cases, where Professors in the University are at liberty to teach Two Branches.
- (9.) It shall not be necessary for any Teacher, Attendance on whose Lectures is now recognised for the Purposes of Graduation in the University, to obtain a new Recognition from the University Court; and Attendance on the Lectures of every such Teacher shall continue to be recognised as heretofore.
- (10.) It shall be in the Power of the University Court, if they shall see Cause, at any time to withdraw or suspend the Recognition of any Teacher or Teachers.

Septimo, That the Provisions of the said Ordinance of the Sixth Day of August Eighteen hundred and Fifty-nine, and of this Ordinance, shall come into Operation and receive Effect from and after the Fifteenth Day of October in the present Year.

Octavo, That Persons, who shall have begun their Medical Studies before the Fifteenth Day of October in the present Year, shall be entitled to graduate under the System in force before or after that Date, according as they shall comply with the Regulations in force in the University before or after that

TO BE OBSERVED WITH REGARD TO THE QUEEN'S DRAWING-ROOMS AT ST JAMES'S PALACE.

By Her Majesty's Command.

The Ladies who propose to attend Her Majesty's Drawing-Rooms at St James's Palace are requested to bring with them two large cards, with their names clearly written thereon, one to be left with The Queen's Page in Attendance in the Corridor, and the other to be delivered to the Lord Chamberlain, who will announce the name to The Queen.

PRESENTATIONS.

Any Lady who proposes to be presented to The Queen, must leave at the Lord Chamberlain's

Office, before twelve o'clock, two clear days before the Drawing-Room, a card with her name written thereon, and with the name of the Lady by whom she is to be presented. In order to carry out the existing Regulation that no presentation can be made at a Drawing-Room excepting by a Lady actually attending that Court, it is also necessary that a letter from the Lady who is to make the presentation, stating it to be her intention to be present, should accompany the presentation card above referred to, which will be submitted to The Queen for Her Majesty's approbation. It is Her Majesty's Command that no presentations shall be made at the Drawing-Rooms except in accordance with the above Regulations.

No Presentations will take place at the Drawing-Room on the 18th of May next.

It is particularly requested that in every case the names be very distinctly written upon the cards to be delivered to the Lord Chamberlain, in order that there may be no difficulty in announcing them to The Queen.

The Secretary of State for India in Council has received the following Despatch:—

The Secretary to the Government of India with the Governor-General, to the Military Secretary to the Government of the Punjab.

SIR.

Camp, Daviepoora, February 10, 1860.

Having submitted to his Excellency the Governor-General your letter, No. 9, dated the 6th instant, forwarding a detailed report of the operations against the Wuzeerees by Brigadier-General Chamberlain, C.B., I am directed to state that his Excellency entirely concurs with the Honourable the Lieutenant-Governor in the cordial approbation expressed by his Honour of the service rendered by Brigadier-General Chamberlain, and in his appreciation of the valuable results of that service.

The Governor-General directs me to request that the Lieutenant-Governor will have the goodness to convey to Brigadier-General Chamberlain his best thanks for the promptitude and success with which these important operations have been conducted. On the 15th of December last, the force commanded by that officer marched from Kohat; and on the 14th of January it returned to that station, having, in the short period of one month, exacted reparation from the Kabyl Khail Wuzeerees for the support and shelter given by them to the murderers of the late Captain Mecham; and having, while effecting that object, exhibited to the tribes of the districts through which he marched, not only the power of the Government to reach and punish those amongst them who are guilty of offence, but its careful forbearance towards all others.

I am directed to request that the Governor-General's thanks may be particularly conveyed to all the officers* mentioned by Brigadier-General Chamberlain; and, generally, to the force which was under his command.

The Governor-General attaches great value to the survey of the districts through which General Chamberlain murched.

The conduct of Captain James, Commissioner of Peshawur, and of Captain Henderson, Deputy Commissioner of Kohat, in co-operation with Brigadier-General Chamberlain, will be duly acknowledged by the Governor-General in the Foreign Department.

TREASURY WARRANT.

WHEREAS by an Act of Parliament passed in the fourth year of the reign of Her Majesty for the regulation of the duties of postage, certain scales of weight and rates of postage were fixed, and were made chargeable and payable upon, for, and in respect of letters, newspapers, Parliamentary proceedings, and printed papers transmitted and forwarded by the post, and various regulations were made for facilitating the transmission of such letters and papers by the post. And by the said Act power was given to the Commissioners of Her Majesty's Treasury, (amongst other things,) from time to time, by Warrant under their hands, to alter and fix any of the rates of British postage payable by law on the transmission by the post of Foreign or Colonial letters or newspapers, or of any other printed papers, and to subject the same to rates of postage, according to the weight thereof, and a scale of weight to be contained in such Warrant, and from time to time, by Warrant as aforesaid, to alter or repeal any of such altered rates, and make and establish any new or other rates in lieu thereof, and from time to time, by Warrant as afore-said, to appoint at what time the rates which might be payable were to be paid.

And whereas the provision fixing the maximum weight of letters to be sent by the post in the said before recited Act was repealed, and further powers were given to the Commissioners of Her Majesty's Treasury in that behalf by another Act of Parliament passed in the eleventh year of the reign of Her Majesty, for giving further facilities for the transmission of letters by post, and for the regulating the duties of postage thereon, and for other purposes relating to the Post-Office.

And whereas it is expedient that regulations should be made for the transmission by the post of packets consisting of books, publications, or works of literature and art, and other paners, between the United Kingdom and burgh, in the Kingdom of Sweden, in the man hereinafter mentioned and contained.

Now we, the Commissioners of Her pie Treasury, in exercise of the powers verilin and by the said before-mentioned two either of them, and of all other powers enably us in this behalf, do, by this Warrant, under t hands of two of us, the said Commissioners, (by the authority of the Statute in that case made and provided,) order, direct, and declare as follows:—

1. All packets consisting of books, publications, or works of literature or art, whether British, Colonial, or Foreign, and all packets consisting of printed votes and proceedings of the Imperial Parliament, posted in the United Kingdom addressed to Gothenburgh, or posted at Gothenburgh addressed to the United Kingdom, may be transmitted by the post between the United Kingdom and Gothenburgh (the sea conveyance being by British or Foreign packet-boat direct). And all such respective packets shall be transmitted in conformity with, and under and subject to the several regulations, orders, directious, and conditions hereinafter mentioned and contained; and the single rate of postage for the transmission of such packets shall be the sum of three pence. And all such respective packets, so transmitted and chargeable with postage as aforesaid, shall be subject to the several progressive and additional rates of postage hereinafter mentioned; that is to say :-

On every such packet, if not exceeding four ounces in weight, there shall be charged, taken, and paid, for the transmission thereof, respectively as aforesaid, the uniform single

rate of postage of three pence.

And on every such packet, exceeding four ounces in weight, there shall be charged, taken, and paid progressive and additional rates of postage as follows (that is to say):—

On every such packet, if exceeding four ounces in weight and not exceeding eight ounces in weight, two rates of postage.

And on every such packet, if exceeding eight ounces and not exceeding one pound in weight, four rates of postage.

And on every such packet, if exceeding one pound and not exceeding one pound and one-half of another pound in weight, six rates of postage.

And for every additional half of a pound in weight of any such packet above the weight of one pound and one half of another pound in weight there shall be charged, taken, and paid two additional rates of postage; and every fractional part of such additional half of a pound in weight shall be charged as an additional half of a pound in weight. And each progressive and additional rate chargeable under this clause shall be estimated and charged at the sum which any such packet would be charged with under this Warrant if not exceeding four ounces in weight.

No such packet which, in length, or breadth, or width, shall exceed the dimensions of two feet, shall be forwarded by the post under the

provisions of this Warrant.

The terms "books, publications, or works of literature or art," in this Warrant used, shall, for the purposes of this Warrant, mean and comprise all such articles as in their general character are either literary, or consist of printed, written, engraved or lithographed matter (although not strictly literary), including books (whether printed, written, or plain); publications or compilations (whether in print or in manuscript); almanacks, printed or lithographed; letters, and such artistic productions as prints, maps (whether on paper, or canvas, or cloth, and whether printed or written); and photographs, when not on glass, or in frames containing glass; and any description of paper, parchment, or vellum (whether printed, lithographed, written upon,

or plain, or any mixture of the four); together with any binding, mounting, or covering of or upon, or belonging to any such article or production, or any portion thereof, or of or belonging to any paper, parchment, or vellum; and including also any cases or rollers of prints or maps, book markers (whether of paper or otherwise); pencils, pens, or other things usually appertaining to any such article or production, paper, parchment, or vellum, or necessary for its safe transmission, which shall be sent in the same packet with any such article or production to which they or it shall belong. And all letters, notices, and other communications, whether upon paper, parchment, or vellum, partly printed, or partly lithographed, and partly written, which, if wholly written, would not be considered letters, or communications in the nature of letters, may be transmitted by the post under the provisions of this Warrant; but any letter, notice, or other communication (whether upon paper, parchment, or vellum), partly printed, or partly lithographed and partly written, which, if wholly written, would be considered a letter or a communication in the nature of a letter, shall not be entitled to the privilege of being transmitted by the post under the provisions of this Warrant: Provided that nothing herein contained shall extend to authorize the sending by the post, under the provisions of this Warrant, of any patterns, or books of patterns, or papers of patterns, of any article or thing whatsoever, unless such patterns shall consist merely of paper.

Every packet transmitted by the post under the

Every packet transmitted by the post under the authority of this Warrant shall be sent open at the ends or sides, and either without a cover, or in a cover or envelope open at the

ends or sides.

No packet transmitted by the post under the authority of this Warrant shall contain any written letter, either closed or open, nor any written communication in the nature of a letter, either closed or open (whether such letter or communication be addressed to, or intended for the person to whom the packet shall be directed or any other person), nor any enclosure sealed, or otherwise closed against inspection, nor any other enclosure not authorized by this Warrant, sent in or with any such packet, nor shall there be any written letter, or written communication in the nature of a letter, in or upon any such packet, or on the cover or envelope thereof.

Every packet transmitted by the post under the authority of this Warrant, and posted in the United Kingdom, shall be put into the Postoffice at such hours in the day, and under all such regulations as the Postmaster-General

If any packet sent, or tendered, or delivered in order to be sent by the post, under the authority of this Warrant, shall in length, or breadth, or width, exceed the dimensions of two feet, or if any such packet, or the cover or envelope thereof shall not be open at the ends or sides, or if any such packet shall be sent otherwise than in conformity with the terms, conditions, and regulations hereinbefore contained, every such packet shall and may be detained and opened, and, at the option of the Postmaster-General, shall be either returned or given up to the sender thereof; and every such packet on being so returned or given up shall, at the option of the Postmaster-General, be either free of postage, or be charged with any rate of postage he may think fit, not exceeding the postage to which it would have been liable as a letter.
- 5. If any packet sent, or tendered, or delivered in order to be sent by the post, under the authority of this Warrant from the United Kingdom to Gothenburgh (any such packet posted in London, and sent from any department or office in or connected with the public service of Her Majesty, which shall keep a postage-account with the General Post-office in London, and the postage thereof being charged in such account, only excepted), shall be posted in the United Kingdom, without any postage being paid thereon, or with a postage paid thereon less in amount than the rate of postage to which such packet shall be liable under and by virtue of the regulations hereinbefore contained, every such packet shall be detained and opened, and, at the option of the Postmaster-General, shall be dealt with and chargeable in like manner as is hereinbefore directed with respect to any packet not open at the ends or sides, or which may exceed in length, or breadth, or width, the dimensions of two feet.
- 6. All packets transmitted by the post, under the provisions of this Warrant, shall be subject to the several orders, directions, regulations, and rates of postage respectively contained in a certain Warrant of the Commissioners of Her Majesty's Treasury, under the hands of two of the said Commissioners, bearing date the 19th day of February 1855, relating to re-directed rates of postage upon packets which shall be re-directed and again forwarded by the post.
- 7. The rates of postage chargeable on packets transmitted by the post under the authority of this Warrant shall be in lieu of any rates of British postage now chargeable by law thereon.
- 8. The several terms and expressions used in this Warrant shall be construed to have the like meaning, in all respects, as they would have had if inserted in the said Act passed in the fourth year of the reign of Her Majesty.
- 9. The Commissioners for the time being of Her Majesty's Treasury may, by Warrant under their hands, duly made, at any time hereafter alter, repeal, or revoke any of the rates of postage hereby fixed or altered, or any of the orders, directions, regulations, or conditions hereby made, and may make and establish any new or other rates, orders, directions, regulations, or conditions in lieu thereof, and from time to time may appoint at what time the rates which may be payable are to be paid.

(No. 9.)—North Atlantic.—Coast of Spain.

Fixed Light on Isla Mouro.

THE Minister of Marine at Madrid has given Notice, that on and after the 15th day of February 1860, a light would be exhibited from the light-tower recently erected on Mouro Islet, at the entrance of the Port of Santander, on the southern shore of the Bay of Biscay, north coast of Spain.

The light is a fixed white light, illuminating an arc of 270° of the horizon, or from S. by W. to W. by N.; through the remainder of the circle a faint light will be seen when beyond the distance of $4\frac{1}{2}$ cables' lengths from the lighthouse. The light is elevated 141 feet above the level of high water, and should be seen in clear weather from a distance of 12 miles.

The illuminating apparatus is catoptric, or by reflectors of the fifth order.

The light-tower is slightly conical, 56 feet high from base to upper balcony, and stands 14 yards from the north shore of the islet. It rises from the centre of the lightkeeper's dwelling, which is circular, and both are built of white stone; the windows and top of lanterns are painted green, and upper balcony red. The dwelling will be hid by the rocks off the islet when approaching it from the north-east. The position of the light-tower is given as lat. 43° 28′ 37″ N., long. 3° 45′ 43″ West of Greenwich.

A rock, called the Corbera, and a bank of 3 feet water, lie respectively S.E. by E. $\frac{1}{2}$ E. 112 fathoms, and W. by S. 140 fathoms from the lighthouse.

Alteration of Lights in the Kalbaden-Grund and Revel-Stein Light Vessels.

THE Imperial Ministry of Marine of Russia has given notice that during the navigation of the Gulf of Finland, in the year 1860, the following alterations will be made in the lighting the Kalbadengrund and Revel-stein light vessels, the former lying 14 miles to the south-west of Glosholm, on the north shore of the Gulf, and the latter off Revel, on the south shore.

The light vessel, which will be placed off the south side of the Kalbaden-grund, instead of the red light will exhibit a fixed white light on her mainmast, and a ball at the mast head.

The light vessel which will be placed off the north side of the Revel-stein, instead of three lights will exhibit only two fixed white lights, one on her fore and the other on her mizen mast; and a ball at the fore and mizen mast heads.

Lebiadnikova Shoal, lying 71 miles to the westward of the north point of Hogland, and hitherto distinguished by a flag, will for the future be marked by a beacon having six streaks, three coloured white and three red, and with a double broom at the side, in order to distinguish it from the Hogland Shoal which lies N.N.W. \frac{3}{4} W. 2 miles from the north point of Hogland, and is marked by a flag.

The bank of 5 fathoms, discovered in 1859, lying 9 miles to the eastward of Ekholm and 1½ miles N. 42 W. (true) from the white flag on the north part of the Kalk-grund, will in future be marked by a black instead of a white buoy.

Namsi Bank.-For the convenience of vessels navigating the eastern part of the entrance to Narva Bay, between the New Ground and the Namsi Bank, the 5 feet water on the Namsi Bank will in future be marked by a black buoy.

Harbour Lights at Revel.

Judge Bergs' house, (the only flat roof building above the town of Charlotte Amalia, on the second hill from the west,) kept well open to the west-ward of Möhlenfels point, or Contant Mill in line with Cowell Point, will lead to the westward of this danger; but a vessel of large draught on nearing the port from the eastward should keep East Gregerie channel well open until the west point of Water Battery is in one with the east end of the northern church, bearing N. by W. 1 W., which is the fairway leading mark into the harbour.
