THE Queen has been pleased to approve of Md. André Jean Baptiste Villamus as Consul-General at Malta for His Majesty the Emperor of the French.

WHITEHALL, March 28, 1861.

The Queen has been pleased to grant unto John Perry Oldershaw, of Pembridge Villas, in the parish of St Mary Abbots, Kensington, in the county of Middlesex, Gentleman, and unto Harriet Hannah, his wife, only child and heir of Richard Errington, late of Errington, in the county of Northumberland, Esquire, deceased, by Harriott, his wife, youngest daughter and co-heir of Thomas Loveland, late of Park Place, in the Parish of St Mary, Islington, in the said County of Middlesex, Esquire, also deceased, Her Royal licence and authority that they may, in compliance with a direction contained in a codicil to the last will and testament of their aunt, Mary Ann Loveland, late of Park Place aforesaid, Spinster, deceased, take and henceforth use the surname of Loveland, instead of that of Oldershaw, and that the said John Perry Oldershaw may bear the arms of Loveland quarterly with those of Oldershaw, and that such surname and arms may in like manner be taken, used, and borne by their issue; such arms being first duly exemplified according to the laws of arms, and recorded in the Heralds' Office, otherwise Her Majesty's said Royal licence and permission to be void and of none effect:—

And also to command that the said Royal concession and declaration be recorded in Her Majesty's College of Arms.
