The QUEEN's Most Excellent Majesty in Council.

WHEREAS the rules and practice observed for preventing collisions at sea, which were formerly adopted by Maritime Nations, have proved insufficient to satisfy the requirements of modern navigation; and whereas various alterations in such rules and practice have from time to time been made by different Nations, but the rules so altered have been found to be in some cases inconsistent with each other, and in other cases to have the force of municipal law only; and whereas, in consequence of communications from the Government of the Emperor of the French inviting Her Majesty's Government to consider the expediency of making the said rules uniform and international, Her Majesty's Government prepared a project of regulations for preventing collisions at sea, and submitted it to the Government of the Enperor of the French; and the project so prepared by Her Majesty's Government was approved by the Government of the Emperor of the French with certain modifications, which were assented to by Her Majesty's Government; and whereas the said regulations so modified have been sanctioned by the "Merchant Shipping Act Amendment Act, 1862," and are contained in Table C in the Schedule to that Act: And when a sanctioned in the schedule to that Act: And when a sanctioned in the schedule to that Act: by the said Act, it is provided that Her Majesiy may from time to time, on the joint recommendati

of the Admiralty and the Board of Trade, by Order in Council modify any of the said regulations, or make new regulations in substitution therefor: And whereas certain clerical errors have been discovered in the regulations contained in the schedule to the said Act, and the Admiralty and the Board of Trade have jointly recommended Her Majesty to modify the said regulations for the purpose of correcting the said clerical errors; and the Regulations so modified are appended to this Order: And whereas, by virtue of the said Act and of this Order the said regulations appended thereto will, so far as relates to British ships, and also so far as relates to Foreign ships when within British jurisdiction, come into operation on the first day of June one thousand eight hundred and sixty-three: And whereas it is provided by the same Act that whenever it is made to appear to Her Majesty that the Government of any Foreign Country is willing that the regulations for preventing collision contained in Table C in the schedule to the said Act, or such other regulations for preventing collision as are for the time being in force under the said Act, should apply to the ships of such country when beyond the limits of British jurisdiction, Her Majesty may, by Order in Council, direct that such regulations shall apply to the ships of the said Foreign Country whether within British jurisdiction or not; and it is further provided by the said Act that whenever an Order in Council has been issued applying any regulation made by or in pursuance of the said Act, to the ships of any Foreign Country, such ships shall in all cases arising in any British Court be deemed to be subject to such regulation, and shall, for the purpose of such regulation, be treated as if they were British ships: And whereas it has been made to appear to Her Majesty that the Government of the Emperor of the French is willing that the said regulations, appended to this Order, should, on and after the first day of June one thousand eight hundred and sixty-three, apply to French ships when beyond the limits of British jurisdic-

Now therefore, Her Majesty, by virtue of the power vested in Her by the said recited Act, and by and with the advice of Her Privy Council, is pleased

First,—That the regulations contained in the schedule to the said Act shall be modified by the substitution for such regulations of the regulations

appended to this Order.

Secondly,—That the said regulations appended to this Order shall, on and after the said first day of June one thousand eight hundred and sixty-three, apply to French ships whether within British jurisdiction or not. EDMUND HARRISON.

Art. 1. In the following rules every Steam Ship which is under sail, and not under steam, is to be considered a Sailing Ship; and every Steam Ship which is under steam, whether under sail or not, is to be considered a ship under steam.

Rules Concerning Lights.

Lights.

Art. 2. The Lights mentioned in the following Articles, numbered 3, 4, 5, 6, 7, 8, and 9, and no others, shall be carried in all weathers, from sunset to sunrise.

Lights for Steam Ships.

Art. 3. Sea-going Steam Ships when under weigh shall carry:

(a.) At the Foremast Head, a bright White Light, so fixed as to show an uniform and unbroken light over an arc of the horizon of 20 points of the compass; so fixed as to throw the light 10 points on each side of the ship, viz.—from right ahead to 2 points abaft the beam on either side; and of such a character as to be visible on a dark night, with a clear atmosphere, at a distance of at least five miles:

(b.) On the Starboard Side, a Green Light, so constructed as to throw an uniform and unbroken light over an arc of the horizon of 10 points of the compass; so fixed as to throw the light from right ahead to 2 points abaft the beam on the starboard side; and of such a character as to be visible on a dark night, with a clear atmosphere, at a dis-

tance of at least two miles: (c.) On the Port Side, a Red Light, so constructed as to show an uniform and unbroken light over an arc of the horizon of 10 points of the compass; so fixed as to throw the light from right ahead to 2 points abaft the beam on the port side; and of such a character as to be visible on a dark night, with a clear atmosphere, at a distance of at least two miles.

(d.) The said Green and Red Side Lights shall be fitted with inboard screens, projecting at least three feet forward from the light, so as to prevent these lights from being seen across the bow.

Lights for Steam Tugs.

Art. 4. Steam Ships, when towing other ships, shall carry two bright White Mast-head Lights vertically, in addition to their side lights, so as to distinguish them from other Steam Ships. Each of these Mast-head Lights shall be of the same construction and character as the Mast-head Lights which other Steam Ships are required to carry.

Lights for Sailing Ships.

Art. 5. Sailing Ships under weigh, or being towed, shall carry the same lights as Steam Ships under weigh, with the exception of the White Masthead Lights, which they shall never carry.

Exceptional Lights for small Sailing Vessels.

Art. 6. Whenever, as in the case of small vessels during bad weather, the green and red lights cannot be fixed, these lights shall be kept on deck, on their respective sides of the vessel, ready for instant exhibition; and shall, on the approach of or to other vessels, be exhibited on their respective sides, in sufficient time to prevent collision, in such manner as to make them most visible, and so that the green light shall not be seen on the port side, nor the red light on the starboard side.

To make the use of these portable lights more certain and easy, the lanterns containing them shall each be painted outside with the colour of the light they respectively contain, and shall be provided

with suitable screens.

Lights for Ships at Anchor.

Art. 7. Ships, whether steam ships or sailing ships, when at anchor in roadsteads or fairways, shall exhibit, where it can best be seen, but at a height not exceeding twenty feet above the hull, a white light, in a globular lantern of eight inches in diameter, and so constructed as to show a clear uniform and unbroken light visible all round the horizon, and at a distance of at least one mile.

Lights for Pilot Vessels.

Art. 8. Sailing Pilot Vessels shall not carry the lights required for other sailing vessels, but shall carry a White Light at the mast-head, visible all round the horizon,—and shall also exhibit a Flare-up Light every fifteen minutes.

Lights for Fishing Vessels and Boats.

Art. 9. Open Fishing Boats and other open boats shall not be required to carry the side lights required for other vessels; but shall, if they do not carry such lights, carry a lantern having a Green Slide on the one side and a Red Slide on the other side; and on the approach of or to other vessels, such lantern shall be exhibited in sufficient time to prevent collision, so that the green light shall not be seen on the port side, nor the red light on the starboard side.

Fishing Vessels and open boats when at anchor or attached to their nets and stationery, shall ex-

hibit a bright White Light.

Fishing Vessels and open boats shall however not be prevented from using a Flare-up in adition, if considered expedient.

Rules concerning Fog Signals.

Fog Signals.

Art. 10. Whenever there is fog, whether by day or night, the Fog Signals described below shall be carried and used, and shall be sounded at least every five minutes; viz.:—

(a.) Steam Ships under weigh shall use a Steam Whistle placed before the funnel, not less than

eight feet from the deck:

(b.) Sailing ships under weigh shall use a Fog

(c.) Steam Ships and Sailing Ships when not under weigh shall use a Bell.

STEERING AND SAILING RULES.

Two Sailing Ships meeting.

Art. 11. If two Sailing Ships are meeting end on, or nearly end on, so as to involve risk of collision, the helms of both shall be put to port, so that each may pass on the port side of the other.

Two Sailing Ships crossing.

Art. 12. When two sailing ships are crossing so as to involve risk of collision, then, if they have the wind on different sides, the ship with the wind on

the port side shall keep out of the way of the ship with the wind on the starboard side; except in the case in which the ship with the wind on the port side is close hauled and the other ship free, in which case the latter ship shall keep out of the way; but if they have the wind on the same side, or if one of them has the wind aft, the ship which is to windward shall keep out of the way of the ship which is to leeward.

Two Ships under Steam meeting.

Art. 13. If two ships under steam are meeting end on, or nearly end on, so as to involve risk of collision, the helms of both shall be put to port, so that each may pass on the port side of the other.

Two Ships under Steam crossing.

Art, 14. If two ships under steam are crossing so as to involve risk of collision, the ship with has the other on her own starboard side shall keep out of the way of the other.

Sailing Ship and Ship under Steam.

Art. 15. If two ships, one of which is a sailing ship and the other a steam ship, are proceeding in such directions as to involve risk of collision, the steam ship shall keep out of the way of the sailing ship.

Ships under Steam to slacken Speed.

Art. 16. Every steam ship, when approaching another ship so as to involve risk of collision, shall slacken her speed, or, if necessary, stop and reverse; and every steam ship shall, when in a fog, go at a moderate speed.

Vessels overtaking other Vessels.

Art. 17. Every vessel overtaking any other vessel shall keep out of the way of the said last-mentioned vessel.

Construction of Articles, 12, 14, 15, and 17.

Art. 18. Where, by the above rules, one of two ships is to keep out of the way; the other shall keep her course, subject to the qualifications contained in the following Article.

Proviso to save special cases.

Art. 19. In obeying and construing these rules, due regard must be had to all dangers in navigation; and due regard must also be had to any special circumstances which may exist in any particular case, rendering a departure from the above rules necessary, in order to avoid immediate danger.

No Ship, under any circumstances, to neglect proper precautions.

Art. 20. Nothing in these rules shall exonerate any ship, or the owner, or master, or crew thereof, from the consequences of any neglect to carry lights or signals; or of any neglect to keep a proper look-out; or of the neglect of any precaution which may be required by the ordinary pratice of seamen, or by the special circumstances of the case.

Whereas by the 410th section of "The Merchant Shipping Act, 1854," it is enacted that upon the completion of any new lighthouse, buoy, or beacon, Her Majesty may, by Order in Council, fix such dues in respect thereof, to be paid by the Master or Owner of any ship which passes the same, or derives benefit therefrom, as Her Majesty may

deem reasonable, and may from time to time alter the amount thereof, and that such dues shall be paid and collected in the same manner, by the same means, and subject to the same conditions in, by, and subject to which the light dues authorised to be levied by the said Act are paid and collected; and whereas the Corporation of the Trinity House of Deptford Strond has placed a new light vessel near the west end of the Scarweather Sand, in the Bristol Channel, and a light is already exhibited therein. Now therefore, Her Majesty, in exercise of the powers vested in Her by the said recited Act, by and with the advice of Her Privy Council, is pleased to direct that there shall be paid, in respect of the said light vessel, for every vessel, whether British or Foreign, which, pursuant to the consolidated tables of light duties sanctioned by an Order in Council dated the twenty-sixth day of June one thousand eight hundred and fifty-five, shall become liable to the charge for the Nash Lights,

in the case of an oversea voyage, the toll of four sixteenths of a penny per ton of the burthen of every such vessel, and in the case of a coasting voyage, the toll of one sixteenth of a penny per ton of the burthen of every such vessel; and that the said tolls in respect of the said light vessel shall be levied by the Corporation of the Trinity House of Deptford Strond, subject to the gross abatement or discount of sixty per cent. mentioned in an Order in Council made under the authority of the said recited Act, and dated the twenty-fifth day of July one thousand eight hundred and sixty-one, and subject also to the regulations and exemptions contained in the said consolidated tables of light duties sanctioned by the said Order in Council dated the twenty-sixth day of June one thousand eight hundred and fifty-five, and to the further exemption sanctioned by an Order in Council dated the twelfth day of April one thousand eight hundred and fifty-EDMUND HARRISON.

TREASURY WARRANT.

WHEREAS by an Act of Parliament made and passed in the Session of Parliament holden in the third and fourth years of the reign of Her Majesty, chapter 96, for the regulation of the duties of postage, certain scales of weight and rates of postage were fixed, and were made chargeable and payable upon, for, and in respect of letters, newspapers, parliamentary proceedings, and printed papers, transmitted and forwarded by the post, and various regulations were made for facilitating the tranmission of such letters and papers by the post; and by the same Act power was given to the Postmaster-General to charge such higher rates of postage on certain letters, newspapers, and other printed papers therein mentioned, as the Commissioners of Her Majesty's Treasury, by Warrant under their hands, should from time to time deem expedient, and also to remit auy of the rates of British postage or inland postage for the time being payable by law on the transmission of post letters, newspapers, or other printed papers, to such extent as the Lords of the Treasury should from time to time direct; and by the same Act power was also given to the Commissioners of Her Majesty's Treasury, from time to time, by Warrant under their hands, to alter and fix any of the rates of British postage or inland postage payable by law on the transmission by the post of Foreign or Colonial letters or newspapers, or of any other printed papers, and to subject the same to rates of postage according to the weight thereof, and a scale of weight to be contained in such Warrant; and from time to time, by Warrant as aforesaid, to alter or repeal any of such altered rates, and make and establish any new or other rates in lieu thereof;

And whereas, by another Act of Parliament made and passed in the Session of Parliament holden in the seventh and eighth years of the reign of Her Majesty, chapter 49, for the better regulation of Colonial posts, power is also given to the Commissioners of Her Majesty's Treasury, by Warrant under their hands, to alter and fix any of the rates of Colonial postage payable by law for the transmission of letters by the post, and to subject the same to rates of postage according to the weight thereof, and a scale of weight to be contained in such Warrant; and from time to time, by Warrant as aforesaid, to alter or repeal any of such altered rates, and make and establish any new or other rates in lieu thereof;

And whereas further powers are given to the Commissioners of Her Majesty's Treasury by another Act of Parliament made and passed in the session of Parliament holden in the tenth and eleventh years of the reign of Her Majesty, chapter 85, for

giving further facilities for the transmission of letters by post, and for the regulating the duties of postage thereon, and for other purposes relating to the post-office;

And whereas, by another Act of Parliament made and passed in the eighteenth year of the reign of Her Majesty, chapter 27, for amending the laws relating to the stamp duties on newspapers, and providing for the transmission by post of printed periodical publications, power was given to Her Majesty's Postmaster-General, with the consent of the Commissioners of Her Majesty's Treasury, at any time or time thereafter, to make and issue such orders, regulations, conditions, and restrictions, as he should deem to be necessary or expedient for the purpose of regulating the receipt, transmission, and delivery by post of periodical publications, under the provisions of that Act, or for preventing or detecting frauds or abuses in relation thereto, and for giving effect to the purposes of that Act, and also for the said Postmaster-General, with the like consent, from time to time to rescind or revoke all or any such orders, regulations, conditions, and restrictions, and to make and issue any new ones in lieu thereof; and it was provided that all periodical publications sent by post otherwise than in conformity with the terms, conditions, and regulations established by or under the authority of that Act might be detained by the Postmaster-General, and any officer of the Post-Office, and after being opened the same should be either returned to the senders thereof or forwarded to the place of their destination charged with the like rates of postage as if the same were letters transmitted by the post, and that the Commissioners of Her Majesty's Treasury, by Warrant under their hands, might authorize Her Majesty's Postmaster-General to charge in any such case any such less rate of postage as to him should seem fit; and it was also declared that the term "periodical publica-tion" used in that Act, should be construed to mean and include (amongst other things) a newspaper as defined by the Acts in force relating to the stamp duties on newspapers;

And whereas certain orders, regulations, conditions, and restrictions have been from time to time made and issued by Her Majesty's Postmaster-General for the time being, with the consent of the Commissioners of Her Majesty's Treasury, for the purpose of regulating the receipt, transmission, and delivery by post of printed newspapers and certain printed periodical publications, under the provisions of the said last hereinbefore recited Act;

And whereas by the said orders, regulations, conditions, and restrictions so made and issued as aforesaid, it was ordered and declared that no newspapers transmitted by the post should have any word or communication printed thereon after the publication thereof, or upon any cover thereof, nor any writing or marks thereupon, or upon the cover thereof, other than the name and address of the person to whom sent, and except as therein also mentioned; and it was further ordered and declared that if any of the said regulations should be disregarded, the said newspapers, in certain cases therein mentioned, should be dealt with in accordance with the regulations contained in certain Treasury Warrants relating to the transmission by the post of book packets as therein mentioned;

And whereas the Commissioners of Her Majesty's Treasury, in exercise of the powers reserved to them in and by the said several hereinbefore recited Acts, some, or one of them, and of all other powers enabling them in that behalf, drave, from time to time, by divers Warrants in writing under their hands duly made, issued acertain

regulations, orders, directions, and conditions relating to the rates of postage, and the mode and time of payment thereof, and to the mode and time of sending, under and subject to and in conformity with which certain newspapers might respectively be transmitted by the post at lower rates than the letter rates of postage, and by which regulations newspapers so transmitted are prohibited in like manner from having any word or communication printed thereon after their publication, or upon the cover thereof, or any writing or marks upon them, or upon the covers of them, except the name and address of the person to whom sent;

And whereas in and by the said recited Warrants, some or one of them, provision is made that where newspapers transmitted by the post under the authority of the said respective Warrants rants, should not be transmitted in conformity with, and under and subject to the regulations, orders, directions, and conditions therein, or in some or one of them respectively mentioned and contained, such newspapers should in certain cases be chargeable with a postage of double the amount of postage to which they would have been liable as letters if the postage had been paid by stamps when posted, and in certain other cases with certain other letter rates of postage therein, or in some or one of the said Warrants respectively mentioned;

And whereas it is expedient that power should be given to the Postmaster-General to charge newspapers transmitted by the post between places within the United Kingdom, and newspapers, British, Colonial, or Foreign, brought into the United Kingdom by British packet-boat or private ship, or transmitted by the post between any ports or places beyond the sea through the United Kingdom, or transmitted by British packet-boat between any ports or places beyond the sea without passing through the United Kingdom, and with respect to which the regulation hereinbefore mentioned has been infringed, with a less amount of postage at his discretion than some of the rates of postage now chargeable thereon in the manner hereinafter mentioned.

Now we, the Commissioners of Her Majesty's Treasury, in exercise of the powers reserved to us in and by the said several hereinbefore recited Acts, any or either of them, and of all other powers enabling us in this behalf, do, by this Warrant, under the hands of two of us, the said Commissioners (by the authority of the Statute in that case made and provided), order, direct, and declare as follows :-

1. In all cases where any newspapers, British, Colonial, or Foreign, brought into the United Kingdom by British packet-boat or private ship, or transmitted by the post between any ports or places beyond the sea through the United King-dom, or transmitted by British packet-boat between any ports or places beyond the sea with-out passing through the United Kingdom, and in all cases where any newspapers transmitted by the post between places within the United Kingdom shall have any word or communication printed thereon after the publication thereof, or upon any cover thereof, or any writing or marks upon any such newspaper, or the cover thereof, other than the name and address of the person to whom sent (except the name or title of the newspaper, and the name and address of the publisher, newsvender, or agent, by whom sent, printed on the cover of any such newspaper), and shall by

or Warrants of the Commissioners of Her Majesty's Treasury now in force, or under or by virtue of any order, regulation, condition, or restriction heretofore made by Her Majesty's Postmaster-General for the time being, with the consent of the said Commissioners of Her Majesty's Treasury, the Postmaster-General for the time being shall and may, and he is hereby authorised and empowered, at his discretion, in lieu of any postage heretofore charged thereupon, and payable under or by virtue of any such Warrant or Warrants, order, regulation, condition, or restriction, as last aforesaid, to charge any such newspaper with any other rate or amount of postage or sum which he shall think proper, not exceeding the rate or amount of postage to which such newspaper would have been liable as a letter, if the postage had been paid by stamps when posted, nor less than the rate or amount of postage which such newspapers would have been liable to or chargeable with if transmitted in conformity with the regulations in force relating to such newspapers, anything in any such last-mentioned Warrant or Warrants, order, regulation, condition, or restriction heretofore made, contained to the contrary in anywise notwithstanding.

And whereas by a certain other Warrant under the hands of the Commissioners of Her Majesty's Treasury, and bearing date at Whitehall, Treasury-Chambers, the 21st day of July 1857, and by divers other Warrants in writing under the hands of the Commissioners of Her Majesty's Treasury since respectively made for regulating the duties of postage, and the transmission by the post of packets consisting of books, publications, and works of literature and art, between the United Kingdom and certain of Her Majesty's Colonies, and also between certain of Her Majesty's Colonies therein respectively mentioned, and also by a certain other Warrant under the hands of the Commissioners of Her Majesty's Treasury, and bearing date at Whitehall, Treasury-Chambers, the 16th day of October 1857, and made for regulating the duties of postage and transmission by the post of packets consisting of books, publications, and works of literature and art, between places within the United Kingdom. It was amongst other things ordered, directed, and declared, that the terms "books, publications, or works of literature or art," in and also between certain of Her Majesty's publications, or works of literature or art," in those Warrants, or in certain other Warrants thereby referred to respectively used, should, for the purposes of those Warrants respectively, mean and comprise all such articles as in their general character were either literary or consisted of printed, written, engraved, or lithographed matter (although not strictly literary), including books (whether printed, written, or plain); publications or compilations (whether in print or in manuscript), almanacks, printed or lithographed letters, and such artistic productions as prints, maps, (whether on paper, or canvas, or cloth, and whether printed or written), and photographs, when not on glass, or in frames containing glass; and any description of paper, parchment, or vellum, (whether printed, lithographed, written upon, or plain, or any mixture of the four); together with any binding, mounting, or covering of, or upon, or belonging to any such article or production, or any portion thereof, or of or belonging to any paper, parchment, or vellum, and including also any cases or rollers of prints or maps, bookmarkers, (whether of paper or otherwise,) pencils, pens, or other thing usually appertaining to any reason thereof have become liable to any increased such article or production, paper, parchment, or rate of postage under or by virtue of any Warrant vellum, or necessary for its safe transmission,

which should be sent in the same packet with any such article or production to which they or it should belong.

And whereas since the making of the said Warrants respectively, a practice has obtained of putting printed matter upon leather and other substances and things not being paper, parchment or vellum, and transmitting the same by the post under the privilege so given in and by the said several last hereinbefore recited Warrants, and it is expedient to make other regulations for preventing such abuses of the said privilege in manner hereinafter mentioned.

- Now we, the said Commissioners of Her Majesty's Treasury, in exercise of the powers reserved to us as aforesaid, do hereby further order, direct, and declare, as follows :-
- 2. In all cases where packets consisting of books, publications, or works of literature or art, may be transmitted by the post under the authority of any of such last-mentioned Warrants, whether the same be transmitted between the United Kingdom and any of Her Majesty's Colonies, or between any of Her Majesty's Colonies, or between any places within the United Kingdom, comprising prints or printed matter, such prints or printed matter shall consist only of prints or printed matter on paper, parchment, or vellum, and shall not comprise or include any printed matter on leather, cloth, canvas, or linen, or any other substance or thing whatsoever, except paper, parchment, or vellum, anything in the said last-mentioned Warrants respectively relating to any such packets, or any or either of them, contained to the contrary notwithstanding.
- 3. In all cases in which any question shall hereafter arise, whether any article, matter, or thing transmitted by the post under or by virtue of the said several Warrants hereinbefore last-mentioned, or under or by virtue of this present Warrant, is entitled to the book-post privilege, and to be so transmitted within the intent and meaning of the said several last-mentioned Warrants, or of this present Warrant, or any or either of them, such question shall be referred to the determination of the Postmaster-General, whose decision thereupon shall be final and conclusive upon all parties.
- 4. The Commissioners for the time being of Her Majesty's Treasury may, by Warrant under their hands duly made, at any time hereafter alter, repeal, or revoke the orders, regulations, and directions hereby made, and may make and establish any new or other rates, regulations, orders, directions, and conditions in lieu thereof, and from time to time appoint at what time the rates which may be payable are to be paid.

This Warrant shall come into operation on the second day of February next.
