recently erected on the summit of the extremity of the peninsula at Port Amastra, in the Black

The light is a fixed red light, placed at an elevation of 312 feet above the mean level of the sea, and should be seen in clear weather at a distance of 10 miles.

The lighthouse is said to stand in lat. 41° 45′ 20″ N., long. 32° 20′ 30" East of Greenwich, or $4\frac{1}{3}$ west of that of the Admiralty Charts.
