THE following Despatch has been addressed to Her Majesty's Ambassador at St Petersburg:—

Foreign Office,

MY LORD, October 20, 1863.

BARON BRUNNOW has communicated to me a despatch from Prince Gortchakoff, dated August 26, in reply to my despatch to your Excellency, No. 178, of the 11th ultimo, of which you were instructed to give a copy to his Excellency.

Her Majesty's Government have no wish to prolong the correspondence on the subject of Poland for the mere purpose of controversy.

Her Majesty's Government receive with satisfaction the assurance that the Emperor of Russia continues to be animated with intentions of benevolence towards Poland, and of conciliation in respect to all Foreign Powers.

Her Majesty's Government acknowledge that the relations of Russia towards European Powers are regulated by Public Law. But the Emperor of Russia has special obligations in regard to Poland.

Her Majesty's Government have, in the despatch of the 11th of August, and preceding despatches, shown that, in regard to this particular question, the rights of Poland are contained in the same instrument which constitutes the Emperor of Russia King of Poland.

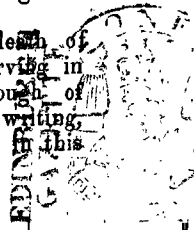

ZETLAND ROADS.

(Constitution of Trust; Assessments; other Purposes.)

NOTICE is Hereby Given that Application will be made to Parliament in the next Session for leave to bring in a Bill to make provision for the maintenance and management of Public Roads in Zetland; by which a body of Trustees will be constituted for that purpose, and the whole roads in that part of the United County of Orkney and Zetland, called Zetland, excepting in the Fair Isle, or including the same, if Parliament shall consider such expedient, will be committed to them, and to the District Committees of the said Trust, to be thereby also constituted, for maintenance and repair and management, according as the respective duties of such Trustees and Committees shall be prescribed; and powers will be taken for division of the portion of the County within the limits of the Act into Districts for the laying out and constructing new roads, and adopting roads which may have been made, and for straightening, widening, altering, and otherwise improving all roads and bridges, and to provide as to inclosing of lands adjacent, and for the permanent or temporary alteration, diversion, or shutting up of roads, bridges, streams, waters, drains, and other works; and for the doing of all and whatsoever things shall be found calculated to promote the objects of the said Bill.

And power will be taken by the said Bill to discontinue the maintenance of the roads by statute service, and the application of the Acts in regard to statute labour to the same; and to levy an assessment or assessments, one or more, on all lands and heritages, for the purposes of the Act, viz.—an assessment over the whole of the County within the limits of the Act, which may be uniform or differential as regards the several Districts or Islands, for maintenance and repair of the roads and general purposes, also an assessment over the particular Districts, all or any of them, for the purposes of making roads, or to pay for the making of the same; or an assessment over the County for all or any of such purposes; or an assessment over the Districts for all or any such purposes; all or any of which assessments may be on the owners and occupiers jointly, or one or other of them, or on either, with relief in whole or in part against the other; and all necessary powers will be taken for the due imposition, collection, and recovery of such assessments; and existing rates, assessments, and duties will be altered and repealed; and all suitable exemptions from payment of the rates and assessments will be conferred; and all existing exemptions be varied and extinguished; and all rights and privileges which will interfere with the objects of the Bill will be varied or extinguished; and all such as will further such objects will be conferred. mortgage, cash credit, or otherwise, and to make all necessary provision for the constitution, transference, and extinction of the sums so borrowed.

And all Acts of Parliament, public or local, which will be affected, will, so far as necessary, be amended, repealed, or declared inapplicable, and all necessary provision will be made for carrying into effect the whole objects of the said measure.

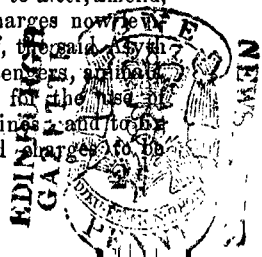
