THE Secretary of State for War has received two Despatches, with Enclosures, from Lieutenant-General D. A. Cameron, C.B., Commanding Her Majesty's Forces in New Zealand, of which the following are copies :-----

My Lord,

Head-Quarters, Queen's Redoubt, October 28, 1863.

HAVING, as I reported in my last Despatch, deferred any advance until I could secure the assistance of the iron steamer from Sydney and the gunboats from Auckland, I have nothing of importance to communicate to your Lordship, as these vessels, though expected daily from the Manukaw for the past three weeks, did not arrive here until the 27th.

The marauding incursions of parties of natives in the bush have been less frequent. Several murders of individual settlers, however, have occurred, who, neglecting repeated warnings, con-tinued to occupy detached houses at considerable distances from villages within our line of posts, thus affording the hostile natives opportunities of perpetrating atrocities which no defensive measures

can effectually prevent. On the 2d instant, at New Plymouth, a force under the direction of Colonel Warre, C.B., engaged a large body of natives who had assembled near the Poutoko Redoubt, with the intention of attacking it, and after more than an hour's sharp fighting, compelled them to retreat with considerable loss. Enclosed is the copy of my Despatch to Sir George Grey, with the report of the different officers in command, which will place your Lordship in posses-sion of the details of an action characterised by the gallantry invariably displayed by the troops, and which resulted in liberating the neighbourhood of the town from the main body of the insurgents, who retired to their pahs, about fifteen miles further south.

On the 23d, Lieutenant Lusk, commanding at Mauku, having observed a body of hostile natives near his post, proceeded with part of his detachment to ascertain their number, when he was incautiously drawn into an engagement before it was possible for the officer commanding at Drury to reinforce him. Attacked on all sides by overwhelming numbers, Lieutenant Lusk fought with great spirit, but was forced to retire, leaving on the ground 2 officers and 6 men killed. The intelligence of this recounter reached me late that reports from the Officer commanding a Ro

night, when I ordered a force of 200 men to march from Drury, with instructions to the officer in command of it to drive the natives out of the bush, and thinking it probable they would make for a point of the river used as a crossing place, called Pura Pura, I directed a part of Lieutenant-Colonel Nixon's moveable column, encamped near this, to proceed at once, by Tuakau and Cameron, to intercept them, but, from the difficulty of pushing rapidly through the bush by night, the natives had time to effect their retreat.

I am happy to state that the Government are making every effort to augment the militia raised in the neighbouring colonies. Two thousand six hundred have already arrived, and it is proposed that the number should be increased to five thousand, for the purpose of maintaining the land wrested from the natives and reserved for settlement.

I HAVE the honour to forward copies of a report from Colonel Warre, C.B., commanding at New Plymouth, and its enclosures, relative to a severe engagement which took place near Poutoko on the 2d instant, from which your Excellency will be glad to learn that the regular troops, as well as the militia and volunteers of the province, displayed their usual gallantry in repelling the attack of very superior numbers of the enemy. Colonel Warre evinced great judgment and ability throughout the action.

and to report, for the information of the Lieutenant-General Commanding, that later in the day the rebel Maories, from 6 to 800 strong, advanced with great determination to attack the redoubt.

Knowing that the Maories had been collecting their forces, and by information I received the previous evening, I was somewhat prepared for this attack, although I did not know against what quarter it was intended, and large fires lighted in every direction were evidently meant to withdraw our attention from the real point.

On receipt of Captain Wright's letter, I immediately sent Major Butler, 57th Regiment, to take command, and the reinforcements stated in the margin, being all the men I could spare compatible with the safety of the town.

On Major Butler's arrival at Poutoko, he found that the Maories were advancing from Hurford's Clearing and Brown's Land to the left, and left rear of the redoubt; and as the ground is tolerably open he advanced to meet them with about 100 men of the 57th and 70th from the redoubt, directing Captain Armstrong, with about 40 Militiamen, from the Omata Stockade, to hold the redoubt.

As it was now quite evident on which side the attack was directed, I followed the reinforcements, and directing Captain Shortt to proceed by the new line of road from Omata village towards Allan's Hill, and Captains Atkinson and Webster to continue their march by Warreka Gulley, I went forward and found Major Butler engaged by a very superior number of the enemy, who had possession of the bush, flanking the fields over which he had advanced. The firing was very heavy, and several casualties had .occurred, but the timely arrival of Captain Shortt, who at once attacked the rebels upon their right flank, enabled Major Butler to recover his ground, and to oblige the rebels to take refuge in the densely wooded gullies, from whence, and from the high trees on the opposite banks, they kept up an incessant but fortunately not very effective fire.

Captain Shortt also found himself opposed by very large numbers of rebels, who for a short time disputed his passage across the narrow neck of land between two deep gullies, near Touett's house. With the most determined gallantry his party forced their way across the broken half-cleared ground; and the arrival of the volunteers, under Captains Atkinson and Webster, enabled us to become the assailants, and the Maories were driven into the bush-covered gullies, where I folt that it would have been but a useless sacrifice of life to follow them.

During this action, which lasted upwards of an hour, word was brought to me that 2 or 300 'Maories had crossed the Tapuæ river, and were advancing towards the redoubt by the point, or Bob Erangi's pah, from whence they kept up a useless fire, until dislodged by shell from the howitzer which is kept in the redoubt. I also sent a subdivision, under Lieutenant Mills, to prevent the enemy from getting round the right flank, between the redoubt and the sea.

The troops and volunteers now held every commanding point from Waireka Hill, which had always been kept open by a strong picquet, to the redoubt, and the Maories, evidently satisfied that they could make no impression, gave vent to their rage by repeated volleys and the most frightful yells, after which they retired; and as the troops and volunteers from the town had marched six or eight miles, and had been continually engaged from the moment of their arrival, I did not think it right to allow them to follow the Maories, who

got away, not, I hope, without serious loss, by the thick bush on the way to the upper ford, *en route* to Kaitake. The troops bivouacked on the ground until the afternoon, when they returned to town, leaving a reinforcement of 50 men at the redoubt.

Nothing could exceed the admirable conduct of the officers, non-commissioned officers, and men, of both regular and militia forces engaged.

I am greatly indebted to Mijor Butler, 57th Regiment, for his persevering efforts to keep back the enemy, nearly six times as numerous as the party he had in the first instance to support his advance; also to Lieutenant C. M. Clarke, Deputy-Assistant Quartermaster-General, and Lieutenant E. Brutton, Garrison Adjutant, who accompanied me, and rendered me every assistance, as also did Lieutenant and Acting Adjutant W. Thompson, 57th Regiment, who, at the head of a small party, dislodged the enemy from a piece of bush from whence they had kept up a galling fire. Captains Shortt, 57th, and Wright, 70th Regiments, Captains Atkinson and Webster of the volunteers, and all the officers, set an example to their men which was nobly responded to; and the presence of Surgeon-Mackinnon, of the 57th Regiment, and the other Medical Officers, very materially relieved the sufferings of the wounded, who were brought into town during the afternoon, and who, with the exception of oue man, (Private Finn, 57th Regiment), since dead, are progressing favourably.

I should wish to bring specially to the notice of the Lieutenant-General Commanding, the noble conduct of Ensign Down, 57th Regiment, and Drummer Dudley Stagpoole, who, under a tremendous fire from natives not forty yards from them, brought away wounded men at the risk of their own lives; their efforts being ably seconded by Private Antonio Rodriques, a Mounted Orderly of the Tarauaki Militia, who carried two men off the field on his horse, and galloped through a party of rebel Maories to take my orders to Captain Shortt. At the risk of troubling the Lieutenant-General with too great detail, I beg to forward Captain Shortt's Report, as it specially mentions the above individuals, and bears evidence to his own gallant conduct in this severe engagement.

I must also beg to be allowed to mention the excellent conduct of Captain Mace, T. M., and the Mounted Orderlies who accompanied the troops, and were unceasing in their efforts to assist the wounded, and to distribute ammunition.

I have just received the enclosed report from Major Butler, which I forward, as it supports my testimony of the gallant conduct of all engaged; I also append a List of Casualties, which, although large, is far less than I had any right to expect.

The natives are still in the bu-h, about two miles from the redoubt, and are very numerous at Kaitake, but have made no further move this morning.

St Patrick's Redoubt, October 2, 1863.

I HAVE the honour to report that I observed the smoke of a large fire at the ford at Hurford's Clearing yesterday evening, at about six o'clock, and as it was necessary to send out a wood party to-day, I sent Mr Mills, with forty men to lay in ambush, at three A.M., on the hill overlooking the Maori track, with orders to proceed to Poutoko. On the road and thus to protect the wood party. I was overtaken by Colonel Warre, C.B., who

I have the honour to enclose his report on the matter, by which you will see he was fired on. I went to his support with thirty men, and found him at Allan's Hill, and that he did not require any more men. I left him to kay an ambush on a spot overlooking the place where the shots were fired from yesterday, thinking that the natives might come there to-day again, but he has since returned without seeing anything.

About sixty Maories or more are at present pulling down the Oakura Redoubt,

Poutoko, October 2, 1863.

I HAVE the honour to report, for your information, that, in accordance with instructions I received from you, I proceeded this morning at three A.M., strength as per margin,* to the bill overlooking the Tapuæ River, with the intention of laying an ambuscade, in order to cover a wood party which was to leave the redoubt at 8 A.M. On reaching Touett's bouse I formed single rank, and moved in that order up to within forty yards of the crest of the hill, when several Maories, who were evidently on sentry, immediately rose up and fired. I ordered my men to return the fire, which they did, and then I rushed up to the top of the hill, upon which the natives retired into the dense bush, two or three of them appearing to be badly wounded, leaving behind them six mats, one Maori kit full of bread, and a tomahawk. I followed them a short distance, but finding the bush too thick, and it being very dark at the time, I contented myself by holding the crest of the hill, in the event of an attack by a large number of natives. I remained there for about a quarter of an hour, but hearing the voices of a great number of Maories, I should say at least 200, I deemed it advisable to withdraw my party to some more open spot, and I accordingly moved back to Allan's Hill, where I posted my men, and waited until daybreak.

I beg you will bring to the notice of the Colonel Commanding the admirable conduct of the men under my command; the quiet and orderly way in which they behaved enabling me to surprise these Maori sentries.

Ensign Broderip and Dr Tomlinson were with my party, and greatly assisted me in every way.

New Plymouth, October 2, 1863.

I HAVE the honour to report, for the information of the Officer Commanding the regiment, that, in compliance with instructions received, I marched this morning with a party, strength as per margin,⁺

I was overtaken by Colonel Warre, C.B., who directed me to advance to the redoubt by the bush road, near Touett's house. Shortly after we had turned down this road I heard firing on my right, in the direction of Poutoko. at once strengthened my advance guard, and pushed on as rapidly as I could, and became engaged with the enemy near Touett's house. The natives immediately retreated to the bush, and opened fire upon my party from all directions. Leaving a reserve on Alwyn's Hill to protect my rear, I advanced towards the bush, but being met with a tremendous fire, I got the men under cover behind logs, &c., and endeavoured to keep down the fire of the enemy. I then charged the bush, but per-ceiving that it was occupied by a very large body of natives, I desisted, and got my men again under cover, and remained at this spot until I received orders from Colonel Warre to retire gradually; which I did, occupying Alwyn's Hill with the whole of my party, and we then retired in good order towards Poutoko.

I beg to bring to your notice the excellent conduct of the two officers with me, Ensign Douglass and Down. The latter officer volunteered, and with four men brought in the body of a wounded man under a very heavy fire. Drummer Dudley Stagpoole I would wish also to recommend most favourably to your notice; for, although wounded in the head, he twice volunteered and brought in wounded men. I cannot indeed speak too highly of the conduct of all my men; notwithstanding the superiority of the enemy in numbers, and the exceedingly heavy fire with which we were assailed, the they were cool and collected, and obedient to orders, which enabled me to retire with such slight loss and in good order, in the face of a very large body of natives, who lined the whole belt of bush to my front.

New Plymouth, New Zealand, October 2, 1863.

I HAVE the honour to report that, in accordance with your instructions, I proceeded at half-past ten A.M. this morning to the Poutoko Redoubt. On arrival there I was informed by Captain Wright, 70th Regiment, that a party under Lieutenant Mills, 57th Regiment, had proceeded to Hurford's Clearing early in the morning, for the purpose of laying an ambuscade, and had come into contact with the natives, killing one and wounding several. I was also informed by Captain Wright that the redoubt had been fired on by the Maories, and that he had reason to believe that they were assembled in large numbers in the surrounding bush.

I immediately despatched a mounted orderly to Omata for reinforcements, and, on their arrival, and on hearing that 100 men were on their road from town for my support, I proceeded in charge of the force detailed in the margin, * in the direction of Hurford's Clearing, for the purpose of making a reconnaissance and ascertaining as nearly as possible the number and position of the enemy. On arriving at Gilbert's Clearing, barely a mile from the redoubt, a very heavy fire was

* 1 Field Officer, 1 Captain, 3 Officers, and 100 Rank and File, 57th and 70th Regiments, opened upon my party from the surrounding bush, by which Ensign Powys, who commanded the advanced guard, and four men were wounded. I at once returned the enemy's fire, keeping my men as much under cover as possible; but finding myself greatly outnumbered I ordered my party to retire steadily towards the redoubt.

Learning, however, that 100 men of the 57th Regiment, under Captain Shortt, were advancing by the bush road towards the same spot, I advanced my men again, and (the enemy's fire being much weakened by Captain Shortt's attack on their right,) drove them back from their position on the edge of the bush, which I then occupied—the natives still keeping up a heavy fire, which was returned by my men.

As the latter part of the operations was carried on under your own immediate supervision I will omit further details, but must beg to bring to your prominent notice the admirable conduct of the whole of the force under my command; and more

especially I would wish to mention Ensign Douglass and Ensign Down, the latter officer having greatly distinguished himself by taking out a small party and bringing in a wounded man; also Ensign Powys, who behaved very well when in charge of the advance guard before he was wounded.

As the conduct of the parties of volunteers under Captain Atkinson and Captain Webster was brought ander your immediate notice, I think it hardly necessary to state how satisfied I was with the valuable assistance they afforded me.

I regret to state that one man of the force under my command was mortally wounded, four dangerously, one officer and three men severely, and one slightly.

SIR,

New Plymouth, New Zealand, September 30, 1863.

I HAVE the honour to transmit, for the information of the Lieutenant-General Commanding, the accompanying Report from Captain Atkinson, the Senior Officer in command of the Volunteers organized to patrol the settlement with a view to prewent the incursions of rebel Maories. It is with much pleasure I draw the Lieutenant-General's attention to the satisfactory result of this encounter between the Civilian Forces of this province and the rebel Maories, and to the persevering efforts of Captains Atkinson and Webster and the officers and men under their command, to carry out the important duties entrusted to them. In all weather, and at all hours, have these com-panies sought the enemy; and it is to their constant patrolling not only the immediate vicinity of the town but the outskirts of the settlement, that I attribute the little annoyance we have experienced from the presence of, it is now stated, some 500 of the rebels, who occupy strong positions on the edge of the bush between the Bell Block Stockade and Mataitawa

Captain Atkinson possesses all the energy and perseverance requisite to make him a first-rate guerilla" leader, and he is most ably seconded by the officers he has trained, as well as by the noncommissioned officers and men who form his force. They have co-operated with the regular troops on several occasions, and I am much indebted to their exertions, their endurance of fatigue, and their willing cheerfulness in the performance of their arduous duties.

I am happy to state that no casualties occurred, although the escapes of several of the men engaged appear to have been marvellous.

Taranaki. September 29, 1863.

I HAVE the honour to report, for the information of the Colonel Commanding, that this morning, at twenty minutes past three A.M., I left town with my own and Captain Webster's company of bushrangers, for the purpose of laying an ambuscade in the vicinity of the Bell Block. We planted, and remained in ambush till half past eight A.M., but without success. We then moved inland by the boundary line of the Bell Block, and upon reaching Street's Clearing, which is covered with high fern, we surprised a party of about thirty Maories. They returned our fire well for a few minutes, but very soon took to the bush, and then right away. We continued our march to Greenway's, where we surprised another party of about the same number; they also, after a short skirmish, made off as fast as possible. This party was apparently in waiting for a small escort from the Bell Block Stockade fetching firewood.

Knowing the strength of the natives in the immediate neighbourhood, I did not consider it prudent to follow up either of the parties, or to attempt to surround them, which could have been done in both cases had I felt certain of their numbers.

I believe we killed two, if not more, and wounde dseveral

We took six mats, two stained with blood, several haversacks and kits with food in, and one bag containing twenty-two leaden bullets.

There were no casualties I am thankful to say on our side, except one man (Rushton) just touched in the ear.

We reached town on our return at two P.M.

To Captains Webster and Messenger, to Lieutenant Jonas and Ensign Brown, and to Assistant-Surgeon Webber, my best thanks are due. The conduct also of the non-commissioned officers and men, upon whom so much depends on such occasions, was most satisfactory. I have, &c.,

Head-Quarters, Queen's Redoubt, October 28, 1863.

I HAVE the honour to acquaint your Excellency that, on the afternoon of the 23d iustant, I received information from Lieutenant-Colonel Chapman, Commanding at Drury, that Lieutenant Lusk, Commanding the outpost at Mauku, had reported to him that a large body of the enemy had approached within a mile of Mauku Church, and that he had left the Stockade with part of his detachment, to endeavour to ascertain their strength. Lieutenant-Colonel Chapman stated, that he had sent a reinforcement of 80 rank and file under Captain S. John, Waikato Militia, to Lieutenant Lusk's support.

At about eleven o'clock that night, I received further intelligence, that Lieutenant Lusk had incautiously engaged the enemy with his small force previous to the arrival of Captain S. John's reinforcement, and being greatly outnumbered, and attacked on both flanks, had been compelled to retire with loss.

Ι immediately ordered Lieutenant-Colonel Chapman to dispatch a reinforcement of 200 men (18th and 70th Regiments), under Major Ryan, to Mauku, with orders to attack the natives and drive them from the bush, and requested him to call upon Lieutenant-Colonel Nixon, to co-operate with part of the Colonial Defence Force from Papukura. I instructed Captain Rutherford, 70th Regiment, commanding a portion of Lieutenant-Colonel Nixon's column, which was encamped at Selby's, to move as rapidly as possible by Tuakau and Cameron to Pura Pura, with the view of intercepting the enemy, who were likely to attempt to

recross the river at that point. Lieutenant - Colonel Nixon and Major Ryan arrived at Mauku early on the morning of the 24th, aud found that the natives had decamped from the neighbourhood. Captain Rutherford pushed on to Pura Pura as expeditiously as the marching through the bush at night would allow, but was too late to cut off the enemy's retreat.

I herewith enclose Lieutenant Lusk's report of the engagement. The force which this officer had at his disposal was too small to attack so large a body of natives, advantageously posted in the bush, with any prospect of success; but the gallantry which this officer and the detachment under his

command displayed, in extricating themselves from | a very critical position, is deserving of the greatest praise. The conduct of the officers and men of the Mauku Volunteers and Waikato Militia on this trying occasion was admirable.

I regret to say that two officers, Lieutenant Perceval and Lieutenant Norman, both of whom greatly distinguished themselves, and six men, were killed, and one man dangerously wounded.

October 24, 1863.

I HAVE the honour to report that I started yesterday morning with a force as per margin,* to attack a body of the enemy who were shooting cattle on Mr Wheeler's farm at the Ti-ti. An advance party of my force, under Lieutenant Perceval, got close up to the enemy's position, under cover of the bush; when discovered they were hotly pressed by the enemy, and retired skirmishing, in good order, on the main body, without loss. I then advanced, having been joined by Lieutenant Norman and eight men. I drove the enemy through a strip of fallen timber on to open ground

beyond, but seeing that they wheeled round into the standing forest on my left flank, where they were largely reinforced, I deemed it prudent to retire; while re-orossing the fallen timber, the enemy, numbering from two to three hundred, charged us from the bush on the left, and after about ten minutes' very heavy firing at very short range (from ten to twenty yards), where both parties suffered severely, I being outflanked on both sides, retired into the forest on the right. The enemy did not venture to advance after we were under cover of the forest. I then reformed my under cover of the forest. I then re-formed my men, and retired leisurely on the Stockade. Our loss was one Lieutenant (Perceval), and five men killed, one man dangerously wounded, one Lieutenant (Norman), and one Private missing. The enemy's loss I believe to be about sixteen killed, and a large number wounded. Sergeant Hill and Private John Wheeler specially distinguished themselves by their determined gallantry, under most trying circumstances.

In continuation of my despatch of the 28th ultimo, reporting the arrival here of the steamer "Pioneer" and gun-boats, on the 27th ult., I have the honour to inform your Lordship that the following day was occupied in clearing her of stores, dec., and in landing two forty-pounder Armstrong guns at Whangamarino, which were placed in position to command the landing-place at Mere-Mere. These guns have been lent to the colony by the Sydney Government.

On the 29th I was enabled, in the "Pioneer," with Commodore Sir William Wiseman, to make a more complete reconnaissance than before of the enemy's works. They occupied them strongly on this occasion, and fired several rounds at the steamer from three guns, which they had in I found that the difficulty of landing position. troops rapidly for an attack, and the resistance to be expected from the nature of the defences, had not been over estimated, which induced me to make a further reconnaissance higher up the river, with the view of selecting some point at which a force could be landed to turn the enemy's position, while his attention was occupied in front by the steamer and gun-boats. I therefore proceeded again on the 31st up the river in the "Pioneer," with Sir William Wiseman, as far as Rangariri, and, having observed a point favourable for landing, about six miles above Mere-Mere, I arranged with the Commodore to embark the same night the force shewn in the margin,* with two twelvepounder Armstrong guns.

The "Pioneer" and "Avon," with the four gunboats in tow, got under weigh at half-past two o'clock on the morning of the 31st, and reached

Head-Quarters, Queen's Redoubt, I the point fixed for the landing about six o'clock. No attempt was made to oppose the troops, who took up a commanding position about 400 yards from the bank of the river. As I proposed bringing up an additional force the following night, I ordered a breastwork to be constructed for the protection of the camp, which I left under the com-mand of Colonel Mould, C.B.

During the afternoon of the 1st, whilst the necessary preparations were in progress for the conveyance of the remaining part of the force, the officer in command at Whangamarino reported that the natives were escaping in cances up the Whangamarino and Maramarua rivers. I embarked at once in the " Pioneer," with 250 men of the 12th and 14th Regiments from the Koheroa, and on reaching Mere-Mere it was evident the enemy had abandoned his position. A party of 250 seamen, under Commander Mayne, R.N., and the detach-ments from the Koheroa under the command of Colonel Austen, 2d Battalion 14th Regiment, landed on the position, and were ordered to hold the ground during the night, which was occupied the following day by detachments of the 12th, 14th, 18th, and 70th Regiments, amounting to about 500 men, who are employed in throwing up a redoubt there.

The steamer "Pioneer" left this about ten A.M. on the 2d, for the purpose of communicating with the camp at Takupetohetohe, and ascertained that about three o'clock on the morning of the 1st a small body of natives fired upon the camp, inflicting no loss, and making off as soon as the guns were turned upon them.

I am greatly indebted for the success of the operations described above to the cordial co-operation of Commodore Sir William Wiseman, and to the indefatigable exertions of the officers and men under his command.
