An act for permitting French wines to be imported in-to this kingdom from the ifles of Guernsey, Jersey, or Al-derney, in bottles or flasks.

An act for creeding a Lazaret on Chetney hill, in the county of Kent; and for reducing into one act the laws relating to quarantine, and for making further provision

An act for the better preventing the embezzlement of his Majefty's naval ordnance, and victualling flores.

An act to authorife his Majetty to grant commissions to natives of the Seven United Provinces, or of the Hereditary States of the Prince of Orange, to ferve on board certain Dutch thips of war furrendered to his Majesty's fleet, and in regiments in the pay of his Majefty; and to enable any fuch natives to inhit as folders in fuch regiments under certain refrictions.

An act for establishing further regulations for the Government of the British territories in India, and the bet-ter administration of justice within the same.

An act to restrain all trusts and directions in deeds or wills, whereby the profits or produce of real or personal restate shall be accumulated, and the beneficial enjoyment thereof postponed beyond the time therein limited.

An act to continue until the 5th day of April 1801, and amend an act in the last Session of Parliament for continuing feveral acts for the encouragement of the British Esheries.

An act for the more effectual prevention of depreda-

tions on the river Thames and in its vicinity.

An act to indemnify all persons who have printed, published, or dispersed, or who shall publish or disperse any papers printed under the authority of the Commission.

This day, his Majetty came to the House of Peers, and being in his royal robes, seated on the throne with the usual solemnity, Sir Erancis Molyneux, gentleman usher of the black rod, was fent with a meffage from his Ma-jefty, to the House of Commons, commanding their at-tendance in the House of Peers. The Common being come thither accordingly, his Majesty was pleased to give the royal affent to

An act for granting to his Majesty a certain sum of money out of the consolidated sund, for applying certain sums of money therein-mentioned for the service of the year 1800; for further appropriating the supplies granted in this session of parliament; and for making forth duplicates of Exchequer bills, lottery tickets, certificates, receipts, annuity orders, or other orders loft, burnt, or

otherwise destroyed.

An act for indemnifying the governor of Surinam, or the person acting as such, for having permitted the importation and exportation of goods and commodities in foreign bottoms; and for making void all feizures of thips, vessels, or goods, for any thing done in pursuance of fuch permission.

An act to permit until fix weeks after the commencement of the next fession of parliament, the importation of

Swedish herrings into Great Britain.

An act to repeal an act passed in the last fession of Parliament, intituled An act to prevent unlawful combina-tions of workmen, and to substitute other provisions in licu thereof.

And two private acts.

After which his Majesty was pleased to make the following most gracious Speech :-

My Lords and Gentlemen,
In putting an end to this laborious Session of Parliament, I must express the just sense I entertain of the diligence and perfeverance with which you have applied yourselves to the various objects of public concern which came under your deliberation. It is with peculiar satisfaction I congratulate you on the success of the steps which you have taken for effecting an entire Union between my kingdoms of Great Britain and Ireland.

This great measure, on which my wishes have been long earneftly bent, I shall ever consider as the happiest event of my reign, being persuaded that nothing could so effectually contribute to extend to my Irish subjects the full participation of the bleffings derived from the British constitution, and to establish on the most folid foundation, the strength, prosperity, and power of the whole empire.

I have witnessed with great concern the severe pressure on my people, from the continued scarcity of the season; but I trust that, under the bleffing of Providence, there is now every reason to expect that the approaching harvest will afford a speedy and effectual relief.

Gentlemen of the House of Commons,

I return you my particular thanks for the zeal and liberality with which you have provided for the various exigencies of the with which you have provided for the various exigencies of the public fervice. I regret deeply the necessity of these repeated facrifices on the part of my subjects, but they have been requisite for the preservation of our dearest interests; and it is a great consolation to observe, that, not with sanding the continuance of unusual burdens, the revenue, commerce, and resources of the country have shours the beyond all former example, and are still in a state of progressive augmentation.

My Lords and Gentlemen,

The course of the campaign upon the Continent has, by a sudden reverse, disappointed the sanguine hopes which the stu-

ation of affairs at its commencement appeared fully to justify, and has unhappily again exposed a considerable part of Europe to those calamities and dangers from which it had recently been

to those calamities and dangers from which it had recently been referred by the brilliant fucces of my allies.

Much as these events are to be regretted, it will always be matter of just satisfaction to me to reflect, that, in the course of this important contest, my efforts, and those of my Parliament, have been unremittingly employed for the maintenance of our own rights and interests, and for animating and supporting the exertions of other powers in defending the liberties of Europe. Europe.

Europe.

Notwithstanding the vicissitudes of war, your constancy and firmess have been productive of the most important and lasting advantages in the general situation of affairs, and the determination manifested in your recent declarations and conduct, must afford me the best means of promoting, in conjunction with my allies, the general interests, and of providing under every circumstance for the honour of my crown, for the happiness of my subjects, and for the security and welfare of every part of the British empire.
