To The QUEEN's Most Excellent Majesty.

Most Gracious Sovereign,

WE, your Majesty's most loyal and dutiful Subjects, the Chancellor, Masters, and Scholars of the University of Oxford, beg leave to approach your Majesty with renewed assurances of loyalty to the Throne and affection towards your Majesty's

Royal person.

The anticipations which, in common with all other your Majesty's devoted Subjects, we ventured to entertain when last permitted to address your Majesty, have been recently fulfilled by the birth of a Prince; and it now becomes our duty to offer to your Majesty the sincere congratulations of this

With the liveliest feelings of gratitude and joy we have been assured from time to time of the safety of Her Royal Highness the Princess of Wales, and the uninterrupted health and well-being of the infant Prince. But our deep sense of thankfulness has been immeasurably increased by the conviction that this signal domestic blessing has contributed largely to your Majesty's own personal relief and comfort. In these most happy results we gladly trace the orderings of an All-wise and gracious Providence, ever watchful (as we humbly trust and pray) over your Majesty's welfare and happiness, affording also the promise of increased stability to your Royal House, and encouraging in the hearts of all your Majesty's Subjects the fervent hope that the impress of your Majesty's wise and prosperous government may be transmitted in the persons of your Majesty's own descendants to the far distant future of our Nation's destiny.
