NOTIFICATION of the Raising of the Blockade of the Prussian Ports in the Baltic, and the Ports of Sleswig and Holstein.

IT is hereby notified that Earl Russell, Her Majesty's Principal Secretary of State for Foreign Affairs, has received from Her Majesty's Chargé d'Affaires at Copenhagen, an Official Notification, issued by the Ministry of Marine of the King of Denmark, and dated the 10th May 1864, announcing that the Blockade by the Danish Naval Forces of the Prussian Ports in the Baltic, and of the Ports of Sleswig and Holstein (which ports and places are particularly named in the official notice hereunder set forth), will, from the 12th of this present month (May 1864) be raised, and cease to be in force.

The following is the Official Notification received by Earl Russell:~

THE Ministry of Marine notifies herewith that, according to the suspension of hostilities concluded yesterday in London, the blockade of the ports of Cammin, Swinemunde, Wolgast, Greifswalde, Stralsund, Barth, Danzig, and Pillau, will be raised the 12th of this month.

Further, the blockade of ports and inlets in the Duchies of Slesvig and Holstein, notified under the 18th and 27th of February and 22d of March this year, will be raised from the same time.

New Harbour Light.

A fixed red light, similar to the one heretofore shown from the light vessel, will be exhibited from a mast 84 yards from the present extremity of the breakwater, at an elevation of 40 feet above the level of high water.

A gong will be sounded during foggy weather, in like manner as is now done on board the light

vessel.

A red buoy marks the spot where the extreme end of the breakwater will be when finished; vessels should pass eastward of the buoy.

PARISH OF GAIRLOCH, ROSS.

OTICE is Hereby Given, That in terms of the 12th Clause of the Vaccination (Scotland) Act, 1863,—26 and 27 Vict., cap. 108,—and upon application by the Parochial Board of Gairloch, in the County of Ross, the Board of Supervision have framed Modifications of the 8th and 9th Clauses of the said Act, as hereinafter expressed, to supersede the provisions in these Clauses so far as regards the said Parish of Gairloch, and that the said Modifications have been approved of by the Lord Advocate, in conformity with the Act:-

"In the 8th Clause of the said Act, where the word 'Six' occurs, the word 'Twelve' to be substituted for it; and where the words 'Three Days occur, the words 'One Month' to be substituted

for them.

"In the 9th Clause of the said Act, wherever the word 'Two' occurs, the word 'Six' to be substituted for it."

Accordingly, the 8th and 9th Clauses of the Vaccination (Scotland) Act, 1863, will stand as follows, so far as regards the Parish of Gairloch :-

"8. The Father of every Child born in Scotland after the First Day of January in the Year One thousand eight hundred and sixty-four, and in the event of the Death, Illness, or Inability of the Father, then the Mother, or in the event of the Death, Illness, Absence, or Inability of the Father and Mother, then the Person who shall have the Care, Nurture, or Custody of such Child, shall, within Twelve Months after the Birth of such Child, cause such Child to be vaccinated by a Medical Practitioner, and upon and immediately after the successful Vaccination of such Child the Medical Practitioner who shall have per-formed the Operation shall deliver to the Father or Mother of such Child, or to the Person who shall have the Care, Nurture, or Custody of such Child, a Certificate under his Hand, according to the Form of the Schedule (A) hereto annexed, that such Child has been successfully vaccinated; and such Certificate shall, within One Month after the Date thereof, be transmitted to and lodged with the Registrar for the District by the Father, Mother, and Power of week of which are the Certificate if registered. or Person aforesaid, and such Certificate, if registered, shall, without further Proof, be admissible as Evidence of the successful Vaccination of such Child in any Information or Complaint which shall be brought against the Father, Mother, or Person aforesaid, for Non-compliance with the Provisions of this Act.

" 9. If any Medical Practitioner shall be of opinion that any Child is not in a fit and proper State to be suc-
