Board of Trade, Whitehall, March 30, 1865.

The Right Honourable the Lords of the Committee of Privy Council for Trade have received, from the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Chargé d'Affaires as Copenhagen, enclosing the following translation of a Danish Law recently enacted, and which regulates the amount of drawback to be allowed on the exportation of Danish and Foreign brandies.

1st. A drawback will henceforth be allowed on the export of home-made brandy to a foreign or a free port, or as ships' stores, of 1.6 skilling per "pot," of four degrees of strength, with an addition of 0.1 skilling per "pot" for each quarter of a degree increase of strength. No drawback will be allowed on brandy of less

than four degrees of strength.

If sugar, spice, or any such thing is added to the brandy, thereby preventing the gauging of the strength, as in the case of "Aquavit," liqueur, cherry brandy, punch extract, and such mixtures, the strength is considered to be eight degrees, so that in each case a drawback of 3.2 skillings per "pot" will be allowed.

2d. The present law will apply also to the drawback allowed by paragraph 29 of the law of the 4th July 1863, on the exportation to foreign or free ports of foreign spirits liable to customs' duty, either pure, or mixed with sugar and the like.

3d. The conditions respecting the extent of drawback on the exportation of home-made brandy, with or without sugar, contained in paragraph No. 7 of the law of February 7, 1851, are hereby repealed, but the remainder of the paragraph continues in force.

4th. So long as the law of the 5th August of last year respecting the war tax on brandies remains in force, the drawback mentioned in the

above paragraphs 1 and 2 will be calculated under the conditions laid down in that law, with an increase of 50 per cent.

Fixed and Flashing Light on Ons Island.

The Minister of Marine at Madrid has given notice, that on and after the 15th day of April 1865, a light will be exhibited from a lighthouse recently erected on Ons Island, on the north side of entrance to Pontevedra Bay, west coast of Spain.

The light will be a *fixed* white light, varied by a *flash* every *two minutes*. It is placed at an elevation of 421 feet above the mean level of the sea, and in clear weather should be seen from a distance of 12 miles.

The illuminating apparatus is dioptric or by lenses, of the fifth order.

The tower is 20 feet high, green, with a white lantern, and stands in lat. 43° 28' 40" N., long. 8° 15' 31" West of Greenwich.

Gulf of Naples.

In order to mark at night the progress of the works in course of construction for the extension of the mole at the military port of Naples, from the 15th day of March 1865 a light boat will be substituted for the bell buoy now marking the extremity of the works. The light-boat will be placed about E.S.E., distant rather less than half a cable from the lighthouse on the mole, and will show a *fixed green* light, visible at a distance of 2 miles. The boat will carry a skeleton cage, painted white and red, and vessels should give her a wide berth.
