INVESTITURE OF HIS MOST FAITHFUL MAJESTY LOUIS, KING OF PORTUGAL, WITH THE ENSIGNS AND HABIT OF THE MOST NOBLE ORDER OF THE GARTER.

LISBON, May 4, 1865.

THE Queen, Sovereign of the Most Noble Order of the Garter, having been pleased, by Commission under Her Majesty's Sign Manual and the Great Seal of the Order, to constitute and appoint the Right Honourable William Philip, Earl of Sefton, Her Majesty's Envoy Extraordinary and Minister Plenipotentiary on a Special Mission to this Court, and Sir Charles George Young, Knight, Garter Principal King of Arms, or his Deputy for this occasion, Walter Aston Blount, Esquire, Norroy King of Arms, to be Her Majesty's Plenipotentiaries for Investing His Most Faithful Majesty Louis, King of Portugal, with the Ensigns and Habit of the Order of the Garter.

The Earl of Sefton and Deputy Garter embarked at Portsmouth on the 17th of April last, on board Her Majesty's ship "Edgar," together with their respective Suites, for this City, and landed on the 22d.

On the 24th the Earl of Sefton was honoured with an audience of His Most Faithful Majesty at the Palace of the Ajuda, at which Deputy Garter and the Members of their respective Suites were severally presented to His Majesty.

On the 2d of May the Earl of Sefton, Deputy Garter, and the Members of their respective Suites, had the honour of being presented to His Majesty the King Don Ferdinand, at the Palace of the Necessidades.

The requisite arrangements for the Investiture having been made, His Majesty was pleased to appoint Thursday the 4th instant for that purpose, on which day, at half-past ten o'clock, the several persons appointed to take part in the ceremony assembled at the Residence of the Earl of Sefton, and from thence proceeded to the Royal Palace of the Ajuda, in four of the Royal State Carriages, under an Escort of Lancers.

On arriving at the Palace the Mission was received by a Guard of Honour, and, advancing through the Hall, was met by the Marquis de Bemposta Subserra, Introducer of Ambassadors, and the Duke de Palmella (Archerio-Mŏr), and conducted to a Saloon of the Palace, where the Procession was formed, and passed through an Ante-Chamber into the Royal Presence, with due reverences, in the following manner; the Insignia of the Order being carried on Velvet Cushions:—

Captain Geoffrey Thomas Phipps Hornby, R.N., carrying the mantle of the Order.

Rear-Admiral Sydney Colpoys Dacres, K.C.B., carrying the Sword of the Order. Colonel Dudley Wilton Carleton, carrying the Hat and Plume.

Major-General Lord Henry Percy, carrying the Collar and Star of the Order



George Edward Adams, Esq., Rouge Dragon Pursuivant of Arms, in his Tabard, carrying the Garter with the Riband and George.

James Robinson Planché, Esq., Rouge Croix Pursuivant of Arms, Secretary to the Garter Mission, in his Tabard, carrying The Sovereign's Commission.

Walter Aston Blount, Esq., Deputy Garter, in the Mantle, Chain, and Badge, and bearing the Sceptre of Garter, carrying The Sovereign's Letters of Credence.

Charles Stuart Aubrey Abbott, Esq., Secretary to Her Majesty's Envoy Extraordinary, carrying the Book of the Statutes.

The Right Honourable William Philip, Earl of Sefton, Her Majesty's Envoy Extraordinary on a Special Mission.

The Mission was received by His Most Faithful Majesty standing in front of the Throne, and surrounded by the Ministers of State and the Great Officers of the Court. The Gentlemen bearing the Insignia divided to the right and left, the Plenipotentiaries advancing between them, and passing to the right of the Throne, the Secretary to the Mission remaining near to the Plenipotentiaries to deliver to them the Insignia.

The First Plenipotentiary, the Earl of Sefton, then made an Address to His Majesty, declaratory of the object of the Mission, to which His Majesty made a most gracious reply; Deputy Garter then delivered to his Lordship the Letters of Credence, which his Lordship presented to The King, who delivered them to the Count D'Avila, Minister for Foreign Affairs. The Statutes were then in like manner presented to The King, and next the Commission, which latter was subsequently returned to the Secretary. Deputy Garter then taking the Garter, delivered it to the Earl of Sefton, who buckled the same round His Majesty's left leg; Deputy Garter reading the Admonition.

His Majesty was next invested with the Riband and George appendant; Deputy Garter reading the Admonition.

The King then delivered His Sword, which Deputy Garter received and retained as an ancient fee appertaining to the office of Garter, and His Majesty was invested with the Sword of the Order.

His Majesty being then divested of the Riband and George, which was received by an Officer of the Court, Deputy Garter presented to the Earl of Sefton the Mantle, with which His Majesty was invested by the Plenipotentiaries.

His Majesty was in like manner invested with the Collar of the Order; Deputy Garter than delivered to the Earl of Sefton the Hat and Plume, which was presented by His Lordship to the King, and immediately afterwards the Star of the Order, which was in like manner presented to His Majesty.

The Ceremony of Investiture being completed, the Plenipotentiaries, with their respective Suites, making their reverences, withdrew from the Royal Presence.

Manuel de Camara, Chamberlain to the King; The Marquis de Ficalho, Chamberlain to the King; Count de Valde Reiz, Chamberlain to Her Majesty the Queen; General Feliciano da Cortas, First Aide-de-Camp to His Majesty; General Caula, Aide-de-Camp to His Majesty; Lieutenant-General Count de Campanhaa, Aide-de-Camp to the King Don Ferdinand; The Marquis de Fronteira; The Count da Ponte, Grand Master of the Household; The Marquis de Bemposta Subserra, Introducer of Ambassadors, and other Officers of the Household; The Councillors of State; Sir Arthur Charles Magenis, K.C.B., Her Britannic Majesty's Envoy Extraordinary and Minister Plenipotentiary at the Court of Lisbon; William Smith, Esq., the British Consul; The Foreign Ministers at the Court of Lisbon, and other Distinguished Personages; also the Principal Officers of Her Britannic Majesty's Squadron in the Tagus.

A Banquet took place at the Ajuda Palace in the evening, at which were present The King, wearing the Ensigns of the Order of the Garter, His Majesty King Don Ferdinand, The Infant Don Augusto, The Plenipotentiaries and their Suites, The Ministers of State and Great Officers of the Court, The British Minister, Admiral Sir George Rose Sartorius, K.C.B., Rear-Admiral Sydney Colpoys Dacres, K.C.B., Rear-Admiral Frederick Warden, C.B., and the Captains of Her Britannic Majesty's Squadron in the Tagus.

# By Her Majesty's Command.

The Noblemen and Gentlemen who propose to attend Her Majesty's Levee, at St James's Palace, are requested to bring with them two large cards, with their names clearly written thereon, one to be left with the Queen's Page in Attendance in the Corridor, and the other to be delivered to the Lord Chamberlain, who will announce the name to His Royal Highness.

#### Presentations.

Any Nobleman or Gentleman who proposes to be presented must leave at the Lord Chamberlain's Office, St James's Palace, before twelve o'clock, two clear days before the Levee, a card with his name written thereon, and with the name of the Nobleman or Gentleman by whom he is to be presented. In order to carry out the existing regulation that no presentation can be made at a Levee excepting by a person actually attending that Levee, it is also necessary that a letter from the Nobleman or Gentleman who is to make the presentation, stating it to be his intention to be present, should accompany the presentation card above referred to, which will be submitted to The Queen for Her Majesty's approbation. It is Her Majesty's command that no presentation shall be made at the Levee except in accordance with the above regulations.

It is particularly requested that in every case the names be very distinctly written upon the cards to be delivered to the Lord Chamberlain, in order that there may be no difficulty in announcing them to His Royal Highness.

The State Apartments will be open for the reception of Company coming to Court at one o'clock.

If any Medical Practitioner shall be of opinion that any Child is not in a fit and proper State to be successfully vaccinated, he shall thereupon and immediately deliver to the Father or Mother of such Child, or the Person having the Care, Nurture, or Custody of such Child, a Certificate under his Hand, according to the Form of the Schedule (B) hereto annexed, that the Child is in an unfit State for successful Vaccination, and such Certificate shall remain in force for Six Months from its Delivery as aforesaid; and the Father, Mother, or Person aforesaid shall, unless they shall within each succeeding Period of Six Months have obtained from a Medical Practitioner a Renewal of such Certificate, within Six Months next after the Delivery of the said Certificate as aforesaid, and if the said Child be not vaccinated at the Termination of such Period of Six Months, then during each succeeding Period of Six Months, then during each succeeding Period of Six Months until such Child has been successfully vaccinated, cause such Child to be examined by a Medical Practitioner, and if he deem such Child to be then in a fit and proper State for Vaccination, he shall forthwith vaccinate him accordingly, and if the Operation be successful shall deliver to the Father or Mother of such Child, or Person aforesaid, a Certificate under his Hand, according to the Form of the said Schedule (A), that such Child has been successful Vaccination, then he shall again deliver to the Father or Mother of such Child, or Person aforesaid, a Certificate under his Hand, according to the Form of the said Schedule (B), that the Child is still in an unfit State for successful Vaccination; and the Medical Practitioner, so long as such Child remains in an unfit State for Vaccination and unvaccinated, shall at the Expiration of every succeeding Period of Six Months deliver, if required, to the Father or Mother of such Child, or Person aforesaid, a fresh Certificate under his Hand, according to the said Form; and t
