INVESTITURE OF HIS ROYAL HIGHNESS THE GRAND DUKE OF HESSE, WITH THE ENSIGNS AND HABIT OF THE MOST NOBLE ORDER OF THE GARTER.

DARMSTADT, June 7, 1865.

HER MAJESTY, Sovereign of the Most Noble Order of the Garter, having been pleased, by a Commission under the Great Seal of the Order, to constitute and appoint Their Royal Highnesses Prince Alfred and Prince Louis of Hesse, Knights of the said Most Noble Order, to be Her Majesty's Plenipotentiaries for Investing His Royal Highness The Grand Duke of Hesse with the Ensigns and Habit of the said Most Noble Order, and to direct and command Sir Charles George Young, Knight, Garter Principal King of Arms, to attend and assist Their Royal Highnesses in the Ceremony of Investiture, the Plenipotentiaries and Garter, with their respective Suites, assembled at Darmstadt on the 2d instant.

On the following day Garter, and the Secretary to the Mission, had the honour of being presented to His Royal Highness The Grand Duke, by His Royal Highness Prince Alfred.

The preliminary arrangements having been made, Tuesday, the 6th instant, was fixed for the Investiture.

Their Royal Highnesses the Plenipotentiaries, Garter, and their respective Suites, assembled at half-past Two o'clock, in the State Apartments of the Grand Ducal Palace, from whence the Princes Plenipotentiaries, in a Royal State Carriage drawn by Six Horses, and the Gentlemen appointed to take part in the Ceremony, preceded by the Grand Master of the Ceremonies, Von Werner, all in Royal Carriages, proceeded to the Grand Ducal Residence (Schloss), under an Escort of Cavalry.

Upon arrival at the Schloss, the Mission was received by the Grand Marshal of the Court, the Count Ysenburg, and conducted to the Fahnen-Saal, where it waited until the Grand Master of the Ceremonies announced the Grand Duke's readiness for its reception in the Kaiser Saal.

The Procession being formed, advanced into the Royal Presence in the following order:-

The Grand Master of the Ceremonies and Grand Marshal of the Court.

Percy Mitford, Esq., Second Secretary of Legation, accredited to the Court of the Grand Duke, carrying the Sword of the Order on a Velvet Cushion.

Lieutenant Arthur Balfour Haig, R.E., Equerry in attendance on H.R.H. Prince Alfred, carrying the Hat and Star of the Order on a Velvet Cushion. Edwin Corbett, Esq., Secretary of Legation, accredited to the Court of the Grand Duke, carrying the Book of the Statutes on a Velvet Cushion.

Major John Clayton Cowell, R.E., C.B., Governor of H.R.H. Prince Alfred carrying the Mantle and Collar of the Order on a Velvet Cushion. Captain Von Westerweller,

Master of the Household to His Royal Highness Prince Louis of Hesse,
carrying the Garter, and the Riband and George,
on a Velvet Cushion.

William Courthope, Esq., Somerset Herald, Secretary of the Garter Mission, in his Tabard and Collar of S.S., carrying The Sovereign's Commission.

Sir Charles George Young, Knt.,
Garter Principal King of Arms, in his Mantle, Chain, and Badge, and
carrying his Sceptre.

THE PRINCES PLENIPOTENTIARIES.

His Royal Highness Prince Louis of Hesse, K.G., in the full Habit and Ensigns of the Order. His Royal Highness Prince Alfred, K.G., in the full Habit and Ensigns of the Order.

Advancing into the Royal Presence with due reverences, the Mission was received by the Grand Duke upon his Throne. The Gentlemen bearing the Insignia, divided to the right and left, the Plenipotentiaries advancing between them, the Secretary to the Commission, Somerset Herald, remaining near to Garter and Plenipotentiaries to deliver the Insignia.

After a short pause His Royal Highness Prince Alfred made an address to His Royal Highness The Grand Duke, to which the Grand Duke made a gracious response.

The Commission was then presented and returned to Garter, who delivered it to the Secretary. The Garter being next handed to the Plenipotentiaries, Their Royal Highnesses buckled the same round the Grand Duke's Left Leg, Garter reading the Admonition. The Grand Duke was then invested with the Riband and George, Garter reading the Admonition.

The Grand Duke then delivered his Sword to Lieutenant-General Baron Von Trotha, Grand Stewart of the Court, which Garter received and retained as an ancient Fee pertaining to his office. His Royal Highness the Grand Duke was then invested with the Sword of the Order. His Royal Highness was then divested of the Riband and George, which was received by the Baron Von Doernberg. Garter then presented to the Plenipotentiaries the Mantle, with which their Royal Highnesses invested the Grand Duke, and afterwards with the Collar of the Order. The Plenipotentiaries next presented the Hat and Star, and lastly the Book of the Statutes of the Order.

The ceremony of Investiture being concluded, the Plenipotentiaries, with Garter and their respective Suites, making their reverences, withdrew from the Royal Presence, and were conducted to the Grand Ducal Palace in the order in which they had arrived.

The ceremony was witnessed by Her Royal Highness The Princess Louis of Hesse, (Princess Alice of Great Britain and Ireland,) His Grand Ducal Highness Prince Charles of Hesse, His Grand Ducal Highness Prince Alexander of Hesse, Their Grand Ducal Highnesses the Princes Henry and William of Hesse, the Great Officers and Ministers of State, General Officers, and Aides-de-Camp, Sir Alexander Malet, Bart., Her Majesty's Envoy Extraordinary and Minister Plenipotentiary to the Germanic Diet, accredited at the Court of The Grand Duke, and other persons of distinction.

A banquet was afterwards given, at which the Grand Duke appeared, wearing the Collar of the Order. During the banquet His Royal Highness drank to the health of the Sovereign, Queen Victoria, and His Royal Highness Prince Alfred afterwards drank to the health of His Royal Highness the Grand Duke, Knight of the Most Noble Order of the Garter.

The Queen has been pleased to appoint Robert Rawlinson, Esq., John Thornhill Harrison, Esq., and John Thomas Way, Esq., to be Her Majesty's Commissioners for the purpose of inquiring how far the present use of rivers or running waters in England, for the purpose of carrying off the sewage of towns and populous places, and the refuse arising from industrial processes and manufactures, can be prevented without risk to the public health or serious injury to such processes and manufactures, and how far such sewage and refuse can be utilized or got rid of, otherwise than by discharge into rivers or running waters, or rendered harmless before reaching them; and also for the purpose of inquiring into the effect on the drainage of lands and inhabited places, of obstructions to the natural flow of rivers or streams caused by mills, weirs, locks, and other navigation works, and into the best means of remedying any evils thence arising.

The Right Honourable the Lords of the Committee of Privy Council for Trade have received, from the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Minister at Washington, enclosing a copy of the following Proclamation issued by the President of the United States, relative to the opening of the ports of the Southern States to Foreign Commerce:—

#### OFFICIAL.

#### Department of State.

By the President of the United States of America.

#### A PROCLAMATION.

Whereas, by the Proclamation of the President, of the 11th day of April last, certain ports of the United States therein specified, which had previously been subject to blockade, were, for objects of public safety, declared, in conformity with previous special legislation of Congress, to be closed against

foreign commerce during the National will, to be thereafter expressed and made known by the President; and whereas events and circumstances have since occurred which, in my judgment, render it expedient to remove that restriction, except as to the ports of Galveston, La Selle, Brazos de Santiago (Point Isabel), and Brownsville, in the State of Texas.

Now therefore, be it known that I, Andrew Johnson, President of the United States, do hereby declare that the ports aforesaid, not excepted as above, shall be open to foreign commerce from and after the 1st day of July next; that commercial intercourse with the said ports may, from that time, be carried on, subject to the laws of the United States, and in pursuance of such regulations as may be prescribed by the Secretary of the Treasury. If, however, any vessel from a foreign port shall enter any of the before-named excepted ports in the State of Texas, she will continue to be held liable to the penalties prescribed by the Act of Congress approved on the 13th day of July 1861, and the persons on board of her to such penalties as may be incurred, pursuant to the laws of war, for trading or attempting to trade with an enemy.

And I, Andrew Johnson, President of the

And I, Andrew Johnson, President of the United States, do hereby declare and make known that the United States of America do henceforth disallow to all Persons trading, or attempting to trade in any ports of the United States, in violation of the laws thereof, all pretence of belligerent rights and privileges; and I give notice, that from the date of this Proclamation all such offenders will be held and dealt with as pirates.

It is also ordered that all restrictions upon trade, heretofore imposed in the territory of the United States east of the Mississippi River, save those relating to contraband of war, to the reservation of the rights of the United States to property purchased in the territory of an enemy, and to the 25 per cent. upon purchasers of cotton, are removed. All provisions of the internal revenue law will be carried into effect under the proper officers.

In witness whereof I have hereunto set my hand, and caused the Seal of the United States to be affixed.

Done at the City of Washington, this 22d day of May, in the year of our Lord 1865, and of the Independence of the United States of America the eighty-ninth.
