## Revolving Light on Cape Katakolo.

THE Greek Government has given notice, that on and after the 17th day of September 1865, a light would be exhibited from the lighthouse recently erected at Cape Katakolo, the south point of the peninsula forming Katakolo Bay, on the west coast of the Morea.

The light is a revolving white light, which attains its greatest brilliancy once every two minutes. A faint light will be seen for  $1^m 30^s$ ; followed by a total eclipse for  $10\frac{1}{2}^s$ ; a bright flash for  $9^s$ ; and then a total eclipse for  $10\frac{1}{2}^s$ . The light is elevated 149 feet above the mean level of the sea, and should be seen in clear weather at 17 miles.

The illuminating apparatus is dioptric or by lenses, of the fourth order.

The tower stands at 779 yards within the south point of the peninsula, and its position is given at lat. 37° 38' N., long. 21° 18' 5 J" East of Greenwich.
