WHEREAS by an Act passed in the session of the eleventh and twelfth years of Her present Majesty's reign, chapter one hundred and seven, intituled "An Act to prevent until the "first day of September one thousand eight "hundred and fifty, and to the end of the then " session of Parliament, the spreading of conta-" gious or infectious disorders among sheep, cattle, "and other animals," and from time to time continued by divers subsequent Acts, and lastly by an Act passed in the session of the twentyeighth and twenty-ninth years of the reign of Her present Majesty, chapter one hundred and nineteen, it is (amongst other things) enacted that it shall be lawful for the Lords and others of Her Majesty's Privy Council, or any two or more of them, from time to time, to make such Orders and Regulations as to them may seem necessary for the purpose of prohibiting or regulating the removal to or from such parts or places as they may designate in such Order or Orders, of sheep, cattle, horses, swine, or other animals, or of hay, straw, fodder, or other articles likely to propagate infection; and to make any other Orders or Regulations for the purpose of giving effect to the provisions of the said Act, and again to revoke, alter, or vary any such Orders or Regulations; and that all provisions for any of the purposes aforesaid in any such Order or Orders contained, shall have the like force and effect as if the same had been inserted in the said Act:

And whereas the said Act has been amended and explained by an Act passed in the twentyninth year of Her present Majesty's reign, intituled "An Act to amend the Act of the eleventh "and twelfth years of Her present Majesty, "chapter one hundred and seven, to prevent the "spreading of contagious or infectious disorders among sheep, cattle, and other animals;"

And whereas a contagious or infectious disorder, generally designated as the "Cattle Plague," has lately appeared and now prevails amongst cattle in England and Wales:

And whereas by an Order bearing date the twenty-fourth day of March last, duly made by the Lords of the said Council, it was among other things ordered, that until the first of June one thousand eight hundred and sixty-six, all cattle brought by sea from any place out of the United Kingdom into any town or place in England, shall be marked by clipping the hair off the end of the tail, and no such cattle shall be removed alive from such town or place, except by sea:

And whereas there is a certain market held for the sale of cattle in the parish of St Mary Islington, in the county of Middlesex, known as the Metropolitan Cattle Market, which market has been licensed by the Lords of the said Council for the sale of cattle intended for immediate slaughter until the first day of June next, or until the same licence shall be revoked, and it is advisable that regulations should be made for the removal of certain cattle to such market to be sold for

immediate slaughter:

Now, therefore, the Lords of the said Council do hereby order, that from and after the date of this Order, cattle brought by sea from any place out of the United Kingdom to any place on the rivers Thames or Medway, westward of the Nore Light, from which place there may be a railway on which cattle can be taken by trains without change of carriages to within 500 yards of the said market, may be removed along such railway to such market, for the purpose of being sold therein for immediate slaughter, any thing in the said recited Order to the contrary notwithstanding, subject to the following regulations:—
1. All such cattle shall be landed in such

manner, at such times, and subject to such supervision and control as the Commissioners of Customs shall from time to time direct, and shall be conveyed without stopping, except for the purpose of feeding or being watered, from the place where they shall be landed to the said market.

2. They shall be brought along the railway in trucks or carriages exclusively set apart and used for the purpose of conveying cattle brought from abroad, and coloured with a special colour, or otherwise by distinct mark to be approved of by the Board of Trade, to designate them as so appropriated, and such trucks and carriages shall, after they have been used for the purpose of conveying any cattle to the said market, be thoroughly cleansed and disinfected in such manner as may be necessary, or as the said Board of Trade may from time to time direct.

3. As soon as any truck or carriage shall have conveyed such cattle as aforesaid to the said market, and discharged them there, and have been so cleansed and disinfected, it shall be removed from the neighbourhood of the said market, and returned forthwith to the place from

which it shall have brought the cattle.

4. If any truck or carriage is at any time used in contravention of any regulation herein contained, the company or person by whom it is used shall, every time that such truck or carriage is so used, be liable to a penalty not exceeding five pounds.

5. This Order shall be construed in like manner as the said Order of the twenty-fourth day of March, and all the provisions of such last-mentioned Order shall apply to this Order, except so

far as they may be inconsistent with anything herein contained.

And whereas it is expedient that special provision should be made in respect to the county of

Westmoreland, as herein contained:

Now, therefore, the Lords of the Council do hereby order, that from and after the date hereof

the Local Authority for the county of Westmoreland may make such regulations for the admission of cattle and other animals into that county as shall seem to them most expedient, for the prevention of the spreading of the disease, and no cattle or other animals shall be conveyed, brought, or taken into the said county contrary to such regulations, anything in the Orders of the 24th of March and 11th of April 1866 to the contrary notwithstanding, after four days from the publication of such regulations, except as hereinafter provided:

Provided that no such regulation shall interfere with the conveyance of any animals by railway into, through, or out of the said county:

This Order shall be construed in like manner as the Orders of the 24th March and 11th April 1866, and all the provisions therein contained shall apply to this Order, so far as the same can be applicable, and the violation of any part of this Order shall be an offence subject to the penalty incurred under the said Orders by the committing of any offence against them or either of them; and the regulations made by the Local Authority for Westmoreland, under this Order, shall be published in some newspaper or newspapers circulating within the county or counties bordering on the county of Westmoreland.

Beacon Buoys for Measured Mile, off Stokes Bay.

Notice is hereby given that two beacon buoys, painted red, with staff and ball, have been moored off Stokes Bay, Spithead, for the purpose of indicating the course of the measured mile for testing the speed of Her Majesty's ships.

The Eastern buoy lies in 13 fathoms water, at

half a mile southward of Gilkicker point.

The Western buoy lies in 10 fathoms, at three quarters of a mile southward of Brown Down batteries, on the shore of Stokes Bay.

These buoys lie in a N.W. and S.E. direction, and are placed a cable's length from either end of the measured mile. As the course between the buoys is not more than 1½ cables outside a bank in Stokes Bay, on which there are only 3¾ and 4 fathoms at low water springs, vessels of heavy draught should not turn inwards or towards the shore of the bay.

Light Vessel at Entrance to Fraser River.

THE Government of British Columbia has given Notice that a light vessel has recently been established at the Sand Heads, entrance to Fraser River, British Columbia.

The light is a fixed white light, and in clear weather should be seen at a distance of 11 miles. The vessel is painted red, with the words South Sand Head in white letters of two feet in length on her sides, has two masts, and carries at the main a skeleton ball 5 feet in diameter. A bell is sounded in foggy weather.

She lies in lat. 49° 3′ 30″ N., long. 123° 17′ 16″ West of Greenwich, in 10 fathoms water, with Garry Point bearing N. by E. ¾ E. easterly, distant 51°5 miles; North Sand Head buoy N.N.W. ¾ W. 7 (cables; and the South Sand Head buoy E.N.E. 2 cables.

(No. 19.)—MEDITERRANEAN.

Buoys in the Ionian Sea.

Information has been received at the Admiralty that the buoy on the Madonna Shoal, eastward of the Island of Paxo, has not been in its position for some time; and that the buoy on the extremity of the shoal, extending south-eastward from Cape Skala, Island of Kephalonia, is either sunk or washed away. The buoy on the Madonna not having been replaced was the cause of the English yacht Myth being seriously damaged, and nearly lost, by grounding on that Shoal.

Mariners are therefore cautioned that when navigating in the vicinity of the shoals which have hitherto been marked by bouys, not to trust to the buoys being in their position.
