The QUEEN's Most Excellent Majesty in Council.

WHEREAS the Right Honorable Speacer Horatio Walpole, one of Her Majesty's Principal Secretaries of State, has, under the provisions of the "Burial Grounds (Scotland) Act, "1855," made a Representation stating that he has received a copy of an Interlocutor pronounced by the Sheriff of Forfarshire finding that the further use of the existing Burial Ground of the Parish of Cortachy is dangerous to health and is offensive and contrary to decency:

And whereas in the said Representation it is recommended that Burials be forthwith discontinued in the said Burial Ground:

Now, therefore, Her Majesty in Council is pleased to give Notice of such Representation, and to Order that the same be taken into consideration by a Committee of the Lords of Her Majesty's Most Honorable Privy Council on the 29th day of October next.

And Her Majesty is further pleased to direct that this Order, or Notice thereof, be published in the Edinburgh Gazette, and that copies or Notices thereof be fixed, as required by the abovementioned Act, on the doors of the Church of, or on some conspicuous places within, the Parish of Cortachy, one month before such Representation is so considered.
