THE Secretary of State for Foreign Affairs has received, from Her Majesty's Consul-General at Venice, the Circular, of which the following is a translation, issued by the Central Maritime Government of Trieste :--

# (TRANSLATION, No. 10,608.)

Circular of the I. R. Central Maritime Gavernment to all Port and Health Office Organs in the Coasts of the Empire.

With reference to the Circular of 19th June, 2d August, and 21st October last, No. 552, 6648, and 9059, the Central Maritime Government orders that vessels from Holland, Liverpool, also from the Gulf of Palermo and the Province of Trapani, if provided with clean bills of health, and without sickness on board, shall, on arrival, be admitted to free pratique.

# Florence, January 7, 1867.

The Official Gazette of yesterday contains a notification from the Home Department that, in consequence of some cases of Cholera in the district of Taranto, vessels leaving that port after the 5th of January will be subject to five days' quarantine on arrival in other Italian ports.

Bilbao, January 11, 1867.

# Constantinople, December 19, 1866.

" Telegrams from Salonica, dated the 12th and 17th instant, announce the entire cessation of cholera there since the 7th, and that a clean Bill of Health is now issued to vessels clearing that The news received by the Board of Health port. from Alexandria is also favourable. It is now (4th December) nineteen days since the last case of cholera occurred. Malta has taken off the quarantine on arrivals from Alexandria, and Greece has reduced to five days that upon arrivals from Constantinople."

The Secretary of State for Foreign Affairs has received from Her Majesty's Consul at Cadiz a Despatch, of which the following is a copy :--

# Cadiz, January 10, 1867.

I have the honour to report to your Lordship that an official telegram reached this last night from Madrid, to the effect that a Royal Order (dated 9th instant) decrees that vessels arriving from Great Britain, France, &c., &c., at Cadiz, Carthagena, and Santander, with clean Bills of Health, all on board well, and from ports declared healthy and unsuspected, will now have only three days' observation at these Spanish Ports named ; but if coming from foul ports, or ports not declared healthy, such vessels will be sent to the lazaretto harbours for quarantine.

Board of Trade, Whitehall, January 14, 1867.

The Right Honourable the Lords of the Committee of Privy Council for Trade have received a Notification that in consequence of the appearance of cholera in the island of St Thomas, the Governor of Trinidad has issued a Proclamation on the subject to the following effect :--

Whereas information has been received that cases of an infectious disorder of the nature of cholera have occurred in the island of St Thomas, and it is expedient to take measures for preventing the communication of cholera to the inhabitants of this colony : Now, therefore, His Excellency the Honorable Arthur Hamilton Gordon, C.M.G. Governor and Commander in and over the said island and its dependencies, with the advice and consent of the Executive Council thereof, has been pleased to order and adjudge, and it is hereby ordered, and adjudged and declared, by the authority aforesaid, that it is probable that the cholera, an infectious disease highly dangerous to the health of Her Majesty's subjects, may be brought into this colony from the said island of St Thomas : And it is hereby further ordered and declared by the authority aforesaid, that all ships and vessels, as well Her Majesty's Ships of War as others coming from or having touched at the said island of St Thomas at any time less than fourteen days from the time of their arrival in this colony, except as hereinafter mentioned ; and all vessels or boats, persons, goods, wares and merchandize, packets, packages, baggage, wearing apparel, books, or other articles from or out of any vessel so coming from or having touched at the island of St Thomas as aforesaid, shall, if there is no case or symptoms of cholera or other infectious disorder on board, be liable to and shall perform a quarantine for such time as, with the time elapsed since the departure of such vessel from St Thomas, will complete the period of fourteen days; but in case there shall have been or shall be before the termination of such quarantine any case of eholera or other infectious

disorder on board of such ship or vessel, then such ship or vessel shall be liable to, and shall perform quarantine for fourteen days from and after the time that all persons on board shall have been free from such cholera or other infectious disorder: Provided always, that when any such ship or vessel shall only have touched at St Thomas, and shall not have brought any passengers, or goods, or merchandize from that island, and shall have left the said island of St Thomas thirty-six hours before her arrival here, then such vessel shall not be liable to quarantine.

And it is hereby further ordered and declared. by the authority aforesaid, that this present Order shall be and continue in force from and immediately after the promulgation thereof, until such time as the same shall be revoked by the Order or Proclamation of the Governor, and no longer.
