#### Fixed Light at San Francisco River.

Information has been received at this Office that, since the 1st day of February 1867, a light has been established from a lighthouse at the mouth of the River San Francisco, near Maceio.

The light is a *fixed* white light, elevated 69 feet above the level of the sea, and in clear weather should be seen from a distance of 11 miles.

The lighthouse is built on the northern point of the river, and its position, as given, is in lat.  $10^{\circ}$  27' S., and long.  $36^{\circ} 21\frac{1}{2}'$  West of Greenwich.

Fixed Light at Entrance of River Pekalongan.

The Netherlands Government has given notice that, since the 27th day of September 1866, a light has been exhibited from a lighthouse erected at the entrance of the River Pekalongan, on the north coast of Java.

The light is a *fixed* white light, elevated 26 feet above the level of the sea, and in clear weather should be seen from a distance of 8 miles.

The illuminating apparatus is dioptric or by lenses.

The light is placed at the west entrance of the river, and its approximate position is in lat.  $6^{\circ}$  54½ S., and long. 109° 43' East of Greenwich. It is intended to indicate the position of the read-stead off the river.
