THE Secretary of State for Foreign Affairs has received from Her Majesty's Consul at Wiborg, a Despatch, of which the following is a copy:—

British Consulate,
Wiborg, March 20, 1867.

I DO myself the honour to inform your Lordship that an Imperial Decree, dated Helsingfors, the 27th February last, and published in the Finland Official Gazette, ordains as follows; viz.:—

"That all merchandize which, according to the regulations in vigour, is liable to duty when exported from Finland, may, during a period of five years, or from 1867 to 1871, both inclusive, be exported from this Grand Duchy free of duty, with the exception, however, of rags and bones."

"That all goods, the exportation of which from

"That all goods, the exportation of which from this country is at present prohibited, may, during the above-mentioned five years, also be exported free of duty, excepting, however, Russian small coin of the 72 standard, for which the non-exportation continues to remain in force."

I may mention that the ordinary export duty on sawn wood goods, the staple article in this country, and more particularly in this Consular District, was hitherto 1 penni per cubic foot, or 1 mark 65 penni = 1s. 4d. sterling for the St. Petersburgh standard.

A sawing tax of 2 penni per cubic foot, or 3 marks 30 penni = 2s. 8d. sterling, for the St. Petersburgh standard, and another tax of 12 penni = 1d., for every dozen of deals and boards, called a tax in favour of the Imperial Alexander University Fund at Helsingfors, both of which have hitherto been levied along with the ordinary export duty now repealed, remain still in force.
