PRESENT.

THEREAS by an Act passed in the Session of Parliament of the eleventh and twelfth years of Her present Majesty's reign, chapter one hundred and five, intituled "An Act to prohibit "the importation of sheep, cattle, or other "animals, for the purpose of preventing the intro-"duction of contagious or infectious disorders," after reciting, as therein is recited, it was enacted "that it shall be lawful for Her Majesty, from time to time, by Order in Council, to prohibit " the importation or introduction into the United "Kingdom, or into any particular port or ports thereof, of cattle, sheep, horses, or other animals, "either generally or from any place or places that "may be named in such Order, for such period or periods as she may deem to be necessary for "the purpose of preventing the introduction of "any infectious or contagious disorder among the sheep, cattle, horses, or other animals in this " country :"

And whereas by an Act passed in the Session of the eleventh and twelfth years of Her present Majesty's reign, chapter one hundred and seven, intituled "An Act to prevent, until "the first day of September one thousand eight "hundred and fifty, and to the end of the then "Session of Parliament, the spreading of con-tagious or infectious disorders among sheep, cattle, and other animals," and from time to time continued by divers subsequent Acts, and lastly by an Act passed in the Session of the twenty-eighth and twenty-ninth years of the reign of Her present Majesty, chapter one hundred and nineteen, it is as to them may seem necessary, for the purpose of or r gulating the removal to or from

> And whereas the said Act has been amended and explained by an Act passed in the twentyninth year of Her present Majesty's reign, inti-tuled "An Act to amend the Act of the eleventh " and twelfth years of Her present Majesty, chapter " one hundred and seven, to prevent the spreading " of contagious or infectious disorders among sheep, cattle, and other animals:"

> And whereas a contagious or infectious disorder, generally designated as the "Cattle Plague," has lately appeared, and still prevails amongst cattle in some parts of England, and in divers parts beyond the seas:

> And whereas divers Orders have been made by the Lords of the said Council in relation to the Cattle Plague, which were consolidated and amended by an Order bearing date the 24th day of March 1866 :

> And whereas by an Order bearing date the 26th day of May 1866, some of the regulations con tained in the said Order of the 24th day of March 1866, which would have ceased on the 1st day of June then next following, were continued, and certain further regulations were made with respect, amongst other things, to the landing of foreign cattle, and the movement of cattle:

And whereas by an Order bearing date the 7th day of November 1866, the Lords of the said Council made certain provisions with regard the licensing and holding of markets for the section of animals intended for immediate slaw territy (amongst other things) enacted that it shall be lawful for the Lords and others of Her Majesty's Privy Council, or any two or more of them, from granted under that Order permitting any limitation to time, to make such Orders and Regulations to be held in any port or other place into which anima orted from any country d Kı d m f the U

And whereas it is desirable that certain further regulations shall be made with regard to the licensing and holding of markets, and in relation to cattle imported into England and Wales from foreign countries, and for preventing the introduction of infectious and contagious disorders amongst animals in this country:

Now, therefore, the Lords of Her Majesty's Privy Council do hereby, by virtue of the said recited Acts, and of every other Act enabling them in that behalf, order that, notwithstanding anything in the said Orders, or in any other Orders of the said Council to the contrary,—

- 1. Markets may be held with the licence of the Lords of the said Council for the sale of animals, otherwise than for immediate slaughter, at any port or other place in England or Wales into which animals may be imported from any country not part of the United Kingdom: Provided that, in ports or places in which licences to hold such markets as aforesaid shall be granted, no cattle brought by sea from any place out of the United Kingdom, except the Channel Islands and the Isle of Man, shall be landed, except at some part of such port or place to be defined in some Order or Orders of the Lords of the Council, nor until some such Order or Orders has or have been so made, nor shall they be moved from such part of such port or place except to be taken to the nearest shed or slaughter-house in such port or place, which shall have been duly licensed by the Lords of Her Majesty's Council for the reception or slaughter of foreign cattle, and they shall be there slaughtered within four days from the day of landing, both days inclusive.
- 2. All lambs, sheep, goats, and swine, brought by sea from any place out of the United Kingdom into any town or place in the United Kingdom, in the same vessel with any foreign cattle, shall be dealt with in all respects as such foreign cattle, and shall be subject to all the regulations applicable to such foreign cattle brought by sea into any such town or place.
- 3. That nothing herein contained shall affect an Order of Her Majesty in Council of the 10th day of November 1866, relative to the landing of foreign cattle, and subjecting such cattle to quarantine, nor any Orders regulating the performance of quarantine of animals, nor any Order now in existence or hereafter to be duly sanctioned, allowing or permitting the movement of foreign cattle from any port in Great Britain to London or elsewhere.
- 4. This Order shall be construed in like manner as that of the 24th day of March 1866; and every person who shall contravene it shall be guilty of an offence, and be subject to the provision of the said Order relative to offences; and all the other provisions of the said Order not inconsistent herewith shall apply to this Order.
- 5. This Order shall take effect on and after the fifteenth day of April one thousand eight hundred and sixty-seven.
