DOWNING-STREET-Dec. 23. 1800.

DISPATCH, of which the following is an A extract, dated head-quarters, Muhldorf on the Inn, Thursday, 4th December 1800, has been received from William Wickham, Esq. by the Right Honourable Lord Grenville, his Majelly's Principal Secretary of State for the foreign department :-

The army marched in the night of Tuesday, and before day-break yesterday morning, towards Hohenlinden, in three columns; the centre along the great road to Munich, which paffes through Hohenlinden; the right and left in the woods on each fide of the great road.

The corps of General Kienmayer, which was destined to take the enemy in slank, marched from Dorfen in the direction of Schwaben.

The columns ought all to have arrived at their destination a little before day-break, or at the latell between eight or nine o'clock; but from a heavy fall of frow and fleet, which continued all night and the greater part of the morning, the centre column only was at its destination at eight o'clock, whilft both the left and right were fill confiderably behind; and the left, under General Lisch, had, besides, lost its way, and marched to the left towards Ebersberg, instead of turning to the right, in the direction of Hohenlinden.

In this state of things it appears, that the di- from Cherbourg, without taking any thing. vision of General Richepanse pierced between the left and the centre about nine o'clock, got.

upon the great road behind the centre, and fell upon the left flank and rear of that column at the time that it had formed in front, and had just begun to attack the enemy's position.

I have not yet been able to obtain any accurate account of what paffed afterwards; but it feems that the disorder soon became irretrievable, and that the retreat towards the heights of Ramsan was made with very heavy lofs, particularly in artillery. Generals Spanniorchi and Loppert are prifoners. I have not yet heard of the loss of any other officers of the same rank.

General Kienmayer was attacked on his march by two divisions from Aerding, and suffered also feverely in his retreat, which he made upon Isen in good order, on learning the difaster that had befallen the main army.

Copy of a Letter from Vice-Admiral Lutwinge, Commander in Chief of his Majesty's ships and vessels in the Downs, to Mr NEPEAN, dated on board the Overyffel, December 20. 1800.

I DESIRE you will please to lay before the Lords Commissioners of the Admiralty the enclosed letter from Lieutenant Wells, commanding his Majesty's hired cutter the Lord Duncan, giving me an account of his having captured the French cutter privateer L'Eclair, commanded by Jacquiere Toussaint le Terrier, carrying three guns and twenty men, having been out two days

I BEG leave to acquaint you of my having feen the convoy fafe into St Helen's, agreeably to your directions; and that on my return, (Thursday the 18th instant,) being off Shoreham in 2 thick fog, I fell in with and captured L'Eclair French cutter privateer, commanded by Jacquiere. Toussaint le Terrier, carrying three two-pounders, fmall arms, and twenty men; from Cherbourg. two days, and had not taken any thing.
