(No. 90.)—United States, Virginia.—Chesapeake Bay.

Fixed Light off Smith Point.

The United States Government has given notice that, from the 9th day of September 1868, a light would be exhibited from the screw pile lighthouse recently erected off Smith Point, entrance of Potomac River, Chesapeake Bay.

The light is a fixed white light, elevated 37 feet above high water, and in clear weather should be seen from a distance of 11 miles.

The illuminating apparatus is dioptric or by lenses of the fourth order.

The lighthouse stands on the edge of Smith Point Shoal, in 2 fathoms water. From 4 to 6 fathoms will be found within 150 yards to the eastward, and 2 fathoms on the shoal extending about one mile westward between N.W. and S.W.

The lighthouse is white, and the iron-work of the foundation red.

A fog-bell is attached to the lighthouse, on its eastern side, which, in foggy weather, will be sounded by machinery, at intervals of 15 seconds.

. Vessels passing up or down the Bay, or into the Potomac River, and drawing from 12 to 14 feet water, may approach the lighthouse safely to within a distance of 250 yards, but vessels of heavier draught should give it a berth of onethird of a mile.

On the same date the light vessel marking the station, as well as the temporary light vessel moored close to the lighthouse for the protection of the work during its progress, would be removed.

Re-establishment of Fixed Light at Bull's Bay.

Also that, from the 31st day of August 1868, the *fixed* white light formerly exhibited from a lantern over the keeper's dwelling, on the north end of Bull's Island, Bull's Bay, would be re-established.

(No. 91.)—West Indies.—North Coast of Cuba.

Revolving Red Light on Lucrecia Point.

Notice has been published in the Official Gazette at Havana, that on and after the 10th day of October 1868 a light would be exhibited from a lighthouse recently erected on Lucrecia Point, on the north-east coast of Cuba.

The light will be a revolving red light, attaining its greatest brilliancy every minute. It is elevated 130 feet above the mean level of the sea, and in clear weather should be seen at a distance of 17 miles.

The illuminating apparatus is of the second order.

The tower is of stone, and stands about 110 yards from the sea, in lat. 21° 4′ 21″ N., long. 75° 37′ 41″ West of Greenwich. The keeper's dwelling is in the rear of the lighthouse, and whitewashed. The coast is low and rugged.

The temporary white light at present exhibited will be discontinued.
