# ACT OF SEDERUNT FOR

CARRYING INTO EFFECT THE PURPOSES OF THE COURT OF SESSION ACT, 1868.

# EDINBURGH, 14th October 1868.

HEREAS, by the One hundred and sixth W Section of the 'Court of Session Act, '1868,' it is provided that 'The Court of Session 'may from time to time make such Regulations 'by Act of Sederunt as shall be necessary for carrying into effect the purposes of this Act; and for regulating the Times and Forms of Summonses and Writs, and Modes of Procedure 'and of Pleadings; and, generally, the practice of 'the said Court in respect of the Matters to 'which this Act relates; and for regulating the Fees of the Agents practising before the said 'Court: and, so far as may be found expedient, 'for altering the course of proceeding herein-'before prescribed, in respect to the Matters to 'which this Act relates, or any of them; and 'may also repeal or alter the Provisions of any 'Act of Sederunt relating to any of the Matters 'hereinbefore specified as may be inconsistent with such new Regulations; and for that pur-pose the said Court may meet during Vacation.

'as well as during Session.' And whereas, by the Eighth Section of the said Act, it is provided that it shall be 'com-' petent for the Court from time to time, by Act 'of Sederunt, to appoint any Four Lords Ordi-'nary to meet as a Court at such times as shall 'be specified in the Act of Sederunt, for the <sup>6</sup> purpose of hearing and disposing of such Causes <sup>6</sup> standing on the Rolls of the First and Second <sup>6</sup> Divisions of the Inner House, not being Causes 'which have come into the Inner House by 'Reclaiming Note against the Judgment of a 'Lord Ordinary, and to appoint one or more of ' the Depute Clerks of Session to act as Clerk or 'Clerks of said Court; and further, by Act of 'Sederunt, to make all necessary Regulations as 'to the Causes which shall from time to time be 'so heard and disposed of; and the Senior Lord 'shall have the same effect in all respects as a tively (and where there are several Causes of the

'Judgment of one of the Divisions of the Inner ' House of the Court.'

And whereas, by the Twenty-second Section of the said Act, it is provided that 'the Calling ' Lists shall be printed and published in the Daily \* Rolls of Court, under such Regulations as the \* Court may see proper to make, in place of the \* separate Calling Lists now in use to be pub-\* lished, and that 'the Weekly printed Rolls of ' new Causes shall be discontinued; and where a ' Defender shall not enter Appearance on or before ' the Second day after the Summons has been called in Court, the Cause may immediately be enrolled in the Lord Ordinary's Motion Roll as an undefended Cause for Decree in Absence; ' and where Appearance is timeously entered, as aforesaid, on behalf of a Defender, his Defences shall be lodged on or before the Tenth day after 'the date of Calling of the Summons, failing which the Cause may be immediately enrolled for Decree in absence, or in the case of Actions containing reductive Conclusions the Cause may be enrolled for the Purpose of obtaining an order for satisfying the Production, and there-after the Cause may be enrolled by either Party ' for further Procedure.'

And whereas, by the Seventh Section of the said Act, it is provided that 'the hours for the 'attendance of the Clerks of Court, at their 'offices, shall be as fixed from time to time by the · Court.

I. The Lords appoint the four Senior Lords 1. The Lords appoint the four Senior Lords Ordinary to meet as a Court on Tuesday the 20th, Wednesday the 21st, Tuesday the 27th, Wednes-day the 28th, and Thursday the 29th days of October, Tuesday the 3d, Wednesday the 4th, Thursday the 5th, Tuesday the 10th, and Thursday the 12th days of November, in the present year, and such other days thereafter as may be prescribed in competent form, for the purpose of hearing and disposing of such Causes as may be remitted to them from the Rolls of the First and Second Divisions of the Court, in manner hereinafter provided, and which Causes shall be entered in a Roll, to be called 'The Roll of Remitted 'Inner House Causes,' in the order of the dates on which the said Causes were enrolled in the 'Ordinary present shall preside and shall sign the 'Judgment of the said Court, and such Judgment Rolls of the First and Second Divisions respec-

same date, they shall be taken alternately one from each Division), which Roll shall be made up and kept by the Clerk of the Senior Lord Ordinary. And the Lords further appoint the Depute and Assistant-Clerks of Session, officiating at the Bars of the two Senior Lords Ordinary respectively, to be Clerks and Assistant-Clerks of the said Court, the Depute and Assistant-Clerk officiating at the Bar of the Senior Lord Ordinary taking charge of the First Division Causes, and the Depute and Assistant-Clerk officiating at the Bar of the Second Lord Ordinary taking charge of the Second Division Causes, remitted as aforesaid; and it shall be competent to the said Court to adjourn to any other day for the purpose of finishing the hearing of a Cause or Causes which may have been partly heard, or for any other purpose that may seem to them proper.

And the Lords further enact and declare as follows :

II. In the event of the Judges composing the said Court being equally divided in opinion on any Cause, it shall be competent for the said Court to make an order appointing the Cause to be reheard before themselves and one other Judge to be thereafter named by the Lord President; and the Judgment to be pronounced on such re-hearing shall be in conformity with the opinion of the Majority of the five Judges, but shall bear to be the Judgment of the said Court of four Lords Ordinary, after consulting with such additional Judge, and shall be signed by the Senior Lord Ordinary as President of the said Court.

III. The Lord President and the Lord Justice-Clerk may from time to time select from the Rolls of the First and Second Divisions respectively, such Causes (not being Causes which have come to the Inner House by Reclaiming Note against a Judgment of a Lord Ordinary) as they con-sider suitable to be remitted to the said Court of four Lords Ordinary, and the Lord President shall thereupon make an Order in the form and manner prescribed by the Act 20 & 21 Vict., cap. 56, §§ 1, 2, & 3, transferring the said Causes from the Rolls of the Inner House to 'The Roll of Remitted Inner House Causes ; but it shall be competent, in regard to any of such remitted Causes, for the Division of the Court to which it belongs at any time, either on the motion of any party to the Cause, or cx proprio molu on being satisfied of the propriety and expediency of such a course of procedure, to order such Cause to be retransmitted to the said Division.

IV. In any of the Causes standing in 'The Roll of Remitted Inner House Causes,' which have been brought to the Court of Session from an inferior Court, whenever it shall be necessary that Proof or Additional Proof should be taken, or that a Record should be made up or amended, such Proof or Additional Proof shall be taken, and the Record made up or amended under the direction of the said Court of four Lords Ordinary, in terms of the powers and provisions contained in the Seventy-second and Seventyseventh Sections of the said recited Act.  $\mathbf{And}$ the said Court of four Lords Ordinary shall also possess and exercise the powers conferred on the Court and the Lord Ordinary by the Twentyninth Section of the said recited Act.

V. It shall not be necessary for the Lords Ordinary composing the said Court to sit for the taking of Proofs, or presiding at Trials by Jury in Causes depending before them in the Outer House respectively during any week in which the said Undefended Causes, and a Roll of Motions

Court shall sit under the authority of the said recited Act and this Act, nor shall it be necessary for any of the said Lords Ordinary (unless he shall think fit to do so at some hour when the said Court is not sitting) to call his ordinary Motion Roll or Debate Roll in the Outer House on any day on which the said Court shall sit under the authority foresaid, anything contained in the Sixth Section of the said recited Act notwithstanding.

VI. When an Interlocutor has been pronounced by a Lord Ordinary, approving of an Issue or Issues under Section Twenty seven, Sub-section Three, of the said recited Act, it shall not be necessary nor competent to reclaim against the said Interlocutor, if the Party aggrieved thereby desires only to obtain a variation of the Terms of the Issue or Issues, and does not desire to have such Issue or Issues, or one or more of such Issues, disallowed in toto; but, in every such Case, the Party shall apply by motion to the Inner House, in terms of the Twenty-eighth Section of the said recited Act, specifying precisely in his notice of motion the particular variation or variations which he desires should be made on the said Issue or Issues, and at same time Box Copies of the Record.

VII. That the Daily Rolls now in use to be printed and published, shall in future be printed and published under the authority and directions of the Court, by a Printer to be appointed from time to time by the Lord President.

VIII. That the partibus of every Summons shall specify both the Lord Ordinary and the Division of the Court to which the Cause shall belong, and shall be framed in terms of the Act of Sederunt 11th July 1828, Section Twenty-seven. And every Summons, in order to be called during Session, shall be lodged with the Clerk on the lawful day preceding that on which it is to be called, accompanied by a copy of the *partibus*, in plain, legible writing.

IX. That each of the Clerks, after revising the copy of the partibus, shall hand over the same to the Printer to be printed in the Calling List, and shall on the following day, in the Parliament House, before Twelve o'clock noon, revise the Proof of his share of the Calling List, and the completed Calling List of that day shall be printed and published in the Daily Rolls of that afternoon, at the earliest hour possible, and a separate Copy of the printed Calling List shall at the same time be put up on the walls of the Parliament House.

X. That every Summons, in order to be called on any Box-day during Vacation or Recess, shall, with the copy partibus, be lodged with the Clerk the Second day preceding the Box-day, and a separate Calling List shall be printed and pub-

lished on the Box-day. XI. That appearance may be entered for Defenders on the day of calling or on either of

the two days following. XII. That in Actions containing reductive conclusions, if the Pursuer shall fail within twelve days after the calling to enrol the Cause, the Defender shall be entitled to enrol for Dismissal of the Action or other competent procedure

XIII. That during Session a Roll of undefended Causes shall be taken up daily when necessary by the Clerk of each Lord Ordinary, and shall

under the 93d section of the said recited Act, shall be taken up by the Clerk of the Lord Ordinary officiating for the time on the Bills on the third lawful day following each Box-day, between the hours of Eleven forenoon and Twelve noon, and shall be printed and published on that day; and the said Rolls shall be disposed of by the Lord Ordinary officiating on the Bills, on the Fifth lawful day after each Box-day, in terms of the said recited Act.

XIV. That in the Daily Rolls the Calling List and Roll of undefended Causes shall precede the other Enrolments.

XV. That the Teind Roll and Calling List of Teind Causes shall be printed and published in the Daily Rolls, instead of being printed separately as at present; and that the preparation and publication of the same shall be under the direction of the Teind Clerk; and that the Interlocutors of the Court of Teinds which are at present signed on Friday after being pronounced on Wednesday, shall hereafter be signed on the Thursday following the day on which they are pronounced.

XVI. That the Keeper of the Inner House Rolls of the First Division, the Senior Assistant-Clerk in the Outer-House, the Clerk of the Senior Lord Ordinary for the time, and the Teind Clerk, shall from time to time fix the price which the Printer shall be authorised to charge for Copies of the Daily Rolls, and separate Calling Lists, and Rolls of undefended Causes above mentioned.

XVII. That the Inner and Outer House Assistant-Clerks shall attend at the Register House, and keep their Offices open for the performance of their official duties during the following hours, viz. —In time of Session every Sederunt day, except Saturday, from Two till Five afternoon; and on Monday from Eleven forenoon till Three afternoon. In time of Vacation and Recess on Tuesday, Wednesday, and Thursday, from Eleven forenoon till One afternoon, except during the week in which a Box-day occurs, and the week immediately following, when attendance shall be given every lawful day, except Saturday, in the last mentioned week, from Eleven forenoon till One afternoon.

XVIII. That all Petitions and Applications, which may, under the Statute 20 & 21 Victoria, c. 56, or under any other Act of Parliament, be brought before a Lord Ordinary, shall be enrolled for an order for Intimation and Service to be pronounced by the Lord Ordinary. But after the period of Intimation and Service in any such Petition or Application has expired, it shall not be necessary to enrol such Petition or Application, when unopposed, before the Lord Ordinary, but the same shall, on the requisition of the agent, be transmitted to the Lord Ordinary, to be disposed of, or for such farther or other procedure as to him shall seem proper. And after a remit shall have been made by the Lord Ordinary to a man of business or man of skill to report, all Motions in such Petition or Application shall be made before the Lord Ordinary, and be enrolled in the Lord Ordinary's Daily Roll, and not in the Roll of continued Motions provided for by Section Thirty-one of the said recited Act.

XIX. All Motions for the Amendment of Summonses or other Pleadings in undefended Causes, Rawlinson, K.C. for Revisal and Adjustment or Amendment of Council of India.

Pleadings, for leave to Reclaim for Transference for Wakening and Transference, and for Decrees by default, shall be made before the Lord Ordinary, and not before the Clerk, and shall be enrolled in the Lord Ordinary's Daily Roll, and not in the Roll of continued Motions provided for by the Thirty-first Section of the said recited Act.

XX. That in order to secure a more equal distribution between the two Principal Clerks of each Division of the Court, of the business that may be brought into the Inner House, all Appeals under the 'Debts Recovery (Scotland) Act, 1867,' and under the said recited Act; and all Causes or other proceedings in the Bill-Chamber which shall be removed by Reclaiming Note or otherwise to the Inner House, shall belong in the First Division to the office now held by Archibald M'Neill, Principal Clerk, and in the Second Division to the office now held by Cosmo Innes, Principal Clerk.

And the Lords APPOINT this Act to be inserted in the Books of Sederunt, and to be printed and published in common form.

APPOINTING JUDGES FOR HEARING APPEALS UNDER THE TWENTY-SECOND SECTION OF THE REPRESENTATION OF THE PEOPLE (SCOTLAND) ACT, 1868,

# EDINBURGH, 14th October 1868.

WHEREAS, by Section the Twenty-third of the Representation of the People (Scotland) Act, 1868, it is provided that the Court for hearing Appeals under the Twenty-second section of the said Act shall consist of three Judges of the Court of Session to be named from time to time by Act of Sederunt of the said Court, one Judge to be named from each Division of the Inner House, and one from the Lords Ordinary in the Outer House.

Therefore the Lords hereby NOMINATE and APPOINT the following three Judges, viz., Lord BENHOLME, Lord ARDMILLAN, and the Junior LORD ORDINARY, to be the Court for hearing Appeals under the Twenty-second Section of the said Act, with power to the said Court to adjourn their Sittings, from day to day, so long as the business before them renders it necessary.

And the Lords APPOINT this Act to be inserted in the Books of Sederunt, and to be Printed and Published in Common Form.
