By the Lords of Her Majesty's Most Honourable Privy Council.

PRESENT,

Lord Stanley. Mr Disraeli.

WHEREAS by an Order bearing date the twentieth day of August one thousand eight hundred and sixty-eight, the Lords of Her Majesty's Most Honourable Privy Council did make certain provisions relating to sheep (including lambs) brought to, and landed in Great Britain from the Continent of Europe, and in such Order it is amongst other things provided that such sheep shall, at the option of the consignee or owner of such sheep, either be kept in quarantine in some convenient place, to be set apart and appointed by the Commissioners of Her Majesty's Customs, for fourteen days from the time when such sheep shall have been landed, (the day of landing being counted as one of such days,) or shall within four days after they shall have been landed, (such four days being exclusive of the day of landing,) be slaughtered at the place whereat they shall be so landed:

And whereas it is expedient that the time should be extended within which sheep, not subjected to quarantine, are directed by such Order to be slaughtered:

Now, therefore, the Lords of the said Council do order, and it is hereby ordered, that the period of four days mentioned in the said Order of the twentieth day of August one thousand eight hunded and sixty-eight, within which such sheep, not subjected under the said Order to quarantine, are ordered to be slaughtered, shall, notwithstanding anything in the said Order contained, be considered to be exclusive of the day of landing, and exclusive of Sunday.

This Order shall take effect on and after the nineteenth day of October one thousand eight hundred and sixty-eight.

And the Right Honourable the Lords Commissioners of Her Majesty's Treasury are to give the necessary directions herein accordingly.

(No. 95.)—NEW ZEALAND.—NORTH ISLAND.

Fixed Light on Somes Island, Port Nicholson.

Information has been received that a light has been established on Somes Island, Port Nicholson, in the province of Wellington, New Zealand.

The lighthouse is an octagonal iron tower, painted white, from which, at an elevation of 74 feet above the level of high water, is exhibited a fixed light, showing white in mid-channel, red on the western, and green on the eastern shore of the main entrance into the port.

The light is intended as a leading light for vessels entering the port by the main channel of the entrance, and in clear weather should be seen from a distance of 10 miles, or 4 miles outside Pencarrow head light.

The illuminating apparatus is catadioptric of

the fourth order.

From the lighthouse the centre of Ward Island bears S.S.E.  $\frac{1}{8}$  E.; Pencarrow Head S.  $\frac{5}{8}$  E.; Steeple Rock South; Halswell Point S.W.  $\frac{7}{8}$  S.; and Jerningham Point S.W.

Caution.—When entering the port through the main entrance, the white light should not be shut in after bringing Pencarrow head light to bear E.N.E.
