The Right Honourable the Lords of the Committee of Privy Council for Trade have received, from the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Consul at Malaga, reporting that the Provisional Government of Madrid having decreed that all the liberal measures adopted in matters of quarantine by the Provincial Juntas shall cease to have effect, the Sanitary Direction of that port has resolved to re-establish the quarantines which were in force previously to the resolution; and consequently all vessels arriving at Malaga from ports of the United Kingdom, Gibraltar, and Malta, will in future be dismissed to a lazaret of observation of three days quarantine.

The Secretary of State of War has appointed Edward Waylen, Esq., M.R.C.S., to be Visiting Surgeon at Colchester, under the Contagious Diseases Act, from this day, inclusively.

TREASURY WARRANT.

Whereas by an Act of Parliament passed in the fourth year of the reign of Her Majesty, chapter ninety-six, for the regulation of the duties of postage, certain scales of weight and rates of postage were fixed and made chargeable and payable upon or in respect of letters, newspapers, Parliamentary proceedings, and printed papers, transmitted and forwarded by the post, and various regulations were made for facilitating the transmission of such letters and papers by the post; and by the same Act powers were given to the Commissioners of Her Majesty's Treasury, from time to time, by Warrant under their hands, to alter and fix any of the rates of postage therein mentioned.

And whereas further powers were given to the Commissioners of Her Majesty's Treasury by another Act of Parliament passed in the eleventh year of the reign of Her Majesty, chapter 85, for giving further facilities for the transmission of letters by post, and for the regulating the duties of postage thereon, and for other purposes relating to the Post-office.

And whereas the Commissioners of Her Majesty's Treasury in exercise of the powers vested in them and by the said before-mentioned Acts, and of all other powers enabling them in that behalf, have from time to time, by divers Warrants under their hands, authorised and directed that packets consisting of printed papers other than newspapers, or of books, publications, or works of literature or art, or of patterns, or samples of merchandise, might be transmitted by the post between the United Kingdom and Malta and Gibraltar, and also from Constantinople, Alexandria, Cairo, and Suez, to the United Kingdom, at certain rates of postage, and under and subject to certain conditions, regulations, and restrictions in and by the said several Warrants respectively specified and mentioned.

And whereas it is expedient to reduce the postage now chargeable on certain of the several packets transmitted as hereinbefore respectively mentioned

Now we, the Commissioners of Her Majesty's Treasury, in exercise of the powers reserved to us in and by the hereinbefore recited Acts of Parliament and each of them, and of all other powers enabling us in this behalf, do, by this Warrant, under the hands of two of us, the said Commissioners (by the authority of the Statute in that case made and provided), order, direct, and declare as follows, that is to say:—

1. That all packets consisting of printed papers (other than newspapers), or of books, publications, or works of literature or art, or of patterns, or samples of merchandize, not exceeding two ounces in weight, posted in the United Kingdom, addressed to Malta or Gibraltar, or posted in Constantinople, Alexandria, Cairo, Suez, Malta, or Gibraltar, to Alexandria, Cairo, Suez, Malta, or Gibraltar, to and 19.

the United Kingdom, under the authority of any Warrant or Warrants of the Commissioners of Her Majesty's Treasury now in force relating thereto, shall, in lieu of being charged with the respective rates of postage payable thereon for such transmission thereof respectively as hereinbefore mentioned under such respective Warrant or Warrants, be charged with the rates of postage following, that is to say:—

On every such packet if not exceeding one ounce in weight, there shall be charged and taken an uniform rate of postage of one penny;

penny;
And on every such packet if exceeding one ounce and not exceeding two ounces in weight, there shall be charged and taken an uniform rate of postage of twopence.

- 2. All such packets as are mentioned in the first clause of this Warrant shall remain subject in every respect (save as is in such first clause of this Warrant mentioned) to the several orders, regulations, conditions, and restrictions now in force and applicable thereto; and the several Warrants hereinbefore referred to, shall (save in so far as the same are respectively altered or affected by this present Warrant) continue in full force and effect.
- 3. The Commissioners for the time being of Her Majesty's Treasury may, by Warrant under their hands duly made, at any time hereafter alter, repeal, revoke, or modify the rates of postage hereby fixed or altered, or the regulations hereby made, and may make and establish any new or other rates in lieu thereof.
- 4. This Warrant shall come into operation on the first day of January one thousand eight hundred and sixty-nine.

Alteration in Position of Plouguerneau Light.

The French Government has given notice that, from the 15th day of November 1868, the following alteration would take place in the position of Plouguerneau light, Abervrac'h.

The light will be exhibited from a tower recently erected on the heights of Lanvaon, between Plou-

guerneau and the head of the bay,

The new light is a fixed white light, visible through an arc of about 22 degrees, and bearing S.E. by E. \(\frac{1}{3} \) E., distant rather more than a mile and a half from the Vrac'h isle light. It is elevated 170 feet above the sea, and in clear weather should be seen from a distance of 12 miles.

The illuminating apparatus consists of a parabolic reflector.

The tower is 70 feet high, rectangular, white,

and build of stone.

This light in one with the Vrac'h isle light bearing S.E. by E. $\frac{1}{3}$ E., is (as formerly) the leading mark for the outer part of the main channel of Abervrac'h.

Beacons on the Platus and Jument Rocks.
