#### PRISON OF FALKIRK.

The Right Honorable Henry Austin Bruce, one of Her Majesty's Most Honorable Privy Council, and Principal Secretary of State, &c., &c.

WHEREAS, with the approval of the Secretary of State, a BUILDING has been recently erected in the Town of Falkirk, one portion of which is appropriated to the purposes of a Court-house, and another portion is intended for the purposes of a Prison, and contains the following accommodation, viz.:—Four Cells and one Strong-room for Male Prisoners; Three Cells for Female Prisoners; a Prison Kitchen, and Store Rooms.

In virtue of the powers contained in the Prisons (Scotland) Administration Act, 1860, I do hereby Order and Intimate that the portion of the said building so intended for the purposes of a Prison shall, on and after the 13th day of May 1869, under the designation of "The Prison of Falkirk," be a Legal Place of detention for Criminal Prisoners: Provided that, in the case of such Prisoners undergoing sentences of Imprisonment, the same shall only be a legal place of detention for periods not exceeding one month from the date of their respective sentences; and that every Prisoner under a sentence exceeding one month from the date thereof be removed from the said Prison of Falkirk to the Prison of Stirling by or under the direction of the Prison Board for the County of Stirling: Farther, I hereby Order and Intimate that the BUILDING heretofore used as the Prison of Falkirk, and as such referred to in an Order of the late General Board of Directors of Prisons, dated on the 10th day of March in the year 1847, shall, after the said 13th day of May 1869, CEASE to be a Legal Prison; and on that day all Prisoners confined therein shall, by or under the direction of the said Prison Board, be removed to the Building hereby rendered a Legal Prison.

Mr James Crowden, Chief Officer, Second Class, of the Coast Guard Station at Muchals. respect of which the Decoration has been conferred :-

The schooner "Kinloss" was wrecked at Scatraw Creek, a mile and a half from Muchals,

on the 21st of December 1868.

Mr James Crowden, the Chief Officer at Muchals Station, proceeded with his boat's crew to Scatraw, and found the ship breaking up fast. The fishermen of the place had succeeded in getting a rope from the vessel, by which it was hoped that the lives of those on board would be saved.

Mr Crowden ventured out on to a rocky point aud endeavoured to fasten a life-belt to the rope in order to send it out to the ship, but without success. Whilst striving to perform this opera-tion Mr Crowden was several times washed off into the sea. Once a heavy sea swept him off and carried him about 100 yards towards the wreck, and it was thought that he was lost; but after a few minutes struggling he was carried round a point by a violent run of the sea, and thrown upon the rocks with such violence however, that he became insensible, and received a severe contusion of the left knee.

When he recovered his senses Mr Crowden succeeded in getting a coble launched, and was the first to jump into it. He and his men (4 in number) hauled off to the ship by the rope, and succeeded in taking four men from the mast and

bringing them ashore.

On being informed that there was still another man on board Mr Crowden and his crew hauled off again to the wreck; but the man was dead or dying, and in such a position that it was impossible to extricate him.

A very heavy sea was running at the time of the rescue, and the coble might have been dashed

upon the rocks at any moment.

Mr Crowden was fourteen days upon the sick list in consequence of the injuries received by him in being washed off and dashed against the rocks.

This is the fourth time that Mr Crowden has been instrumental in saving life from shipwreck, and including the present instance, he has aided in the rescue of thirteen lives.
